Notice is hereby given that a public hearing will be held by the City Council of the City of Porterville on Tuesday, March 1, 2022 at 6:30 PM, or as soon thereafter as the matter can be heard, in the Council Chambers at City Hall, 291 N. Main St, Porterville, California, and/or virtually utilizing the Zoom platform in order to consider the public interest in the updated Draft Urban Water Management Plan 2020 (UWMP). Pursuant to the California Water Code section 10642 and 10608, the City Council of the City of Porterville will conduct a public hearing to take testimony regarding the adoption of the 2020 Urban Water Management Plan (UWMP) for the City of Porterville.

The City Council will consider a finding of exemption from the California Environment Quality Act for the proposed amendment.

Public comments may be submitted to cityclerk@ci.porterville.ca.us and will be read aloud for Council consideration during public hearings as applicable. Members of the public are encouraged to submit comments prior to 6:30 p.m., Tuesday, March 1, 2022, to participate in said meeting. Staff will periodically check for any emails that may have been submitted after 6:30 p.m., however it is not guaranteed that those emails will be read prior to Council action.

This notice is given in order to provide all parties an opportunity to be heard and to present their views regarding the Update to the City of Porterville UWMP 2020.
