

(a) Upon formal motion made, seconded and carried, all bodies and agencies subject to the open meetings act may recess, but not adjourn, open meetings for closed or executive meetings. Any motion to recess for a closed or executive meeting shall include a statement of (1) the justification for closing the meeting, (2) the subjects to be discussed during the closed or executive meeting and (3) the time and place at which the open meeting shall resume. Such motion, including the required statement, shall be recorded in the minutes of the meeting and shall be maintained as a part of the permanent records of the body or agency. Discussion during the closed or executive meeting shall be limited to those subjects stated in the motion.

(b) No subjects shall be discussed at any closed or executive meeting, except the following:

(1) Personnel matters of nonelected personnel;

(2) consultation with an attorney for the body or agency which would be deemed privileged in the attorney-client relationship;

(3) matters relating to employer-employee negotiations whether or not in consultation with the representative or representatives of the body or agency;

(4) confidential data relating to financial affairs or trade secrets of corporations, partnerships, trusts, and individual proprietorships;

(5) matters relating to actions adversely or favorably affecting a person as a student, patient or resident of a public institution, except that any such person shall have the right to a public hearing if requested by the person;

(6) preliminary discussions relating to the acquisition of real property;

Trash transfer station fee increase reviewed

Labette County's solid waste committee needs more information before deciding on a fee increase request for cities and other customers of the trash transfer station south of Parsons.

The current rate is \$40.76 a ton and GFL Environmental wants to increase that fee to \$43.50 a ton for cities in the county that use the transfer station and \$65 a ton for other customers of the transfer station, such as for-profit businesses that would include Green Environmental Services of Erie. If everyone would pay the same rate, the cost would increase to \$55 a ton as proposed by GFL.

Green Environmental, the second largest customer of the trash transfer station, doesn't like the idea of paying more than Labette County cities in part because some of its customers live in Labette County and the company would just pass the increased cost to them.

The committee took no action on Wednesday and opted for another meeting this month to allow for additional information to be distributed to members, including annual tonnage brought to the trash transfer station from 2018 to November 2022.

The biggest user of the trash transfer station is the city of Parsons, which has dumped 39,127 tons of trash there since Jan. 1, 2018, according to a GFL summary distributed to committee members. GFL uses a third-party transportation company to haul the trash trailers from the transfer station to the GFL landfill in Arcadia in Crawford County. That transportation company has increased rates charged to GFL because of increased fuel costs, which is one factor in GFL seeking the increase from the users in Labette County. Another factor is inflation.

The second largest user of the transfer station is Green Environmental, which has brought 21,413 tons of trash to the transfer station since Jan. 1, 2018.

The other larger customers of the transfer station: IWCA of Joplin-Chanute, 19,983 tons of trash and special waste; miscellaneous customers, 8,553 tons; Oswego, 6,352 tons; SEK Sanitation Services, 4,999 tons; Altamont, 4,413 tons; Parsons street sweepings, 4,397 tons; Chetopa, 3,395 tons; and Great Plains Disposal (roll off service), 3,082 tons.

Committee members wanted to know how much trash was dropped there by year for each of the users and that information should be available for the next meeting. Part of the reason for this report is to determine how to distribute royalties that were formerly collected on trash dumped at the transfer station. Committee members have collected other information as well, including rates charged by area landfills, but have yet to discuss it.

Charlie Morse, the facilitator for the committee, asked GFL if the company would be willing to include language that would reduce the tonnage rate as time goes along based on falling fuel prices. Max Murray of GFL said the company could build in verifiable parameters to the next contract on rate adjustments.

John Hafner, owner of Green Environmental, was concerned that his for-profit business was being singled out for an increased fee that he would have to pass on to his customers. Morse said the \$43.50 a ton rate, if approved, would be for trash collected from Labette County cities. Hafner noted that some of his customers live around Parsons and would have to pay more under the proposal because he is a for-profit business while the city of Parsons paid the lower rate. Committee member Tim Peoples said he had an issue with that as well if the transfer station charges Green Environmental one rate and the city of Parsons trucks another when the trash came from the same area.

Policing where the trash came from would be difficult for private businesses that cross county boundaries while collecting, committee members have heard and discussed in the past.

Hafner called the fee change proposal predatory pricing and indicated the Justice Department frowns on that.

"You can't single those customers out. All I'm going to do is pass it along. Right? The customers are going to get punished," Hafner said.

Hafner asked committee member Josh Hucke what rate he would have to pay as a stakeholder to the transfer station. Hucke's SEK Sanitation is a for-profit business that collects trash from Mound Valley and other customers and delivers it to the transfer station.

"Yeah, it's a little ambiguous to me, too," Hucke told Hafner.

Morse said the committee could look at a flat rate and not entertain the two-fee structure so that everyone was treated the same.

Committee members already expressed concern about paying the extra nearly \$3 per ton if the new rate is approved. Paying the flat rate proposed by GFL (\$55 per ton) would be even more difficult with tight city budgets.

County Counselor Brian Johnson recommended the committee meet in closed session for an attorney-client privileged discussion for 15 minutes.

When the committee returned to open session, no action was taken.

The committee will next meet at 2 p.m. Wednesday, Nov. 30, in the city commission room of the Parsons Municipal Building.
