Mayor Rod Smith called the meeting to order at 6:00 p.m. Roll call was taken with a quorum present.

At the aforementioned time and place, oral or written objections may be filed or made to the proposal to enter into the Agreement. After receiving objections, the City may determine to enter into the Agreement, in which case, the decision will be final unless appealed to the District Court within fifteen (15) days thereafter.

Pursuant to Section 1.150-2 of the Income Tax Regulations (the "Regulations") of the Internal Revenue Service, the City declares (a) that it intends to undertake the Project which is reasonably estimated to cost approximately \$119,000, (b) that other than (i) expenditures to be paid or reimbursed from sources other than the issuance of bonds, notes or other obligations (the "Bonds"), or (ii) expenditures made not earlier than 60 days prior to the date of this Resolution or a previous intent resolution of the City, or (iii) expenditures amounting to the lesser of \$100,000 or 5% of the proceeds of the Bonds, or (iv) expenditures constituting preliminary expenditures as defined in Section 1.150-2(f)(2) of the Regulations, no expenditures for the Project have heretofore been made by the City and no expenditures will be made by the City until after the date of this Resolution or a prior intent resolution of the City, and (c) that the City reasonably expects to reimburse the expenditures made for costs of the City out of the proceeds of the Bonds. This declaration is a declaration of official intent adopted pursuant to Section 1.150-2 of the Regulations.

Section 4. All resolutions or parts of resolutions in conflict herewith are hereby repealed to the extent of such conflict.

Section 5. This resolution shall be in full force and effect immediately upon its adoption and approval, as provided by law.

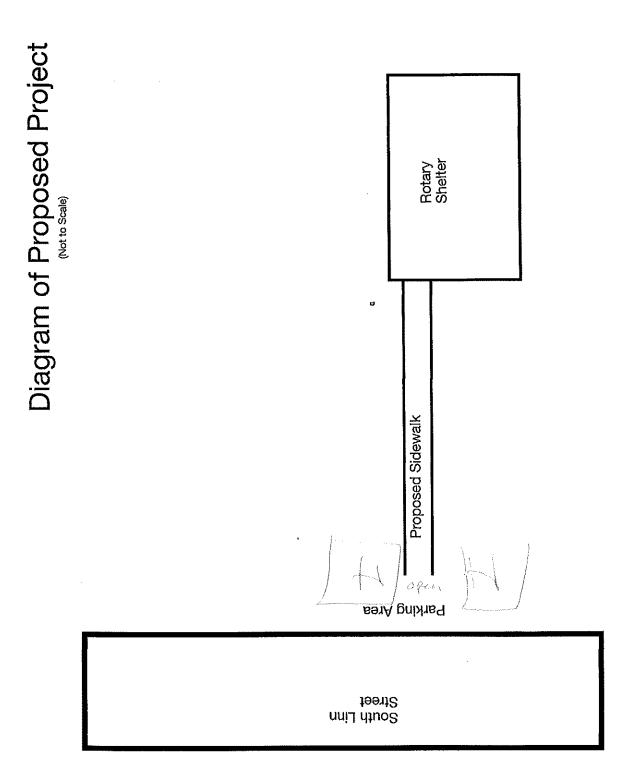

#### **CITY PROJECTS**

#### WWTP Flow Equalization Basin

We have adjusted the site layout and tank per the tank suppliers' information and now are working on submitting a floodplain construction permit application with the Iowa DNR and Army Corp of Engineers. A site visit is currently being scheduled to review the existing electrical layout. We are planning to have 90% drawings to the City for review by March 24<sup>th</sup> with final drawings to the City on April 10<sup>th</sup> to turn into the Iowa DNR for a wastewater construction permit.

#### <u>2nd Street Lift Station – Phase 2</u>

Final plans are ready for filing with the City Council after a letting schedule has been determined.

The nature of the project where the street profiles and pavement limits are being modified leads to impacts on the existing franchise utilities. The utilities within the project limits have all been notified of the project conditions, and those with impacts that may require relocations have been specifically notified of the project conditions. We will continue coordinating with these utilities with the expectation that any adjustments will be made without impacting project schedules.

#### **Old Dubuque Road Extension and Roundabout**

Working days have been suspended since January 13, with a total of 68 working days used and 70 days remaining and will likely remain suspended until weather conditions allow for the controlling work to progress. Snyder & Associates continued to support the City with the observation of the water main installation outside of the DOT participation. Our staff has also been reviewing the video from the newly installed and televised utilities and have identified deficiencies for the contractor to correct.
