RESOLUTION NO. 2022-57

Resolution approving Bond Purchase Agreement for the sale of General Obligation Corporate Purpose Bonds, Series 2022 thereunder

WHEREAS, the City of Anamosa (the "City"), in Jones County, State of Iowa heretofore proposed to enter into a general obligation corporate purpose loan agreement (the "Loan Agreement"), pursuant to the provisions of Section 384.24A of the Code of Iowa, and to borrow money thereunder in a principal amount not to exceed \$2,200,000 for the purpose of paying the costs, to that extent, of (i) constructing street, water system, sanitary sewer system, storm water drainage and sidewalk improvements; and (ii) acquiring and installing street lighting, signage and signalization improvements; and pursuant to law and duly published notice of the proposed action has held a hearing thereon on July 25, 2022; and

WHEREAS, a Preliminary Official Statement (the "P.O.S.") has been prepared by Dorsey & Whitney LLP (the "Disclosure Counsel") as bond and disclosure counsel to the City and Speer Financial, Inc. as municipal financial advisor (the "Municipal Advisor") to facilitate the sale of General Obligation Corporate Purpose Bonds, Series 2022 (the "Bonds") in evidence of the obligation of the City under the Loan Agreement, and the City Council has made provision for the approval of the P.O.S. and has authorized its use by UMB Bank, n.a. (the "Underwriter"), as the underwriter of the issuance of the Bonds; and

WHEREAS, a certain Bond Purchase Agreement (the "Bond Purchase Agreement") has been prepared to set forth the terms of the Bonds and the understanding between the City and the Underwriter with respect to the purchase thereof and it is now necessary to make provision for the approval of the Bond Purchase Agreement and its execution and delivery;

NOW, THEREFORE, It Is Resolved by the City Council of the City of Anamosa, Iowa, as follows:

Section 1. The City Council hereby approves the Bond Purchase Agreement in substantially the form as has been presented to the City Council. The Mayor and the City Clerk are hereby authorized to execute the Bond Purchase Agreement on behalf of the City and to deliver the same to the Underwriter.

Section 2. Further action with respect to the authorization of the Loan Agreement and the issuance of the Bonds is hereby adjourned to the City Council meeting on October 10, 2022.

Section 3. All resolutions and orders or parts thereof in conflict with the provisions of this resolution, to the extent of such conflict, are hereby repealed.

Section 4. This resolution shall be in full force and effect immediately upon its adoption and approval, as provided by law.

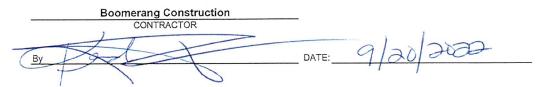

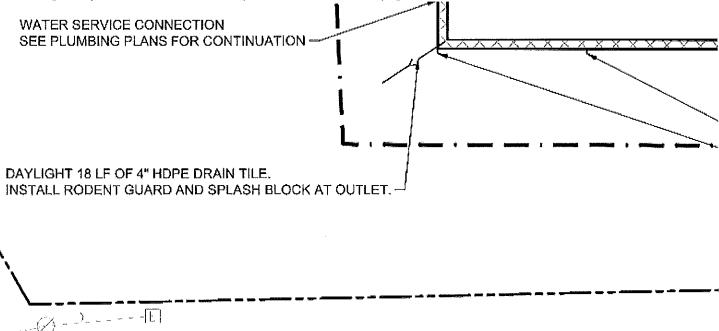

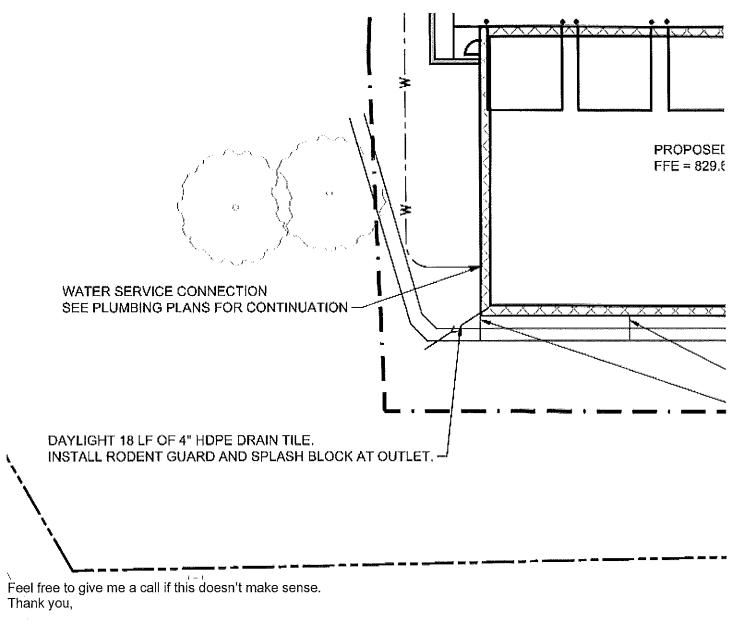

That is a great question. Here's what the plans have detailed on page C301:



Which shows the downspouts coming off the gutter and landing on a splash block (the concrete piece at the bottom of the downspouts). The 4" hdpe at the bottom left of the detail is for a subdrain that goes into the building. With what is designed, erosion will be a problem, since there is a large volume of water that will be coming off that roof. What Dan had proposed was to tie all the field tiles together, then discharge them northwest of the tree that is at the edge of the building. Phil had said to group the downspouts into groups with 8" ADS (field tile), so it would look like this:

AN ORDINANCE ADOPTING THE "CODE OF ORDINANCES OF THE CITY OF ANAMOSA, IOWA"

BE IT ORDAINED by the City Council of the City of Anamosa, Iowa, that:

SECTION 1. Pursuant to published notice and following public hearing on the 22nd day of August, 2022, so required by Sections 362.3 and 380.8, Code of Iowa, there is hereby adopted by the City of Anamosa, Iowa, the "CODE OF ORDINANCES OF THE CITY OF ANAMOSA, IOWA."

SECTION 2. All of the provisions of the "CODE OF ORDINANCES OF THE CITY OF ANAMOSA, IOWA," shall be in force and effect on and after the effective date of this ordinance.

SECTION 3. All ordinances or parts thereof in force on the effective date of this ordinance are hereby repealed from and after the effective date of this ordinance, except as hereinafter provided.

These reports are the upmost priority that we must focus on to attain that deadline. But, City Hall cannot do it alone with the timeline in front of us considering we have approximately a month to get data current and allow time for me to work on financial reports that are necessary.

Once the financials are made current we have the resources to process information timely. Additionally, we will be able to include financial statements in your council packets again (as soon as possible) so this will allow you to make informed financial decisions that are necessary.

Capital plan development begins with the establishment of long-term forecasting models that establish historical trends, current revenue and expense patterns, as well as future revenue raising abilities.

Revenue & Financing Requirements

The analytical approach centers on the concept that a financial plan should be both flexible and dynamic, ultimately reflecting the City's actual financial performance. To accomplish this, excel-based financial plans are created, built on deriving revenue projections from underlying usage and customer data as applied to the appropriate billing structure or from tax rates and underlying property valuations. This methodology allows for the testing of the impact of recommended modifications to user charges, as well as the ability to make ongoing adjustments throughout the fiscal year as data becomes available. Regular monitoring is especially important for a water utility (or sewer utilities for which billing is based on water consumption), as fluctuations in weather have a direct impact on usage and revenues.

For enterprise funds, the financial forecast begins with an in-depth review of system customers and usage; this data is modeled based on the billing structure, reflecting variances related to items such as meter sizes. Volume charges are also modeled separately from monthly access charges, allowing the City to isolate the potential revenue from each type of charge and evaluate proposed rate adjustments individually. After the rate structure is replicated IPA can evaluate both the adequacy of the existing rates and the impact of proposed rate changes on cash balances and debt coverage. Similarly, a proposed financing plan can be analyzed to determine its impact on revenue requirements. The flexibility of the forecasts allows the City to find the compromise between the size and timing of the capital program and any rate parameters put in place by Council.

When evaluating levy-based funds, valuations and tax rates are used to project revenue. Many cities prefer to keep the debt levy stable or slightly increasing to avoid sudden declines. This can be accomplished by using the debt levy model to monitor debt levels and valuation, which allows the City to structure future debt to achieve the desired levy. Tax increment revenues are evaluated in a similar way.





Finally, whether financing is funded by property tax or user fee revenues, this comprehensive analysis is used to determine available revenues to fund projects. Any costs that cannot be funded with cash while maintaining adequate liquidity or reserves will be identified as costs to be financed with debt.

STATE REVOLVING FUND

The State Revolving Fund ("SRF") program provides access to belowmarket rates for eligible projects, and can allow issuers to avoid the establishment of a reserve fund, and the cost of obtaining a credit rating. IPA has worked extensively with the program to develop loan structures that meet the needs of the borrower; options such as general obligation pledges, taxable loans, and deferred debt structures are available to increase flexibility. As your municipal advisor, IPA will support the application process by providing you with the proforma required to demonstrate financial feasibility for the loan.

TAX INCREMENT FINANCING

In addition to utility planning, IPA can assist the City with the evaluation of economic development incentives and proposals to be financed with tax increment. As tax increment revenues are derived from valuation growth as applied to the levies of a number of jurisdictions over which the City has no control, it is critical that any debt secured by increment be part of long term plan that includes the development of a tax increment cash flow. Ideally, the debt being contemplated can be funded based on existing valuations, and will not be dependent on continued growth.

Because increment revenues fluctuate annually with the tax rates of associated jurisdictions and changes in valuation, it is important to update this analysis on a regular basis to quantify capacity. In addition this analysis enables us to offer as much or as little assistance as desired in the preparation of the annual TIF report to the State.

The City of North Liberty, Iowa (the "City") was managed by IPA's president for approximately eight years before IPA was established. In 2012, the City took advantage of a significant increase in its road use tax allocation to fund bonds supported solely by road use tax collections as an alternative to general obligation bonds. Financial projections indicated that the population-based allocation was likely to stay flat, while operating expenses would grow over time. Although the fund would remain solvent, this imbalance would lead to an ongoing erosion of debt service coverage, which would make the bonds difficult, if not impossible to market.

To correct the problem, a gross revenue pledge was recommended. Bond holders were promised a first lien on all road use taxes collected, prior to the payment of operating expenses. As a result, debt coverage increased and the credit was strengthened. With guidance from IPA's President, North Liberty achieved a successful sale of one of Iowa's only road use tax revenue bonds on a competitive basis.

Over the past 10 years, bonds have been sold to finance water and sewer infrastructure, complete various City projects, undertake economic development, and to capture nearly \$545,000 in net present value debt service savings.
