Public Hearing Regarding Status of Funding for the City of Anamosa's Wastewater Treatment Improvement Project

Mayor Barnes opened the public hearing at 6:02 p.m.

Gary Hughes, ECICOG addressed the Council giving the following update on the status of funded activities for the Wastewater Treatment Plant Improvement Project.

The City's Wastewater Improvement Project, funded through the Federal Community Development Block Grant (CDBG) Program, requires that the following topics be considered during this "Status of Funded Activities" Hearing.

As required, it is noted that:

- a. For a general description of accomplishments to-date, a construction contract in the amount of \$5,090,000 was awarded to WRH, Inc. on December 27, 2010. Based on invoicing received, it estimated that approximately 55% of equipment acquisition and work was complete through October 2011. Constructed improvements generally comprise: excavation and earthwork; storm sewer piping installations; completion of concrete lift station structure; and near completion of concrete Aero-Mod treatment structure.
- b. For a summary of expenditures to-date, through October 2011, a total of \$3,309,507 had been invoiced. \$3,294,407 for design and construction, and \$15,100 for grant administration. The cost of grant administration is reimbursed 100% by the CDBG Program. All other costs are reimbursed 50% each by the CDBG and I-JOBS Programs.
- c. <u>For a general description of remaining work</u>, based on invoicing received through October 2011, it is estimated that 45% was pending at that time. Remaining construction generally comprises: treatment process pipework; headworks building construction; and process equipment installations. It is presently estimated that the project will be completed by October 31, 2012.
- d. <u>For a general description of changes made to the project budget, performance targets, activity schedules, project scope, location, objectives or beneficiaries,</u> no such changes have occurred to-date.

No comments were offered by the public present. Motion by Feldmann, second by Shaffer to close the public hearing at 6:04 p.m. All Ayes. Motion Carried.
