MINUTES OF MEETING, ATHENS CITY COUNCIL, JULY 17, 2012

The Athens City Council met in regular session on Tuesday, July 17, 2012, at 6:00 p.m. with Mayor Buttram presiding. The invocation was given by Mayor Buttram; and upon roll call, the following members were present:

-1-MINUTES

The Minutes of the regularly scheduled meeting of June 19, 2012 was submitted and approved by unanimous consent.

Council Member Jackson raised a point of order. He informed the City Council and residents of the City of Athens that he had recently received a new job and had an opportunity to move his career to Knoxville, Tennessee. As of last week, he had moved his permanent residence to Knoxville. He thanked his fellow council members and citizens of Athens for his last four years on the Council and apologized for not fulfilling his full term on the City Council. Council Member Jackson stated that by City Charter he was required to step down from his position and his position would be left vacant. Mayor Buttram and members of the City Council expressed their thanks to Council Member Jackson for his years of service and expressed their best wishes for his future. Mayor Buttram stated that according to the City Charter, when any vacancy in the council occurs, the vacancy shall be filled by appointment of the council members. He announced that the City Council will be taking applications from anyone in the city that would like to fill the vacancy of Council Member Jackson. The nominations will be received in the City Manager's office by August 10, 2012 at 4:00 p.m. which would give the City Council time to review the applications prior to the August 13, 2012 City Council Work Session.

PRESENTATION OF TENNESSEE ASSOCIATION OF CHIEFS OF POLICE (TACP) LEADERSHIP CERTIFICATION TO CHIEF CHUCK ZIEGLER

Chief David Rausch, Knoxville Chief of Police, stated he was a representative of the Tennessee Association of Chiefs of Police (TACP) on which he serves as District 2 board member. Chief Rausch explained that the TACP has been focusing on professionalizing police departments in Tennessee. The Tennessee Law Enforcement Accreditation Program was created under the direction and authority of TACP as one way of achieving that goal. To date, approximately 20 cities have received their accreditation. The Leadership Certification Program was established as a way of recognizing chief administrators and senior staff individually to show they have shown a commitment to law enforcement and they are a step above in professionalism. Chief Rausch explained the process an individual must go through in order to be considered for certification and the four levels of certification. Chief Chuck Ziegler was recognized by the Tennessee Association of Chiefs of Police (TACP) for Excellence in Leadership and was awarded a Level 4 Leadership Certification which is the highest level of achievement.
