RESOLUTION NO. 2019-08 TO APPROVE THE SALE OF REAL ESTATE

WHEREAS, Bath Township owns real estate located at 1070 Ghent Rd., being legally described in a document attached hereto and identified as Attachment 1; and,

WHEREAS, the property at 1070 Ghent Rd. is comprised of 2 parcels, on which a commercial building exists on the property; and,

WHEREAS, above parcels of real estate are zoned B-1 Gateway Business District; and,

WHEREAS, Bath Township intends to sell the above-described real property in accordance with R.C. 505.10 (A)(6); and,

WHEREAS, an appraisal of said property by a state licensed real estate appraiser, said appraisal dated December 4, 2014, has been publicly available since that date; and is attached hereto as Attachment 2; and,

WHEREAS, the property has been available for sale by Bath Township since December 4, 2014; and,

WHEREAS, R.C. 505.10 authorizes the Bath Township Board of Trustees by

unanimous vote to make all orders for the sale of the Township's real property that may be deemed conducive to the interests of Bath Township and sets forth the procedures by which the sale process may be conducted;

NOW, THEREFORE, IT IS HEREBY RESOLVED AND ORDERED by the Bath Township Board of Trustees that:

Section 1. That the Bath Township Board of Trustees may accept the highest and most responsible bid, or any other bid determined to be in the best interests of the township by unanimous vote of the Board of Trustees, or, the township board may reject any and all bids.

Section 2. That following acceptance of a bid, the Bath Township Board of Trustees is authorized to negotiate the final terms and conditions of the sale, based on the terms and conditions of sale approved by the trustees herein, and approve a sale based on the Board's determination such sale is in the best interest of the Township.

Section 3. That Bath Township Administrator, Vito F. Sinopoli, is hereby authorized to execute all documents in connection with the sale of said real estate.

FURTHER, that the Fiscal Officer be directed to use the General Revenue Fund, and if the sale is finalized, to amend the 2019 Certificate of Estimated Resources and the Permanent Appropriations to reflect the new revenue and expenses.

Second by Mr. Nelson; discussion and roll called:

Mrs. Goodrich moved to amend Section 3 as follows:

Section 3. That Bath Township Administrator, Vito F. Sinopoli, is hereby authorized to execute all documents in connection with the sale of said real estate to Stonemill Real Estate, LLC.

Mrs. Corbett seconded the amendment to the resolution; all aye, the motion passed.
