## PRESENTATION OF ZONING CASE ZC-21-02

Mr. Funk gave a presentation of the proposed text amendments.

- Article 7, Section 701-D (17) (A) Solar Panels Freestanding Panels to require
  a Zoning Certificate and increase permitted area of freestanding solar panels
  form 50 sq. ft. to 350 sq. ft. Clarified setbacks and size of array per parcel.
- Article 12, Section 1204-D (1)(B) Design Standards for Off-Street Parking –
  Increased minimum driveway or parking surface setback from one foot to five
  feet
