EXECUTIVE DIRECTOR REPORT

Ms. Bartlett pointed out that she had previously circulated the report. She added that the Finance report was streamlined to specifically identify CARES Act funds received from HUD. Also, an itemized list was provided and identified additional CARES Act awards from other funding sources. Including \$7M in funds targeting households that are precariously housed or homeless.

The only other update would be the HHH opening. The County is mandating vaccinations for shelter employees, as well as any partner agencies operating at the shelter. Due to this requirement, some staffing issues have arisen and has pushed back the opening of the shelter to a tentative date of June 7th.

ATTORNEY REPORT

Terry Corriston reported that notice from the Courts has been received stating that they are preparing to open back up to proceed with eviction actions. The eviction process will change with more emphasis placed on settling rather than evicting.
