WHEREAS, the Housing Authority of Bergen County (HABC) administers and manages the Bergen County Housing, Health and Human Services Center, with a mission of ending homelessness by providing a full continuum of housing services including homelessness prevention, temporary shelter, and permanent placement.; and

WHEREAS, United Community Corporation (grantor) wishes to enter into a subgrantee agreement with the HABC to provide additional funds to assist in this mission; and

WHEREAS, the objective is to significantly reduce homelessness in the State of New Jersey by enhancing the quality and accessibility of emergency shelter services, fostering community engagement with sheltering providers, provide capital funding, and assist in facilitating the transition of individuals to stable and permanent housing; and

WHEREAS, the term for this agreement shall be one year beginning June 15, 2023 and terminating on June 30, 2024, in the amount of \$85,500.00 which shall be dispersed as described within the agreement; and

WHEREAS, the HABC and Bergen County Housing, Health and Human Services Center have the experience and staff to complete the required deliverables as described within the agreement which will better serve and reduce the homeless population within Bergen County and the State of New Jersey.

NOW, THEREFORE, BE IT RESOLVED, the Commissioners of the Housing Authority of Bergen County authorize the Executive Director to execute the sub-grantee agreement with United Community Corporation for the BRIDGES Program in the amount of \$85,500.00.
