Dave Wohlford, Sedgewood asked if the street sweeper had been fixed and if the fire hydrants had been tested. He stated that not being able to open and operate them or flushing the lines was concerning and it was time to test all of the hydrants. He also asked what treatment was being put in the water because it was leaving mold in his toilet. He stated that there was a lot of glass at the old Sedgewood pool that needed to be picked up because kids were playing soccer there. He stated regarding Mr. Jones's illness that in his experience with talking to physicians that they say after a couple of months that the results you see was what you were going to get. He stated that he knew it was a personal matter but that it was time to bring it out in the open and talk about it and do something because the code stated you could not miss more than 3 meetings. He stated that Mr. Jones was not involved in the acquisition of Fincastle and that a vacant seat showed no respect to the community.

Donnie Linkous suggested regarding the political signs that the board abolition them or enforce them because for the past 20 years they had been enforced to a "T" until he ran. He stated that regarding Mr. Jones that he did not think there was anything in the charter that stated an elected official had to come to the meetings but that it may say something as to they would not get paid. He stated that there was nothing in the charter that stated the Mr. Jones had to be replaced but that it may be something they needed to look at in the future.

Mr. Holt rescinded his motion. He stated that he agreed the ordinance needed to be repealed because it only allowed for arguments at election time. He stated that they were trying to take steps to correct it and steps to address our sick councilmember.

Mr. Bailey stated concerning political signs that in his opinion they could not have an ordinance that they could not enforce and that the fire hydrants were also a concern of his and he had been talking to Mr. Watson concerning them.

AN ORDINANCE TO AMEND SECTION 22-92 (REMOVAL) OF ARTICLE III (INOPERABLE MOTOR VEHICLES) OF CHAPTER 22 (ENVIRONMENT) OF THE CODE OF ORDINANCES, TOWN OF BLUEFIELD, VIRGINIA

BE IT ORDAINED BY THE COUNCIL OF THE TOWN OF BLUEFIELD, VIRGINIA that Section 22-92 of Article III of Chapter 22 of the Code of Ordinances, Town of Bluefield, Virginia is hereby amended to read as follows:

Sec. 22-92. Notice; removal; disposal; costs; and lien.

The property owner(s) of property zoned for residential, commercial or agricultural purposes, upon being notified as described in section 22-54 of this chapter, shall remove therefrom any inoperable motor vehicle, trailer or semitrailer which is not kept within a fully enclosed building or structure or is not shielded or screened from view. Any such notice, once given, shall be effective for a period of twelve (12) months thereafter, and no further notice shall need to be provided within the said twelve (12) month period. The property owner(s) may appeal the alleged existence of an inoperable motor vehicle, trailer or semitrailer. The appeal process hereunder shall be the same process stated in section 22-54 of this chapter.

In the event the property owner(s) fails to remove an inoperable motor vehicle, trailer or semitrailer after being notified as provided herein, then the town, through its agents or employees, may remove such inoperable motor vehicle, trailer or semitrailer.

In the event the town, through its agents or employees, removes an inoperable motor vehicle, trailer or semitrailer from any property within the town, then the town may further dispose of such inoperable motor vehicle, trailer or semitrailer after providing fourteen (14) days' notice to the owner(s) of such inoperable motor vehicle, trailer or semitrailer. Such notice shall be provided by certified mail with return receipt requested to the last known address of the owner(s) of the said inoperable motor vehicle, trailer or semitrailer.

The costs of removal and/or disposal of an inoperable motor vehicle, trailer or semitrailer incurred pursuant to the authority of this section shall be chargeable to the owner(s) of such inoperable motor vehicle, trailer or semitrailer or to the property owner(s) of the property where such inoperable motor vehicle, trailer or semitrailer was removed. Such costs may be collected by the town as taxes are collected. Any costs authorized by this section with which the property owner(s) has been assessed shall constitute a lien against the property from which such inoperable motor vehicle, trailer or semitrailer was removed, and such lien shall continue until actual payment of such costs have been made.

BE IT FURTHER ORDAINED BY THE COUNCIL OF THE TOWN OF BLUEFIELD, VIRGINIA that this ordinance amends and reenacts Section 22-92 of Article III of Chapter 22 of the Code of Ordinances, Town of Bluefield, Virginia.

BE IT FURTHER ORDAINED BY THE COUNCIL OF THE TOWN OF BLUEFIELD, VIRGINIA that this ordinance is hereby adopted on this 24th day of September, 2019.

AN ORDINANCE AUTHORIZING THE TOWN OF BLUEFIELD TO DISPOSE OF AND QUITCLAIM ALL OF ITS RIGHT, TITLE, AND INTEREST IN 830 GREEVER AVENUE, 826 GREEVER AVENUE, AND 129 DEPOT STREET WITHIN THE CORPORATE LIMITS OF THE TOWN OF BLUEFIELD

WHEREAS, pursuant to Article VII, Section 9 of the Virginia Constitution, "[n]o rights of a city or town in and to its an apublic places and shall be sold except by an ordinance or resolution passed by a recorded affirmative vote of three-fourths of all members elected to the governing body,"; and

WHEREAS, pursuant to Section 15.2-2100(A) of the Code of Virginia (1950) as amended, "[n]o rights of a city or town in and to its ... public places shall be sold except by an ordinance passed by a recorded affirmative vote of three-fourths of all the members elected to the council"; and

WHEREAS, pursuant to Section 15.2-1800(B) of the Code of Virginia (1950) as amended, "[s]ubject to any applicable requirements of Article VII, Section 9 of the Constitution, any locality may sell, at public or private sale, ... or otherwise dispose of its real property ... provided that no such real property, whether improved or unimproved, shall be disposed of until the governing body has held a public hearing concerning such disposal."; and

WHEREAS, pursuant to Section 15.2-953 of the Code of Virginia (1950) as amended, a town may also donate real property to certain entities/organizations; and

WHEREAS, all the real estate described in this ordinance, including the improvements thereon and the appurtenances thereunto belonging, has been determined to be surplus real estate by the Town Manager of the Town of Bluefield, and has little or no value to the Town of Bluefield, a Virginia municipal corporation, hereinafter "the Town"; and
