The registration year runs January 1st through December 31st. All contractor registrations expire on December 31st. Contractor registrations are non-transferable & non-refundable.

REGISTRATION FEES:

- All contractors (with the exception of those who hold State of Illinois licenses) are required to pay an annual Contractor Registration fee of **\$75** per trade.
- Accepted payment methods are cash, check, or credit card (except AmEx); however, there is an additional processing fee for credit card payments. Payments are not accepted over the phone.

REQUIRED LICENSES:

- The following State licensed contractors must provide a copy of the current State of Illinois license: Alarm, Elevator, Fire Suppression, Irrigation, Plumbing, Radon, and Roof. There is no registration fee for state licensed contractors.
- Plumbing: Plumbing contractors must provide a copy of their current State of Illinois (058-) or City of Chicago license and their State of Illinois Plumbing Contractor Registration (055-).
- Electrical: Electrical contractors must provide a copy of their current electrical registration/license. The Village honors registrations of any Illinois municipalities that requires a written exam prior to the issuance of the license/registration.

AFFIDAVIT

The undersigned shall indemnify and hold harmless the Village, its officers, employees, and agents from any and all claims, lawsuits, actions, costs, and fees (including attorney fees and expenses) of every nature or description, arising from, growing out of, or connected with the work or because of any act or omission, neglect, or misconduct of the undersigned, its officers, employees, agents, its subcontractor(s), and/or anyone for whose acts they may be liable. This obligation is binding on the undersigned without regard to whether or not such claim, damage, loss, or expense is caused in part by the act, omission, or negligence of the Village or its officers, employees, or agents. This shall not constitute a waiver by the Village of any right, privilege, or defense available to the Village under law including the Illinois Tort Immunity Act.
