AN ORDINANCE RENEWING SPECIAL USE PERMIT (CANNABIS)

WHEREAS, Connie Schrock ("Petitioner") has filed with the City an Application for Renewal of Cannabis Business Establishment Special Use Permit requesting renewal of the special use for a cannabis dispensing organization at 1734 N. Santa Fe, Chillicothe, IL which was granted by the City on December 9, 2019 by Ordinance No. 19-12-38 (the "Special Use Permit"); and

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF CHILLICOTHE, PEORIA COUNTY, ILLINOIS, AS FOLLOWS:

Section 1: The City hereby renews the Special Use Permit for a term to expire on the fourth Tuesday of May, 2023, such special use to be in accordance with the Application for Cannabis Business Establishment Special Use Permit filed by Petitioner on November 11, 2019.

Section 2: This Ordinance shall be effective as of the date of its passage and publication as provided by law.
