NEW OR REPLACEMENT OF EXISTING SIDEWALKS**

Dear Property Owner:

This is to acknowledge your request for information concerning the City's **Commercial/Institutional Sidewalk Participation Program**. This program shares in the cost of New Sidewalks with structures built after 1989 or replacement of sidewalks, and curbs. The City will reimburse property owners 25% based on the low proposal and is **subject to prior approval of application**. The City's share is based on the unit prices within the low proposal. However, if you prefer to choose a contractor with a higher proposal, you will be responsible for paying the difference. To improve access to the limited funds available, the maximum participation by the City for any one Commercial or Institutional property owner is \$3,000 and a Commercial or Institutional property owner may submit a maximum of two properties.

TO APPLY: Submit a completed Sidewalk Participation using the following guidelines:

A minimum of two proposals, from contractors currently listed by the City Clerk as approved for sidewalk construction in the City of Chillicothe, must accompany the completed application.

Each proposal must include the same lineal foot or square foot quantities. Differences will slow the approval process.

Applications will be accepted through September 15th of this year or until allocated funds have been exhausted. All work must be completed before the calendar year end.

The City will notify you if your application is approved or disapproved. Approval is valid for the current calendar year only.

FOR REIMBURSEMENT:

When work is completed, you pay the contractor the full amount for his services.

Forward the paid receipt to City of Chillicothe - City Hall. You will then be reimbursed the previously approved amount.
