The first phase of the campus revitalization includes building a new entrance road from Rte. 41 to help reduce traffic on Deerpath. With approval of the Army Corps of Engineers, construction can begin in mid-July and be completed by November, 2013. EMERALD ASH BORER RESIDENT WORKSHOP

Residents are encouraged to attend the EAB Resident Workshop, co-hosted by The City of Lake Forest and The Village of Lake Bluff. The Workshop is designed to help answer questions and prepare residents for EAB. Community tree professionals

will join local forestry departments to provide education, resources and assistance. In preparation for the insect's invasion, an Emerald Ash Borer Resident Guide was mailed in the spring to each household in Lake Forest. This publication provides essential information to help residents manage their ash trees and prepare for potential losses. Information on ash tree identification, signs and symptoms of EAB, hiring an arborist, treatment options and "re-greening" the community was included in this Guide. How residents prepare for EAB is important. Having no plan may lead to excessive costs, unnecessary liabilities and loss of property value. However, having a well thought-out management strategy will cost far less in the long run, and will help manage your greatest investments, your home and property. FOREST PARK: REHABILITATE, ENHANCE AND PRESERVE



Above: artist's rendering of the future Ring Road. Since January 2013, significant progress has been made in a variety of areas and the Construction Implementation Phase is off to a terrific start. Tree work on the tableland and bluff began in February and Kinnucan Tree Services and Nels Johnson Tree Experts donated their services in support of the project. Tree removals and trimming ensued over the northern half of the park and bluff, setting the foundation for the infrastructure work and rehabilitation of the landscape. Tree pruning and removal is being done under the guidance of the landscape architects and City Forester, and is based upon: the re-opening of the vistas, the goal of proper tree care, bluff stability and erosion benefits and establishing a high-quality, ecologically-diverse landscape contributing to the rehabilitation of the park. Several existing trees on the tableland will be relocated later this fall and tree work in the southern half of the park will be completed this winter. New plantings will be phased in over the next year. Infrastructure improvements, including the park's storm sewer, lighting, roadway and south parking lot will most likely begin late this summer or early fall.

IT'S CONSTRUCTION SEASON

Keys to a Smooth Project:

Permits, Inspections and Bonds

If a construction project, large or small, is in your future, knowing about permits, inspections and bonds can help save you time and money.



Permits

A permit is required for most projects. Examples:

- remodeling, repairs, alterations
- building additions, garages and sheds
- electrical and plumbing work
- exterior lighting
- decks and gazebos
- installation of yard drains
- water service changes and sewer repairs
- swimming pools, hot tubs, spas
- heating/air conditioning work
- patios and driveways
- driveway resurfacing
- satellite dishes, ham radio antennas
- lawn sprinklers
- tuck pointing, roofing and siding
- fireplace installation
- fences, walls and pillars
- yard grading, filling or berming

Inspections

As your project progresses, your contractor should periodically call to schedule inspections. A list of the inspections required for your project will be provided with your building permit. It is important that inspections occur at the appropriate point in your project to avoid the need to remove construction materials that may be covering wires, pipes or mechanical equipment. Inspections can usually be completed within one to two business days of a request.

Bonds

Upon completion of your project, a final inspection is required. Successfully passing the final inspection

before the expiration date of the permit can result in a refund of the cash bond that is posted at the time the permit is issued. In addition, the final inspection triggers closing of the building permit. Most building permits are valid for one year from the date of issuance. An extension of one year can be granted if reasonable progress is being made on the project, subject to a fee.

Project Tips

1. If you have questions on setbacks, building scale, compatibility with other homes in your neighborhood, tree preservation, or Board review process, contact the Community Development Department *early in the process*.
2. Be sure you or your contractor obtains a permit *before* beginning work.
3. Submit clear, complete plans and a current property survey to avoid delays.
4. If your plans change after permits are issued, submit revised plans before you allow your contractor to do work that differs from the approved plans.
5. Instruct your contractor to keep the site and street clean, avoid parking on neighbors' lawns or obstructing driveways, and to keep all construction fencing in place until approval is granted by the City to remove it.
6. Be sure your contractor calls for a final inspection. A new or replacement house may not be legally occupied until a Certificate of Occupancy is issued. For other projects, a final inspection is also required.
7. A permit that is not closed out is recorded against your property deed and causes delays when the property is sold.
8. Cash bonds are required at the onset and unless bond money is needed to correct damage to public property, cash bonds are returned to the owner after final inspections.

Please Recycle with Precision

Lake Forest's Recycling Program has been a great success, thanks to you. Last year, residents recycled the highest tonnage of material in the program's history. In order to keep it successful and utilize the City's recycling equipment to its fullest potential, correct cart placement is essential. Please remember the following:

- ❑ **Park It:** Place your recycling cart within 5 feet of the curb or road edge
- ❑ **Point It:** Place your recycling cart with the handle and wheels facing the house
- ❑ **Give it Space:** Place your recycling cart at an arm's length (3 feet with clearance on all sides) from obstructions such as light poles, mailboxes or parked vehicles

Following these guidelines will enable City crews to empty the carts with less spillage and will save time by not having to move the cart to the correct position before the recycling truck empties it. If you have any questions or would like to purchase an additional cart, please call 847.810.3542.

Memorial Day Holiday Collection Schedule

There will be no refuse, recycling or yard waste collection on Monday, May 27.

- Monday collection will be on Tuesday
- Tuesday collection will be on Wednesday
- Thursday collection will remain on Thursday
- Friday collection will remain on Friday

Fourth of July Holiday Collection Schedule

There will be no refuse, recycling or yard waste col-

lection on Thursday, July 4.

- Monday and Tuesday collection will remain the same
- Thursday collection will move to Friday
- Friday collection will move to Saturday

WATERING/SPRINKLING UPDATE

Water Restrictions Take Effect May 15

The Illinois Department of Natural Resources and City ordinance state that sprinkling restrictions are now in effect through September 15.

- Sprinkling is permitted on odd or even days, based on the odd or even last digit of your street address.
- *Sprinkling between 10 a.m. and 8 p.m. is NOT permitted. Irrigation MAY occur on designated days from midnight until 10 a.m. and from 8 p.m. until midnight. For example, if your address is 809 Smith Street, you may water on June 9 from midnight until 10 a.m. and from 8 p.m. until midnight only. These rules have been enacted because water used on lawns during most daytime hours is quickly evaporated, and the City's water plant needs daytime hours to replenish water reserves in the water tower.*
- Please make sure your irrigation systems are programmed to comply with these regulations. Newly-installed lawns and landscaping, exempt from these restrictions, may be watered daily for a reasonable period after installation.

These water restrictions allow for half of the residents to water every day. However, in the event of drought or an emergency water shortage, the City may have to impose further restrictions.

Help Prevent Stormwater Pollution

- Reduce the use of pesticides
- Clean up pet waste
- Aim downspouts away from driveways and sidewalks
- Dispose of hazardous chemicals properly
- Repair vehicles with oil leaks
- Don't over water your lawn; use soaker hose in place of a sprinkler

BMW CHAMPIONSHIP TO BRING WORLD'S TOP GOLFERS TO LAKE FOREST THIS SEPTEMBER

On September, 9-15, Lake Forest will host the 2013 BMW Championship at Conway Farms Golf Club, drawing the PGA Tour's top golfers to the area for the first time. Tiger Woods, Phil Mickelson, local favorite Luke Donald, 2012 BMW Championship winner Rory McIlroy and 2013 Masters champion Adam Scott of Australia are expected to be among a field of 70 of the world's top players who will grace the fairways. Luke Donald, who won the individual NCAA Championship while playing for Northwestern University, is a North Shore resident and Conway member. In 2011, he ascended to No. 1 in the world golf rankings, a position he held for 55 weeks.

Named "Tournament of the Year" by the PGA Tour last year, the BMW Championship is conducted by the Western Golf Association for the benefit of the Evans Scholars Foundation. The BMW Championship is the penultimate event of the PGA Tour's Playoffs for the FedEx Cup - the top 30 from which will compete at the Tour Championship to determine the winner of the FedEx Cup. Founded in 1899 as the Western Open, the tournament is the second oldest in the U.S. behind the U.S. Open. In addition to raising millions of dollars for the Evans Scholars charity, the BMW Championship is expected to have an estimated economic impact of \$30 million on the North Shore and the surrounding area.

A free shuttle service will be available from both of Lake Forest's train stations. NBC and The Golf Channel will broadcast the entire tournament. Volunteer opportunities are still available.
