# Mayor's Message



The City Council is preparing for a busy year. The 2012 Strategic Planning Group, comprised of the Council and other community leaders, re-convened in August. At that meeting, we determined the status of the Initiatives Action Plan, and I am pleased to report that nearly

100% of those initiatives are either complete or in process. The full report is on the City of Lake Forest website and will be presented to the City Council in September. While considering these plans, the City is actively promoting our four core concepts of Family, Education, Tradition and Philanthropy.

Family
Lake Forest is first and foremost a residential community. Despite a difficult economy, we are still able to maintain the lowest property taxes along the North Shore. Additionally, the City continues to look at ways to provide a variety of housing options. Through the efforts of Community Partners for Affordable housing, four existing houses have been acquired, improved and sold to families with local ties to our City, schools and Lake Forest College. The City is also considering development on the former Municipal Services site on Laurel Avenue, which may include townhomes, apartments and condominiums. Other projects that will enhance the attractiveness of Lake Forest include: designing a Bicycle Master Plan; continuing the beautiful restoration of Forest Park; beginning construction of Northwestern Lake Forest Hospital this fall; and creating additional family events, sponsored by the City and community organizations, that will offer our residents even more ways to enjoy Lake forest. I am also pleased to report that Youth Services at CROYA and Senior Services at Dickinson Hall continue to flourish and participation is increasing.

# Education

The foundation of education has been, and continues to be, paramount to our City and its residents. Lake Forest has an abundant number of educational institutions for **all** residents to utilize. From the large number of preschools, the excellent choices in private and public schools, Lake Forest College, the Lake Forest Graduate School of Management and all of the seminars and classes offered through our numerous religious institutions and Northwestern Lake Forest Hospital, it is evident that our City places great importance on learning and continuing education. Early Catholic pioneers arrived in the area in 1832, Presbyterians arrived and established Lake Forest College in 1857 and the First Presbyterian Church in 1859, and Lake Forest Academy opened in 1858 (all prior to the City's Charter, written in 1861). A very impressive religious and educational foundation!

# Tradition

Architectural and natural beauty is all around us, but Tradition in Lake Forest is not necessarily described by its customary definition. It can also be characterized by Innovation. I refer to the City's 150th Anniversary Celebration, held in 2008, and to the words of Tom Dickelman: "For what comes with the privelege of calling this very special place home is the responsibility of ensuring it will be here for generations to come. It behooves us to foster a creative culture and energy and spirit that will allow innovation...the list of Lake Forest innovators, entrepreneurs, risk takers, goes on and on...those who just didn't think outside the box but in some cases dared to re-invent the box. These people carried with them a creative spirit that is the foundation of this City." It is the duty of the entire City Council to balance innovation and vitality with the important community qualities and traditions that define who we are. While we work to maintain the character and relevance of our City and its charm, we must also make intelligent decisions in order to plan for the preservation of its future.

Philanthropy

Last year, over 1 million hours of volunteer service were provided in The City of Lake Forest. Volunteers are the lifeblood of Lake Forest. You work hard to maintain and enhance the City's (continued on following page)

Community Engagement Forum: "Energy: Where Does It Come From and Where Does It Go?" on Thursday, November 6, 7-8:30 p.m. at CROYA, 400 Hastings Road.

# NORTHWESTERN LAKE FOREST HOSPITAL

Construction at the Hospital entrances on Deerpath and Waukegan Road will continue until early October.

After an 18-month review and approval by the City's Plan Commission, the City Council and countless residents and community leaders, the new Hospital is scheduled to open in 2017 and will include 114 private beds and eight operating rooms. The new inpatient and ambulatory care facility will support a patient-centered experience and feature the latest technologies so that patients benefit from the most advanced diagnostics and leading-edge treatments.

The new facility is designed to be adaptable as healthcare evolves, offering the highest levels of safety and quality as well as cost-effective care. Its affiliation with Northwestern Medicine's academic health system will continue to create a healthcare environment where expert physicians will offer new medical breakthroughs to positively impact lives.

The thoughtful redesign of the 160-acre campus integrates medical care with health and wellness through linked walking and biking trails to the Lake Forest Health & Fitness Center, as well as a new common area for community activity. Drawing upon Northwestern Medicine's commitment to sustainability and green design, 72% of the campus will be maintained as open space.

# FOREST PARK

## REHABILITATE - ENHANCE - PRESERVE



The Forest Park Project Board is moving forward despite a slow, weather-related start to this past summer season. You will notice a "progress schedule" posted along the cross-path that continues just beyond Deerpath. This display allows a birds-eye view of the project. You will see the major addition of a pedestrian path; once completed, you will be able to circumnavigate Forest Park without walking on the road with automobiles.

Thanks to recent Park enhancements, stunning vistas are now open to Lake Michigan. As you stroll the new path system, you will notice a natural pattern of plantings framing these views that allows even greater appreciation for the recently-opened panoramas. During late spring, summer and fall, the deciduous trees provide a green veil, shielding some of the yet-unseen views. As



the leaves color, fall away and temperatures lower, more expansive views open throughout the winter, offering an even broader panorama. The limestone edging for the new paths and final grading of the pathway will be finished by the end of August. The path will be similar to the path surface used at Elawa Farm, only finer. Once complete, there will be over 1,300 feet of new Park and woodland paths. Work will commence on the

terrace areas at the top of the Belvedere and the South Parking Lot, and work on the path from Deerpath to the Belvedere will continue through October. The foundations for the bluff-side benches will begin to be installed, and a portion of the benches will be be put in this fall with the remainder to go in next spring. The planting of trees is nearing completion (a total of 500 new trees). The next focus throughout the fall, will be on the addition of shrubs and herbaceous ground material.

#### **FUNDRAISING UPDATE**

The Board is excited to report that the fundraising campaign within the community for the Forest Park Project is moving into its final phase. To date, over 210 Lake Forest families and businesses have contributed gifts ranging from \$50-\$250,000, totalling over 2.47 million towards the \$3.2 mil-



lion goal. Approximately \$725,000 remains to be raised. As a tribute to the community support, an appropriately-designed donor board within the Park will list contributors of \$1,000 or more. Members of the Legacy Circle (gifts of \$100,000 or more) will be further recognized with their names engraved on a bench overlooking a primary lakefront vista. The Board's goal is to have Lake Forest families and businesses represented on the donor board in perpetuity for contributing to the good stewardship and honoring the Park's historical significance now and for generations to follow.

# DEERPATH GOLF COURSE... A PARK PERSPECTIVE

Deerpath Golf Course plays a vital and critical role in delivering recreation services but also in serving the community with numerous other inspirational benefits that may not be so obvious.

Deerpath Golf Course, a City of Lake Forest public facility, consists of 130 acres in the middle of Lake Forest. It provides a natural habitat for numerous wildlife including red-winged black birds, hawks, squirrels, amphibians, foxes and many others. The property is home to hundreds of native trees, including oaks, walnut and maple trees. Built on land donated to the City by the A. B. Dick Family in 1927, the Course has served residents and the surrounding communities for over eight decades and has a strong history and tradition in the community. Golfers of all ages enjoy the green spaces from early morning to late evening nine months of the year. During the winter, many residents enjoy the miles of cross-country ski trails created across the property. These property uses seem obvious, but many residents may not realize the many other contributions Deerpath Golf Course provides for the community.

Deerpath Golf Course sits within a large flood plain.



This past spring, the grounds captured and retained millions of gallons of water until the Skokie River and City storm sewers were able to safely carry it away. Had the course been developed into residential or commercial use, the community would lose this very natural and essential flood control benefit. In 2005, additional ponds, wetlands and native areas were also added to help with storm water management in the neighborhoods. The wetlands and native areas, in conjunction with the ponds, help clean the water before it reaches the Skokie River or enters ground water sources and reduces flooding in residences and businesses along this central waterway. Water from the Golf Course and Skokie River will eventually make its way some 400 mile to the Mississippi River and ultimately to the Gulf of Mexico.

In addition, the Course also strives to operate in the most environmentally sound manner possible by reducing water usage and using as few chemical treatments as possible. Recent software upgrades allows the irrigation system to efficiently and effectively target watering of specific areas such as tees, greens or fairways at times of greatest need and benefit. Further, the property has converted numerous acres to native areas, versus manicured spaces, to further reduce water consumption. These are just some of the benefits of this outstanding public property.

So the next time you drive by or play Deerpath Golf Course – think about what this property offers Lake Forest. It is another example of a successful philanthropic and private-public partnership.

# **SCAM ALERTS**

#### The Grandparent Scam

The phone rings and the person on the line claims to be your grandchild who's been arrested for DUI or has been in an accident in Canada. Your grandchild pleads with you not to tell his/her parents and to wire him/her



\$2500 immediately. Before you hang up, the caller gives specific instructions about where to go with the money, where to wire the money and to which account.



The caller is not your grandchild but a scam artist. There have been several cases like this reported in Lake Forest.

#### The Jury Scam

Someone posing as a deputy calls your house and informs you that you missed your call to federal jury duty and will be arrested. The caller says that to avoid arrest, you need to pay a fine. You are then instructed to go to a local chain store and obtain a \$500 "green dot" money order, call a specified phone number and provide information on the money order. The caller conducting the scam attempts to make it credible by giving a deputy's name and phone number for "confirmation."



None of these activities are part of the federal court system's protocol, and the public should not provide personal information over the phone EVER.

# AS THE SEASONS CHANGE

Daylight Savings Time: Sunday, November 2

Remember to turn your clocks back one hour before you go to bed on Saturday night. It is also a good time to change the batteries in your smoke detectors and carbon monoxide detectors.

#### **Have Your Appliances Checked Regularly**

Ask a qualified appliance technician to check all fuelburning appliances, furnaces, venting and chimney systems at least once a year, or as recommended by the manufacturer.

#### **Fireplaces**

Make sure you have a screen large enought to catch flying sparks and rolling logs. Chimneys should be thoroughly cleaned once a year or more often if it is heavily used. Remember, soot and creosote buildup in the chimney is what causes flue fires. As part of this cleaning process, the flue should be carefully inspected inside and out for damage and obstructions. Store cooled ashes in a tightly-sealed metal container. Only burn materials appropriate for a fireplace and never burn trash or paper. Burning paper can float up the chimney, onto your roof and into your yard.

# Dispose of Unwanted Medication at the Lake Forest Police Station, 255 W. Deerpath.

In conjunction with other members of the Lake County Underage Drinking and Drug Prevention Task Force, the Lake Forest Police Department installed a drop box in the lobby of the building. Available 24/7, 365 days a year, it is easy to help keep kids and the Lake Forest environment safe.

Homes are the #1 source for teenage abuse of prescription drugs. Flushing unused medications into the sanitary system or disposing of them in the garbage pollutes the environment.

The DEA has collected more than 2.5 million pounds of prescription drugs that were removed from circulation, and the Lake Forest bin typically collects 139 pounds in a 6-month period. The Drop Box provides a safe, convenient, and responsible means of disposal, while bringing awareness to residents about the potential for abuse of these medications.
