## Mayor's Message



The summer season in Lake

outside. I am extremely proud of how well the City staff was able to address the harsh winter, and want to especially thank the Streets and Sanitation Section for its efficient plowing and salting. Our roads were safe and clear and our residents, as well as those visiting, were able to get around with minimal disruption. We are currently assessing weather-related damage to our roads, and given the results, the City Council has made additional funds available for patching and repaving roads this year.

We are also fortunate to have a vibrant and active business community. Plans continue to move forward on the new Northwestern Lake Forest Hospital with a targeted ground breaking scheduled for this fall. Our community "Business Accelerator" is full of new small businesses growing here in our City and adding local residents and college students to their staffs. And our Conway Office Park is full of national and international companies that are proud to call Lake Forest home.

Recent City Council Action (see the City's News on the website for complete details and Frequently Asked Questions)

- A Consolidated 911 Emergency Dispatching Program with Highland Park and Lake Bluff was approved. A concept studied since 2012, the consolidation will save The City of Lake Forest \$1.6 million over five years. The agreement is currently pending approval by the other communities in the consortium.

For the first time in Lake Forest's history, three women now serve on the City Council, and were sworn in by the Mayor at the "Changing of the Guard" meeting on May 5.

### SAFE BIKING TIPS

It's bicycle season! For information about the Bicycle Master Plan, please visit the City's website. Just like drivers, cyclists should follow the Rules of the Road and be aware of their surroundings.

- Be Predictable. Cyclists should stay as far right as possible and ride as far right as possible and in a manner that allows cars to safely pass. On narrow roads, cyclists traveling in groups may have to ride single file and never more than two abreast. Obey traffic signals and controls, use hand signals to indicate movement on the road. Be courteous and cautious when riding.
- The Roads serve as a Bike Path. Did you know that the safest place for an adult cyclist is on the road along with the flow of vehicular traffic? In fact, cyclists are prohibited from riding on the sidewalks in the Central Business District. The mix of pedestrians and cyclists presents a hazard to both.
- Bicycle Improvement Project. With grant funding, this project will begin this summer and includes a new bike path along the west side of McKinley Road which will shift traffic out of the commuter parking lots at the East Side Train Station. Please check the City's website for project updates.



### **CELEBRATING 75 YEARS**

May 2014 marked the 75th Anniversary of Council-Manager Government in Lake Forest, Illinois.

In 1939, Lake Forest adopted the "Council-Manager" governance model that had previously been implemented by its North Shore neighbors to the south. Because the City Council is comprised of eight Volunteer Aldermen (two from each of four wards) and a Volunteer Mayor, this form of local government has served overwhelmingly well, abiding by the philanthropic culture which thrives in the town. The Mayor is elected every two years for a two-year term and Aldermen are elected to staggered two-year terms with one Aldermen elected from each ward annually. Public service prevails, and in one form or another, volunteerism is evident and encouraged in each Lake Forest household.

Prior to the Council-Manager governance, the City was administered by the Business Manager, who had no real experience beyond budgeting and accounting. Today, the typical and preferred background and education for the beginning municipal manager is a Master's Degree in Public Administration (MPA) and at least several years of experience as a department head in local government or as an Assistant City Manager. More than 60% of those in the profession had a MPA, MBA, or other related higher-level degree.

The Lake Forest City Council serves as the legislative and policy making body of the City. The City Manager's responsibilities are to oversee the day-to-day operations of the City, including enforcement of ordinances, recommendations of policy and policy alternatives to the City Council and the preparation of an annual budget for the Council's review. To date, Lake Forest has been served by a total of eight City Managers, who have worked with 29 Mayors and City Councils (almost 200 volunteers), including James King (1933-1944), John McNicol (1944-1949), Neil Campbell (1949-1955), William Douglas (1955-1964), Paul Reaume (1964-1972), Gerald Hagman (1972-1979), John Fischbach (1979-1990) and Robert R. Kiely, Jr. (1990-present).

The City of Lake Forest received LEED Gold Certification recognition for its 2009 Municipal Services Building, a National Gold Medal Award for Parks and Recreation Management, and is awarded an annual Certificate of Achievement for Excellence in Financial Reporting by the Government Finance Officers Association. Today, the City maintains a Aaa bond rating, and property taxes in Lake Forest are the lowest in the area. Through the collective efforts of the City Council-Manager governance, generous residents and a conscientious staff, the City's long history of prudent, financially conservative and proactive fiscal practices will maintain Lake Forest as one of the country's premier communities.

Mr. Kiely comments on his 24-year tenure experience: "The Council-Manager form of government has served the Lake Forest community extremely well for the past 75 years. The combination of very committed, civic-minded volunteers serving on policy-making Boards and Commissions and a talented, highly professional and responsive workforce creates an extremely effective government entity. The quality and character of our community is not the result of luck or good fortune, but rather the outcome of a vibrant caucus system and strong, business-like approach to delivering high-quality services."

#### **Summer Hours at the Center**

Operating hours: Saturdays from 8 a.m.-5 p.m. and Sundays from 9 a.m.-5 p.m. Please display a current Lake Forest vehicle sticker or resident beach permit on the vehicle's windshield. Driver's licenses cannot be accepted as proof of residency. No commercial contractor use of the facility is allowed. Residents may drop off yard waste, unwanted household items, metal cans, glass, plastics (#1-7), newspapers, magazines, corrugated cardboard and office paper for recycling. Unacceptable: appliances with CFCs, asbestos, batteries, paints/chemicals, tires and food waste.

## TIPS FOR SUCCESSFUL GARAGE SALES

- Obtaining a permit is easy.
   Applications are available on the website (select "I Want To" and "Apply For") and at the Municipal Services Building, 800 N. Field Drive. There is no fee.
- You will receive a placard, which should be posted on your property during the sale.
- No Parking signs will be provided with your permit. Please place them along the street as directed.
- One Garage Sale is permitted per residential property per calendar year. The sale may run from 9 a.m.-5 p.m. for two consecutive days, any days of the week.
- Items for sale from "for profit" businesses may not be sold at residential Garage Sales.
- Please remove the No Parking signs after the sale is over.

### STORM WATER NEWS

One of the
North Shore
Sanitary District's greatest
challenges in
providing quality wastewater
treatment services is the "I/I"
- the inflow
and infiltration
of storm water



#### into the sanitary sewer system.

Unlike some other agencies which treat both wastewater and storm water, the NSSD's responsibilities are to treat sewage and protect Lake Michigan and other area waterways. Local municipalities and organizations, such as East Skokie Drainage District, handle storm water. Inflow is when clear water, usually rainfall, from illegal connections of sump pumps, downspouts, and foundation drains is channeled directly into sanitary sewer pipes. **Infiltration** is when groundwater seeps into sewer pipes via cracks and leaky joints. Because the sanitary sewer system was not designed to manage this excess clear water, it becomes overloaded during times of high groundwater or heavy rainfall. Once the sanitary sewer system reaches capacity, water may back up and potentially flood basements. As a result, I/I can reduce a sanitary sewer's ability to transport wastewater to the treatment facility. It is estimated that this problem costs agencies like the NSSD (and their customers) millions of dollars a year annually for needless treatment of storm water runoff. On average, the District treats about 50 million gallons of wastewater per day, but during high flow incidents, such as heavy rain storms, the volume can increase fivefold. The NSSD has undertaken several projects in recent years, including constructing excess flow storage basins and rehabilitating its interceptor sewers, in an effort to alleviate the effects of I/I. If you suspect your downspout, sump pump, or foundation drain might be connected to the sanitary sewer or that your sewer lateral connection is faulty, the NSSD urges you to have your system checked. ## "Sprinkler-Free Mondays"



Please do your part in helping to reduce water usage by adhering to the City's new "Sprinkler Free Mondays" where sprinkling is no longer permitted on Mondays. This new regulation applies to both automated irrigation systems and manual sprinklers. If you own an automated irrigation system, it can be easily programmed.

Days and Hours for Even-Numbered Addresses (i.e. 808 Smith Street): Tuesdays, Thursdays and Saturdays: midnight-10 a.m. and 8 p.m.-midnight

Days and Hours for Odd-Numbered Addresses (i.e. 809 Smith Street): Wednesdays, Fridays and Sundays: midnight-10 a.m. and 8 p.m.-midnight

As in years past, watering restrictions take place from May 15-September 15 on an annual basis, and sprinkling is not allowed between 10 a.m. and 8 p.m. because water put on lawns and gardens during those hours quickly evaporates with the afternoon sun. Additionally, night-time irrigation during the summer months drains the City's water reserves, and the Water Plant needs time during the following day to build up those reserves. Newly-installed lawns and landscaping may be watered before 10 a.m. and after 8 p.m. daily for a reasonable period after installation.

## B-BOX INSPECTION AND INVENTORY PROGRAM

Beginning in May and taking place throughout the summer, the City will be taking inventory and uncovering all the B-Boxes (or "Buffalo Boxes") which are located outside at all Lake Forest residences. B-Boxes are usually located in the parkway lawn, but may have been covered up at some point by new driveway construction or new landscaping.

The B-Box is the valve used to shut off water service to a house from the water main when emergency repairs need to be made. The City employee, who will be carrying City of Lake Forest identification, will locate the B-Box and photograph it so it can be entered in to the GIS system. The process should take no more than 10 minutes per property.

## WATER BILL INSERTS NOTIFICATION

Beginning May 1, all resident water bills will contain inserts with the City Manager Message on p. 7, an information sheet about Refuse Fee implementation and a new Water Rate structure.

The new Refuse Fee is \$8 per month per household, or \$96 per year. The \$24 charge will appear on your quarterly water bill, and labeled "Refuse Collection."

A new Water Rate Structure includes an increase of \$10 per quarter for most residents.

## IMPORTANT BUDGET MESSAGE FROM THE CITY MANAGER

By all accounts, the City of Lake Forest is considered a very good, if not great municipal organization. We hold a "Aaa" bond rating, have a strong balance sheet and provide quality public service in a highly desirable community. We have traditionally engaged in long-term financial forecasting. In mid-2000, the City Council and City acknowledged that economic realities and demographic shifts within the community would alter the provision of City services. The real challenge as articulated in the Strategic Plan ("Properly align services to available resources and make adjustments to meet residents' expectations") is to identify opportunities to control our costs while striving to not diminish the residents' quality of life. Every effort was made to get out ahead of the inevitable changes and recalibrate ourselves proactively rather than reactively. We comprehensively examined our core business lines and matched available resources to identified priorities, traditions and values of the community.

Lake Forest vs. The State of Illinois: The State's financial shortcomings would not be so egregious if it did not result in significant impacts on local governments. The State of Illinois frequently imposes unfunded mandates on local communities, most notably being pension sweeteners – that we have no choice but to pay. More recently, State legislators have focused their attention on local government revenues as a means for closing the projected revenue shortfall. The City currently receives approximately \$2.3 million in income tax and motor fuel tax revenues. And while this represents only 2.7% of the City's total revenue in Fiscal Year 2015, it will prompt an increase in other taxes or cuts to existing services should these revenues be reduced or eliminated.

In December of 2013, the City Council adopted changes to various fees and charges resulting in an increase (\$675,768) in General Fund revenues, attributable to a new Refuse Collection Fee (\$620,000), which the City Council has subsequently elected to direct to the Capital Improvements Fund in Fiscal Year 2015 rather than to the General Fund. Additionally, in February of 2014, the City Council adopted revisions to the water rate structure with the goals of:


- Incentivizing residents to reduce water consumption during peak demand periods
- Raising additional revenue to meet increased capital needs of the water system identified in the 5-year Capital Improvement Program
- Establishing the appropriate portion of the utility's costs that should be covered by the fixed (vs. variable) component of the water rates

Additional adjustments may be made in future years so that the optimum balance between fixed and variable revenue components can be achieved over time. With potential collateral damage resulting from the State's budgetary failures, the Lake Forest City Council must continue to rationally allocate available resources to achieve the greatest common good. We will continue to seek outside funding, promote new thinking, new relationships and structures, and more realistic expectations in our delivery of services.

## A CLOSER LOOK... **AMERICAN LEGION POST 264** AND LAKE FOREST DAY

One of the fixtures of our community sits on the corner of Wisconsin Avenue and McKinley Road. The George Alexander McKinlock, Jr. Post 264 of the American Legion was chartered on October 28, 1919, and was moved to its current location in 1934. Although the Post has had several lamily locations around town, the current building used to stand approximately where the fountain in Market Square is located.

moved it across the tracks to its current location at 801 N. McKinley Road. It was then remodeled by architects Anderson and Tichnor and formally dedicated on May 26, 1935.

The American Legion has devoted itself to service to country and to our comeducation munity, and their many gifts to life in Lake Forest include sponsoring and planting memorial trees on Deerpath, helping by funding local Boy Scouts and Girl Scouts, the Lake Forest High School Band, annual college scholarships and planning and funding Memorial Day and Veterans Day ceremonies.

However, their most significant annual contribution is Lake Forest Day, which is being celebrated this year on the evening of tradition

Tuesday, August 5 and all day on Wednesday, August 6. Why, you may ask, is this community event held in the middle of the week? The tradition is traced back to Lake Forest's early days when local businesses and banks were closed on Wednesdays to reduce their employees' work weeks from 6 to 5 days since they operated on Saturdays as well. Basi-

cally, on Wednesdays, all local merchants had the day off! As the Lake Forest Day Carnival grew to be more popular, the Legion decided to open it up on Tuesday evenings as well.

This year, Lake Forest High School student Sean Fleming, as his Eagle Scout project, has set up new Facebook page for the Legion. In addition to the traditional favorites, the festivities will include new bands playing at the Carnival in the Beer Garden and a Silent Auction featuring some great prizes.

## SEASONAL TIPS FROM PUBLIC SAFETY

Tornados are nature's most violent storms and can devastate an area in seconds. A tornado appears as an ominous rotating funnel-shaped cloud, striking the ground with whirling winds of up to 200 mph. A tornado spins like a top and may sound like an airplane or train. Most tornados only travel a distance of about ten miles, although some have been reported to travel more than 200 miles.

- Wherever you are, if you hear or see a tornado coming, take cover right away.
- If you're in a house or apartment building, go
  to the basement. If there is none, go to the
  middle section of the building on the lowest
  level and seek shelter in a bathroom or closet.
  Always stay away from windows.
- Get underneath something sturdy, such as a heavy table, and stay there until danger has passed. Use your arms and hands to protect your head from falling or flying objects.
- If you're outside, in a car or mobile home, seek shelter in the basement of a nearby sturdy building. If there is no building nearby, lie flat in a ditch or low spot. Highway underpasses are very dangerous and should be avoided. Use your arms and hands to protect your head.
- **Tornado Watch:** Weather conditions are right for tornados to develop. A watch does not necessarily mean a tornado will develop.
- **Tornado Warning:** A tornado has been sighted and is dangerous. Go to a safe place and listen to a battery-operated radio for instructions.

In Lake Forest, if a tornado warning is issued by the National Weather Service, tornado sirens will be sounded by a large outside speaker system around the community, followed by an announcement. If you hear these sirens, get inside and turn on your television or radio for a detailed weather report.


