# Mayor's Message



As we approach the wonderful winter season in Lake Forest, we are reminded of the many things for which we are blessed. One of the most popular events is the kick-off to our Holiday Season, the annual Tree Lighting Ceremony in Market Square.

This annual tradition, which will be held on Friday, November 28, is a favorite event of residents, their families and former residents alike, and is probably one of the most beloved events in Lake Forest. It is a wonderful time to see neighbors, meet new friends, reconnect with old friends, and to enjoy the spirit of the season. Activities include ice sculpting, a visit from Santa Claus, refreshments and caroling with the Lake Forest High School Choristers.

During this season of giving, I also encourage residents to shop locally first, in our two business districts, as well as in the stores and services along North Western Avenue. All provide an abundant selection of high quality goods and services and friendly merchants who are eager to help make your holidays enjoyable.

Philanthropic generosity and volunteer organizations are the lifeblood of Lake Forest. Our residents work hard to support the City's efforts in preserving its natural beauty, patronizing local institutions, endorsing cultural arts, promoting civic pride and maintaining our standards of excellence. Giving to the community is one of Lake Forest's oldest traditions.

In 1927, 70 acres of land were donated by A. B. Dick and other residents with the restriction that *Deerpath Golf Course* would be used "for park purposes only and that no trap shooting would occur there. If it ever were to cease to function as a park or a public benefit, it should revert to the donors of the property."

In 1931, the two daughters of John G. Shedd, Mrs. Charles H. Schweppe and Mrs. Kersey Coates Reed (later Mrs. Stanley Keith), donated \$250,000 for a fully equipped *Lake Forest Library* building. Prior to that time, the library was located on the second floor of City Hall, the current City Council Chamber. Mrs. Keith's son, John Shedd Reed, also contributed to the 1977 Library expansion project.

John "Archie" Stevenson made the first land donation to *Lake Forest Open Lands Association* in 1974. Formed in 1967 for the purpose of acquiring undeveloped land through tax-free gifts and bequests, Open Lands currently has over 800 acres of land under management, including 6 nature preserves, and continues to purchase undeveloped land for conservation.

*Lake Forest High School* was built in 1935 on property purchased by residents and donated to the City. It was a project of the Works Progress Administration (WPA) and designed by local architect Stanley Anderson to blend in with the surrounding estates.

Northwestern *Lake Forest Hospital* opened its doors in 1942 on 24 acres of land donated by the A. B. Dick family, which also raised the private funds to build it (621 contributions totaling \$800,000).

**Ragdale**, the residence designed by renowned architect Howard Van Doren Shaw for his family and later the home of his sculptor daughter Sylvia Haskins, was developed into a non-profit artists' community by Shaw's granddaughter, Alice Hayes, in 1978. Ragdale and its property were given to The City of Lake Forest, and the land and buildings have been leased to the Ragdale Foundation on a long-term basis.

The *deer sculpture* in Triangle Park originally stood at the 1870-built D. J. Lake private home located at 644 East Deerpath and was then donated to the City by a subsequent owner. Lake was the only Lake Forest Association trustee, the secretary beginning in 1856, to build and live here.

The Lake Forest *Cemetery Gates* were given to the City in 1919 by Mrs. Finley Barrell to commemorate her young daughter, who drowned in the Illinois River in 1916.

With the extensive rehabilitation that Market Square has undergone over the last few months, it remains the "historic, iconic and inspired" destination for which it was planned. Market Square was designed and constructed in 1912-16, by the Lake Forest Improvement Trust, a private real estate organization. The Trust was made up of estate owners and local developer John Griffith, and was formed to create a new City Beautiful Movement town center. The fountain at its east end is dedicated to its architect, Howard Van Doren Shaw, and the flag pole at the Square's west end is a memorial to local veterans of World War I. When completed in 1916, Market Square cost \$750,000. Residents Robert Meers and John Coleman purchased Market Square from the Trustees in 1983 and donated the property's landscape to the City as a park. The Lake Forest Garden Club took the leadership role organizing Market Square 2000, the not-for-profit entity that partnered with the City for renovations and raised \$1.5 million for infrastructure and landscaping improvements.

This list is a very small representation of the philanthropic philosophy and history in Lake Forest. The City is preparing for reduced road salting this winter in an effort to conserve resources and protect the environment. With proper application and appropriate timing, less salt is needed. The Public Works Department uses specialized weather forecasts to receive real-time readings of pavement temperatures and precipitation, and will be modifying salting procedures based upon that information.

Beginning January 16, only main streets as well as intersections, hills, and curves of side streets will continue to be salted. The same areas will be salted less beginning February 16.

Families with new and younger drivers should emphasize the importance of exercising caution when traveling on snow-packed streets.

At its October 6 meeting, the City Council rejected the State bid and authorized salt purchases through a sole vendor. When combined with reduced salt application, the City will save over \$100,000.

According to recent transportation studies, road salt was determined to be the most cost-effective and environmentally acceptable alternative. However, the City will continue to look at technological and environmental trends as they develop.

Additionally, based upon a survey issued to residents last winter, the Public Works Committee recommended a modified course of action for sidewalk snow plowing. To more effectively address the 103.75 miles of sidewalks, snow blowers will be used on sidewalks within 1/4 mile of schools and all sidewalks along the main streets, and snow plows will be used for the remaining. All sidewalks will be either blown or plowed after 2" or more of snowfall.

# Look, Listen & Live

STEPPING UP Train Safety

Lake Forest has the second highest pedestrian railroad fatality rate per capita in the Chicago metropolitan area. Resident Norman Carlson, Lake County's representative on the Metra Board of Directors, is leading efforts to change that statistic and to promote railroad safety along with the City through Engineering, Education and Enforcement. The City is promoting the mission of "Operation Lifesaver", a program

supported by a wide variety of federal, state and local government agencies, highway safety organizations, law enforcement, the nation's railroads and their suppliers. Operation Lifesaver's certified volunteer speakers give free rail safety presentations to people of all professions and age groups, and state coordinators are located in 49 states and the District of Columbia.

During a recent City Council meeting, Mr. Carlson emphasized the importance of *simply reminding residents to be careful around railroads.* "People should expect a train at any time on any track in any direction," he commented. "Even though, at the East Side Train Station, southbound trains normally travel on the east track and at the Telegraph Road Train Station, southbound trains normally travel on the west track, that situation can change, unbeknownst to the public." Other dangerous factors include:

- 1. Device Distractions: I-Pods and earbuds, cell phones.
- 2. People misjudging the speed of trains. Because trains are so large they give the impression they are moving slower than they actually are.
- 3. People mistakenly making the assumption that they can beat the train by crossing the tracks ahead of it.

Not all trains stop at Lake Forest train stations. The City has been working with local legislators, Metra, IDOT, and other affiliated agencies to institute an Amtrak stop at the Telegraph Road train station. Currently, several Amtrak trains travel through Lake Forest at high speeds without stopping. An Amtrak stop would add a safety benefit as well as a commuter benefit with service provided to and from Milwaukee and Chicago. The City has also received a \$2 million grant to construct a pedestrian underpass at that station and is diligently pursuing the capital needed for the project. An underpass would also help mitigate traffic congestion at the Telegraph/Everett Road intersection and enhance safety for the public and commuters. Preliminary engineering for the underpass is complete as funding is sought for this important endeavor in Lake Forest.



# TRAIN SAFETY TIPS

## Look Both Ways

Always expect a train from either direction. After a train passes, look both ways before proceeding.

## Don't Get Stuck on the Track

Before you cross in your car, be sure there is room on the other side to completely clear the tracks and do not shift gears while crossing the tracks. Trains overhang the tracks by at least 3 feet on each side.

## Get Out, Get Away

If your vehicle stalls at a crossing, get everyone out and far away immediately, even if you do not see a train. Call the emergency notification number posted on or near the crossing.

## If You See a Train Coming, Wait

Don't be tempted to beat a train. An approaching train may be closer and traveling faster than it appears.

## Trains Cannot Stop Quickly

The average freight train travelling 55 miles per hour takes a mile or more to stop. That's 18 football fields. If the locomotive engineer can see you, it's too late to stop the train.

# Watch for Vehicles that Must Stop at Railroad Crossings

Most states require school buses, commercial buses and trucks carrying hazardous materials to stop at every highway-rail grade crossing (state laws vary).

DO YOU Really Know L.E.A.D.?

For the past 27 years, LEAD has worked with CROYA and the Lake Forest and Lake Bluff Police Departments to reduce underage drinking and substance abuse among youth.

LEAD, a Lake Forest based 501(c)(3) non profit organization, offers programming and educational seminars on topics including drug and alcohol prevention, prescription drug abuse, medical marijuana legislation, e-cigarettes and more. LEAD brings in well-known speakers, authors, and researchers, and develops programming that gives parents fresh ideas on raising kids, negotiating the teen/parent relationship and maneuvering through social media. In addition to parent programming, LEAD also works with middle school and high school youth to offer safe and healthy community activities, educational programming and a 24-hour community text hotline.

## **CHOICES MATTER CAMPAIGN**

By now you may have noticed new community messages around town calling your attention to reflect on choices that matter to the health of youth in the community. The campaign is meant to call attention to the influences and effects adults in Lake Forest and Lake Bluff have on youth. Adults often feel that they have no influence over youth, especially as they become teenagers. However, teenagers consistently report in both local and national surveys that their decisions are strongly influenced by the adults in their lives.

Community schools, in conjunction with LEAD and the SpeakUP! Coalition, have conducted the Illinois Youth Survey every two years since in 2006. The data from these surveys provides Lake Forest and Lake Bluff the opportunity to work together to make changes that will improve the quality of life and wellbeing of our youth. To that end, LEAD encourages all community members to:

1. Talk to your kids! Having clear and regular conversations with your kids about alcohol and drugs is a significant protective factor and will reduce the likelihood that they will get involved with these substances. Not sure how to get started? Visit www.choicesmatter.com for helpful hints and resources.

2. Discuss the Choices Matter Campaign. When you see one of the messages from the Choices Matter campaign (online, in print, in local retailers), consider talking about it with your kids. You'd be surprised how valuable a simple conversation in the car or during dinner can turn out to be.

3. Complete the Community Beliefs and Attitudes Survey created by the Speak UP! Prevention Coalition. Community youth are not only impacted by their parents, families and friends but also by other community members. Please complete the survey whether or not you have school age children. *The survey is available on the LEAD website at www.leadingefforts.org/communitysurvey.* This survey will be conducted every few months to measure the effectiveness of the Choices Matter campaign. Your ongoing participation in this survey is strongly encouraged in the hopes that a measurable change can be created in the community's attitudes about underage drinking and substance abuse, thereby positively affecting the choices made by local teens.

4. Please utilize the prescription drug disposal box located in the lobby of the Lake Forest Public Safety Building at 255 W. Deerpath to dispose of your unused or expired prescription drugs. Properly disposing of your expired, unused, or unneeded prescription and over-the-counter medication will keep them out of the hands of your kids or any other kids that come into your home. # **NEW POLICE FOUNDATION**

The Lake Forest Police Foundation was recently formed as a 501(c)(3) organization to support the important work of the Lake Forest Police Department through the donation of funds, services, and equipment.

The role of the Foundation is not to supplant funding for basic law enforcement services, nor to reduce the responsibility of the City of Lake Forest in any way to commit the necessary funding for law enforcement services for its citizens. According to Police Commander Robert Copeland (Executive Director of the Foundation), "Programs like the women's self-defense class, the Citizens Police Academy, the annual senior picnic, the bike safety rodeo and other community events had to be cut back due to budgetary considerations. A lot of these programs are not necessary to our basic day-to-day operations, but they are programs that we love to do, getting the police officers more involved in the community."

This past June, the first meeting of the Lake Forest Police Foundation was held. The five-member, volunteer board came together with one objective: raising funds so the LFPD can develop and enhance its community programming, update vital equipment, continue specialty training and develop officer wellness programs.

Since then, the board has raised enough funds to purchase new automated external defibrillators for all the squad cars, the public safety building and City Hall. The board has also raised funds to restart the women's self-defense class, re-purpose an unused area in the police station into a dedicated defensive tactics room for classes and training, and funded the Citizens Police Academy alumni picnic. Current board members include residents Terry Rozdolsky, Jay McAveeney, Paul Burt, Steven Esposito and Rick Price, and the Foundation has raised \$80,000 since June of this year.

Future funding plans include police trauma kits, executive level training for supervisors, holding an annual Police Awards and Recognition Dinner for department employees, updating police officer recruitment abilities and enhancing employee development and training.

The final phase of work is underway at your park, Forest Park, and will open with a mile of new pathways for all to enjoy, accommodating walkers, runners, strollers and wheel chairs through late fall and the winter months. During snowfall, the Ring Road will be cleared for pedestrian use but will remain closed to vehicle traffic until the final layer of asphalt is laid. Amenities such as lighting, benches, drinking fountains and bike racks will be installed next spring, along with some trees and shrubs that require spring season planting. The Ring Road will receive its final asphalt layer after the amenities are complete.

Visitors are able to wander in all directions to enjoy the wonderful lake vistas from the meandering path at the north end of the park to the bluff walk, or along the new path on Lake Road to the new woodland path, and the path above Seminary Ravine south of the parking area. All improvements will be complete by Memorial Day and a dedication will take place in June.

As a tribute to the community support, a donor board will be placed within the park and list contributors of \$1,000 or more. The Forest Park Project Board's goal is to have as many Lake Forest families and businesses as possible join in supporting the mission and recognized in perpetuity on the donor board for their gift of good stewardship and a vitally enhanced historic park for generations to follow. 
- Monday and Tuesday collections will remain the same.

# **REFUSE, RECYCLING &** COMPOST CENTER

## Winter Operating Hours

Beginning December 1, the Compost/Recycling Center (located on the south side of Rte. 60 west of Waukegan Road) will be open on Saturdays only from 8 a.m.-3 p.m.

Residents may drop off yard waste, unwanted household items, metal cans, glass, plastics (#1-7), newspapers, magazines, corrugated cardboard and office paper for recycling. Unacceptable items include appliances with CFCs, asbestos, batteries, paints/ chemicals, tires and food waste.

To use the Center, please display either a current Lake Forest vehicle sticker or a Lake Forest resident beach pass. Driver's licenses will not be accepted as proof of residency. No commercial contractor use of the facility is allowed.

Beginning December 1, yard waste collections will reduce to once weekly and will be collected on the same day as your recycling.

## **Christmas Tree Recycling**

During January, Christmas trees and wreaths will be picked up on regularly-scheduled recycling days at the curb. Please remove all lights and ornaments and do not put trees or wreaths in plastic bags. Trees should be cut into six-foot lengths.

## **Holiday Waste**

During and after the holidays, please flatten cardboard boxes and bag all loose wrapping paper and packing materials to keep them from littering the neighborhood.

Family Service: Prevention, Education & Counseling, NFP in Highland Park, provides counseling services for youth and families through the GROW (Guidance, Resources, Outreach & Wellness) program, which offers a limited amount of fee-free services for need-based clients.

The CROYA Student Union is a multi-purpose facility capable of adapting to the ever-changing youth trends and youth-driven ideas. CROYA has something for everyone! Students are encouraged to explore everything CROYA has to offer. Come check out the recording studio, main-stage, DJ booth, multiple lounges, student store, and dance studio, to name a few.
