#### DECLARATION OF DISASTER EMERGENCY FOR THE COUNTY OF CLARION, FENNS LIVANIA

WIBREAS, a novel coronavirus, known as COVID-19, (hereinafter "COVID-19"), emerged in Wuban, China, and begun infecting humans in December of 2019, and

WHTREAS, COVID-19 has spread to multiple countries, including the United States of America, and

WHEREAS, states throughout the United States have been affected, including the Committowalth of Pennsylvania, and WHEREAS, the World Health Organization has declared COVID 19 to be a pundemic;

WHEREAS, on Murch 6, 2020, the Governor of Permylvinsia insued a Freedomation of Disaster Emergency, which aemong other things authorized the responsion of certain procedures and formalities prescribed by law and separ

WHEREAS, on March 13, 2020, the President of the United States declared a Nation

WHEREAS, as of July 15, 2020, there are multiple confirmed und/or presumed positive use of COVID-19 in the United States, including presumed positive cases in the Commonweald Person busing and

WHEREAS, on March 13, 2020, the Governor of Pennsylvania issued as order closing all K-12 schools in the Commonwealth of Pennsylvania until the end of the academic school year;

WHEREAS, this summer, several Clarion County Communities have cancelled or scale back class to held events and festivals that may empression have authorizers, and

WHEREAS, the ongoing impact of COVID-19 has the potential to endanger or threat the health, safety, and welfare of a substantial number of persons residing in Carlon County, as threatens to create problems greater in scope than Clarion County may be able to resolve; and



WHEREAS, emergency management measures are required to be proactive to reduce the potential severity of this disaster and to protect the health, safety, and welfare of the affected residents to Carlon Courie; and

WHERFAS, Section 7501(b) of the Pennsylvania Emergency Management Services Code, 35 PaCSA. § 7501, authorizes the County to declare a disaster emergency "upon the finding a disaster has occurred or is imminent."

NOW, THEREFORE, the Board of Commissioners of the County of Clarico, Pennsylvania, declare that:

 The estimate of a disaster emergency in Clarion County is declared persuant to the provisions of Section 7501 of the Pennsylvania Emergency Management Code (15 Pa.CSA, §7501 et seq.), as amended, due to COVID-19 terrolling a public health emergency.

2. De Clarion County Department of Public Softry emergency management coordinate is derected to coordinate the activities of the emergency response, to work with state and foderal authorities, to take all appropriate aution needed to alleviane the control effects of this disaster, to add in the restantation of essential public services, the energy of the control of the disaster, and the control of the control of the emergency.

3. A Leadership Committee, consisting of the Board of Commissioners, the Commissioners Child's of Staff, the Director of Public Kafery, the EMA Coordinator, the Director of Human Services, the Court Administrator, The Shrift, The Markon, the Director of Hudornation Technology, the County Schichies, and say additional numbers and deemed recognition by the Board of Commissioners, its ferred to address the COVID-19 statution, with the Director of Public Safety and the County Schichies serving as one-hairs.

4. The Leadership Committee shall meet as needed in response to COVID 19 without the need to formally advertise times and places of meetings due to the exigent circumstances. However, as time permits, every effort will be made to list the times and places of much meetings in advance on the County website.



5. The formal requirements of time-consuming procedures and formalists frescribed by law (excepting mandatory constitutional requirements) pertaints to performance of public works, entering into contrast, the incurring of obligations, entering into contrast, the incurring of obligations, unpelloyment of formpoursey workers, the reachest of supplies and materials, the levying of taxes and the appropriation and expenditure of publi finds are temperatury supervised in light of the exigencies of the situation.

 This Declaration or any related order, proclamation or statement shall be given prompt and general publicity and shall be filed promptly with the Ponny Ivania intergency Management Agency.

 This Declaration shall take effect immediately and proceed until Septemb 15°, 2020.
