RESOLUTION No. 17 of 2022

**RESOLUTION OF THE BOARD OF COMMISSIONERS
DESIGNATING THE REDEVELOPMENT AUTHORITY OF THE
COUNTY OF CLARION AS THE ELIGIBLE APPLICANT THROUGH THE
PENNSYLVANIA DEPARTMENT OF COMMUNITY AND ECONOMIC
DEVELOPMENT WHOLE-HOME REPAIRS PROGRAM**

WHEREAS, Pursuant to Section 3002(1) of the act of July 8, 2022 (Act No. 1A of 2022), known as the General Appropriation Act of 2022, the General Assembly of the Commonwealth appropriated federal funds from the COVID-19 Response Restricted Account to the Department of Community and Economic Development, hereinafter referred to as "DCED", for the COVID Relief – ARPA – Whole-Home Repairs Program, hereinafter referred to as the "Program"; and

WHEREAS, Pursuant to Section 135-C of the act of July 11, 2022 (Act No. 54 of 2022), known as the Fiscal Code, the DCED has established guidelines for the Program; and

WHEREAS, the guidelines established by DCED indicate that the Program will provide funding for county-wide agencies to address habitability and safety concerns, provide measures to improve energy or water efficiency and make units accessible for individuals with disabilities; and

WHEREAS, the guidelines further indicate that the County may designate a governmental entity, such as a municipal authority, as the eligible applicant for the Program; and

WHEREAS, the Redevelopment Authority of the County of Clarion, Pennsylvania, hereinafter referred to as the "Redevelopment Authority", is a public body corporate and politic, created by the Pennsylvania Urban Redevelopment Law (P.L. 991, 1945) as an Instrumentality of the Commonwealth; and

WHEREAS, the Redevelopment Authority currently administers a housing rehabilitation program throughout the County and has established local guidelines in order to facilitate the local process for administration and implementation of the Clarion County Whole-HOME Repairs Program.


NOW, THEREFORE, BE IT RESOLVED, by the Board of Commissioners of the County of Clarion:

1. That the Redevelopment Authority of the County of Clarion, Pennsylvania is hereby designated as the sole eligible applicant on behalf of the County for the Pennsylvania Department of Community and Economic Development Whole-Home Repairs Program.


2. That the County further expresses full support for the Program Application which will be submitted by the Redevelopment Authority to the Pennsylvania Department of Community and Economic Development (DCED).


