RESOLUTION NO. 4 OF 2024

RESOLUTION OF THE CLARION COUNTY BOARD OF COMMISSIONERS AUTHORIZING THE USE OF COUNTY FUNDS AS MATCH AND INTERIM/BRIDGE FINANCING FOR A PREVIOUSLY AWARDED REDEVELOPMENT ASSISTANCE CAPITAL PROGRAM GRANT FROM THE GOVERNOR'S OFFICE OF THE BUDGET

WHEREAS, the Clarion County Commissioners were notified on November 18, 2022 that it had been awarded Nine Hundred Thousand Dollars (\$900,000) in Redevelopment Assistance Capital Program (RACP) funding from the Governor's Office of the Budget for the Clarion County Courthouse Renovations Project (ME# 3518-00); and

WHEREAS, the Office of the Budget has requested that Clarion County provide confirmation of its ability and intent to provide matching funds for the project; and


WHEREAS, the Clarion County Courthouse Renovations Project has been identified as a priority capital improvement project in the 2023 and 2024 county budgets.

NOW THEREFORE, it is recognized that Clarion County allocates up to Nine Hundred Thousand Dollars (\$900,000) in cash to match the awarded RACP grant and agrees to provide Nine Hundred Thousand Dollars from the General Fund to serve as interim/bridge financing for the RACP award.

I, Mindy L. Frampton, duly qualified Chief Clerk of the County, hereby certify that the foregoing is a true and correct copy of a Resolution duly adopted by a majority vote of the Clarion County Board of Commissioners at a regular meeting held March 12, 2024 and said Resolution has been recorded in the Minutes of the Clarion County Board of Commissioners and remains in effect as of this date.
