

COUNTY OF CLARION
RESOLUTION NO. 15 OF 2012

WHEREAS, the Clarion County Stormwater Management Plan (Stormwater Management Plan) was completed in accordance with a grant agreement between the County of Clarion and the Commonwealth of Pennsylvania known as, Department of Environmental Protection Grant Program Agreement No. 4100048883;

WHEREAS, pursuant to the recommendation of the Clarion County Planning Commission, dated May 19, 2011, the Stormwater Management Plan was approved and adopted by the Clarion County Commissioners; and,

WHEREAS, on or about June 9, 2011, Pennsylvania Department of Environmental Protection received copies of the Stormwater Management Plan; and,

WHEREAS, on June 17, 2011, Clarion County provided additional information to the Department of Environmental Protection regarding the Stormwater Management Plan; and,

WHEREAS, by correspondence dated September 7, 2011, the Pennsylvania Department of Environmental Protection informed Clarion County that pursuant to Section 5 the Stormwater Management Act, 32, P.S. §680.5 the Department of Environmental Protection was unable to commence its formal review of the Stormwater Management Plan as it remained incomplete and did not meet the mandatory requirements of the Stormwater Management Act; and,


WHEREAS, Clarion County has completed an Amended Stormwater Management Plan, in compliance with 32 P.S. §680.5 for review and approval of the Department of Environmental Protection.

NOW THEREFORE, BE IT RESOLVED, by the Board of Commissioners of the County of Clarion, a 6th class county under the laws of the Commonwealth of Pennsylvania, as follows:


1. The Amended Clarion County Stormwater Management Plan attached hereto as Exhibit A and incorporated herein by reference, is hereby approved and adopted.
2. The Board of Commissioners, for and on behalf of the County of Clarion, is hereby authorized to execute this Resolution.
3. The Chief Clerk of the County of Clarion is hereby directed to attest the execution of the Amended Storm Water Management Plan and to affix the Seal of the County of Clarion thereto.
4. Following proper execution, the Chief Clerk of the County of Clarion is hereby direct to enter this Resolution in the Minutes of the Clarion County Commissioners dated August 28, 2012.
5. The Chief Clerk of the County of Clarion is hereby authorized and directed to forward a fully executed copy of the within Resolution and the attached Amended Stormwater Management Plan to the Pennsylvania Department of Environmental Protection for formal review pursuant to the Storm Water Management Act.


