#### General Rules

- 1. No Smoking in or within 25 feet of Clarion County vehicles
- 2. No eating or drinking, unless approved due to medical reason
- 3. No littering in or from the vehicle
- 4. Be courteous to other riders
- 5. Seatbelts must be worn in all vehicles
- 6. Inform the driver if you need assistance to and from the curb
- 7. All children aged 16 and under must be accompanied by an adult age 18 or older
- 8. Illegal activities, verbal abuse, or physical abuse will not be tolerated. These actions may lead to immediate dismissal from the vehicle. This behavior will also be reported to the referring agency, which may revoke authorization for transportation services.
- **9.** No weapons are allowed on any transport provided by CATA.

#### ARE YOU AGE 65 OR OLDER?

Clarion County Transportation offers Clarion County residents aged 65 or older curb-to-curb transportation at a cost discounted by 85% thanks to Pennsylvania Lottery proceeds. Additional funding may be available through Medical Assistance, Clarion Area Agency on Aging, or Clarion County Veterans Affairs.

No income information is required.

#### CAN SOMEONE GO WITH ME?

An escort may accompany anyone on a trip without cost when independent travel is not possible due to age, disability, language barrier, or when the escort is verified necessary for the recipient to secure medical examinations and treatment. Notify us when scheduling if an escort is necessary.

Note: Our escort policy applies.

### How Is Transportation Provided?

Clarion County Transportation provides curb-to-curb services, which means you are expected to get to the curb to be picked up.

Services are 'shared ride,' meaning you will usually be riding with other passengers. Depending on where you need to go, we will provide your rides using vans, buses, or accessible vehicles for persons with disabilities.

Rides must be scheduled at least one day in advance for destinations within the county and two days in advance for destinations in surrounding counties within the service area.

When you schedule, we will give you a half-hour pickup window. Please be ready to go and watch for your ride during this time. The driver will wait a maximum of five (5) minutes. Call us if you'll be late so we can notify the driver.



# How Do I Apply For Services?

Complete an application, available at the office listed below, or call us and we will record the required information for you. You will need to sign the application and provide an acceptable proof of age before you can start scheduling rides.

You can also apply online as www.apply.FindMyRide.penndot.pa.gov

To receive sponsorship for the 15% copay, provide a valid Medical Assistance (MA) identification number on your application or proof of Veteran's status (choose the relevant proof of age document on the application). If desired, we will file on your behalf and inform you if you are accepted for sponsorship by Clarion Area Agency on Aging.

Note: MA will sponsor medical trips only.
