Cobb County Tax Commissioner's Office Under Limited Operations

Marietta, GA – All Cobb County Tax Commissioner's Offices remain closed to the public until further notice. Our managers and staff are divided into rotating teams to address calls, emails and social media communications as well as to ensure the processing all mail, IVR, web and drop box items. Many tax and tag transactions can be conducted online, at kiosks, by utilizing drop boxes or by mail.
