The Corcoran City Council meeting dates and procedures are set by Title 1, Chapter 5 of the City's Municipal Code. Section 3 covers the meeting schedule which is currently established for holding regular meetings every second and fourth Tuesday of the month at 5:30 pm. Section 4 establishes the Procedural Rules and allows the Council to set rules for the conduct of meetings. The published Council Meeting Agenda defines the individual public comment to be limited to five (5) minutes.

The City Council may consider changes to these Council Meeting provisions. Any change should be considered with the goal of providing good governance to the community, and whether the change would maintain or enhance meeting efficiency, transparency, and accountability to the public.

Cities throughout Kings and Tulare Counties all maintain two Council meetings a month. There are some Cities in California that hold only one meeting a month like the City of Palmdale. Public comment time across most jurisdictions is typically set for either five or three minutes.
