SCOPE OF WORK.

The Project includes, without limitation, furnishing all necessary labor, materials, equipment, and other incidental and appurtenant Work necessary to satisfactorily complete the Project, as more specifically described in the Contract Documents. This Work will be performed in strict conformance with the Contract Documents, permits from regulatory agencies with jurisdiction, and applicable regulations. The quantity of Work to be performed and materials to be furnished are approximations only, being given as a basis for the comparison of Bids. Actual quantities of Work to be performed may vary at the discretion of the City Engineer. The work may consist of but is not limited to: the supply & installation of a new stainless steel clarifier mechanism, drive, and control panel. Blast and coat the clarifier walls and launders.

GENERAL WORK DESCRIPTION

As part of the City's maintenance program, the City's 40' circular primary clarifier has been identified as needing rehabilitation. This clarifier is 40' diameter, with 10' side water depth and a total volume of 12,566 cubic feet. The process design flow is 1.0 MGD with a 2.26 hour detention time. The following items have been specifically identified to be rehabilitated or replaced: one steel column, one walkway with platform, walking surfaces grating, handrailing, one feed well ring and supports, one steel cage, two steel rake arms w/rake blades, two skimmer supports, squeegees, scum box with supports, scum box piping to wall flange, control panel & clarifier wall coating.
