- 1. Call to Order The Meeting was called to order at 9:33AM by Joseph Wubbena.
- 2. Public Comments None.
- 3. Approval of Minutes

The Fire Board approved the September 8, 2022 quarterly meeting minutes as presented, upon motion by John Evenhouse and second by Bob Cabot; motion carried 4-0.

The Police Board approved the September 8, 2022, quarterly meeting minutes as presented, upon motion by Robert Tungate and second by William Rowe; motion carried 4-0.

4. New Business

- a. Actual expenses as of September 30, 2022
 - i. Ferrell Jenne reviewed the requirement and each expenditure type.

The Fire Board approved the actual expenses as of September 30, 2022 as presented, upon motion by Bob Cabot and second by John Evenhouse; motion carried 4-0.

The Police Board approved the actual expenses as of September 30, 2022 as presented, upon motion by Kelly Curtis-Stout and second by William Rowe; motion carried 4-0.

- 6. Reports (Attorney/Consultants)
 - a. AndCo Consulting, Brad Hess, Investment Consultant

i. Quarterly report as of September 30, 2022

1. Brad Hess stated 2022 was the worst calendar year index returns since 1976. Brad stated you would have to go back over 50 years to find a period that had such a poor bond market.

2. Brad Hess stated the plans were fully exposed to the market, as private real estate was added late in the year. Brad discussed the market volatility signs

of a recession.

3. The Market Value of Assets (MVA) as of September 30, 2022 was \$10,535,493 for the Police plan and \$5,325,514 for the Fire plan.

- 4. For the Police plan, total fund net returns for the quarter were -4.14%. Total fund trailing net returns for the 1-, 3-, 5- and 10-year periods were -18.26%, 0.91%, 2.60% and 4.96%, respectively. Since inception (March 1996), total fund net returns were 5.84%.
- 5. For the Fire plan, total fund net returns for the quarter were -4.43%. Total fund trailing net returns for the 1-, 3-, 5- and 10-year periods were -18.25%, 1.50%, 3.15% and 5.13%, respectively. Since inception (March 1996), total fund net returns were 5.86%.
- 6. Brad Hess reviewed the current asset allocations and stated everything was in line with the Investment Policy Statement. Brad stated international equities was slightly underweight, but this was a tactical decision.
- 7. Brad Hess reviewed Principal and stated capital had not yet been called and this would not happen prior to the end of the year. Brad stated private real estate lagged the public market and he expected the first quarter of 2023 to be a negative return for private real estate.
- 8. Brad Hess reviewed the financial reconciliation for the quarter and the manager changes that had taken place during the fiscal year.
- 9. Brad Hess stated currently fiscal year-to-date, both plans were up 9-10%.

b. Christiansen & Dehner, Scott Christiansen, Board Attorney

i. Update on proposed Ordinance (POLICE)

 Scott Christiansen stated the vacant city appointed trustee seat on the fire board is still vacant and they are waiting on contact info for the new police trustee, Glenda Lester. Robert Tungate stated he was attending the upcoming City Commission meeting and would ask the Commissioners about getting her contact info.

2. Scott Christiansen reminded Ferrell Jenne to send the city the September

30th quarterly reports.

3. Scott Christiansen stated the proposed Ordinance to add in the PLOP option to the police plan was going for first reading on December 13, 2022 and second reading on January 10, 2023.
