General Event Information: Country Christmas Stroll

Vendor Responsibilities:

Vendors are responsible for their own tents, tables, lights, and electric cords. If electricity is needed, vendors are required to provide their own quiet generator for power and inform the City a generator will be present. Only pre-approved generators certified for less than 70 decibels will be permitted. Food vendors will not have access to water at the event, you must supply your own.

Tents must be tented down with weights. No staking into grass or ground surfaces.

Tear-down is immediately following the event and must be completed in one hour. All vendors are responsible for their own trash removal.

All transactions with customers are the responsibility of the vendor. Vendors must have their own change funds. The collection and remittance of Florida sales tax is the responsibility of each vendor. Sales tax questions should be directed to the Florida Department of Revenue.

Vehicles of any type are not part of the vendor space and are not permitted inside any event, including during vendor set up and tear down. Food trucks will be permitted, food trailers will need to be set up without a truck attached.

Vendors may only sell from the vendor booth, no strolling to sell will be permitted.

Exclusivity will not be granted to any vendor or category; product duplicity should be expected at most events. Placement and duplicity are at the discretion of the City and in the best interest of the event.

General Information:

All City events are rain or shine. All event locations are outdoors with possible uneven terrain and inclement weather. Please prepare accordingly. No refunds will be given for inclement weather.

Food vendor instructions will be sent out 3 business days prior to the event's start.

The City of Dade City, the sponsoring organizations, or any other duly appointed representatives and employees are not responsible for the loss or damages of any kind arising out of or in connection with the Country Christmas Stroll.
