Uncollectible Material: Refuse which is not acceptable at the East Pasco Recycling Center, and must be disposed of in a Class III, C&D site, or hazardous waste site. Examples include: trees, or tree limbs exceeding six inches in diameter, sleep couch (unless all metal is removed), concrete, brick, tires, large automotive parts including car seats, bed springs and air conditioners.



RECYCLING

Every Wednesday, Central Carting collects containers that contain the following recycled materials:

- Plastic containers, code #1 PET or #2
 HDPE (rinsed and crushed, without caps & lids)
- Metal food cans (rinsed-labels removed)
- Aluminum cans (rinsed)

Do not include the following items which can contaminate material collected: aerosol cans, batteries, oil/paint cans, glass bottles, hazardous chemicals, ceramics, crystal, light bulbs, mirrors, pyrex, window glass, metal caps, aluminum foil, egg cartons, pie pans, unmarked plastics, or numbers other than 1 and 2.

Please set out your bins only when they are full.



Household Guide

GARBAGE COLLECTION



Collection days:

East of 14th Street - Monday and Thursday West of 14th Street - Tuesday and Friday Lynan area - Wednesday and Saturday

Garbage receptacle containers should be made of plastic or metal, and not greater than 35-gallon capacity with a tight fitting cover suitable to protect the contents from flies, insects, rats and other animals. The receptacle shall be fitted with two handles or a lid by which it may be lifted. Contents shall not exceed 50 pounds.

Grass clippings and leaves must be bagged, boxed, or placed in cans for collection along with normal household waste.

Shrubbery cuttings and tree limbs should be cut into lengths not to exceed four feet or have a diameter exceeding six inches. They should be neatly stacked next to the trash can. Newspapers and magazines may be bound and piled and shall not weigh more than 50 lbs.

Special Waste:

Stove, refrigerator, washer, dryer, water heater, automobile tires. Call Central Carting (583-4204) to arrange for a special pick up. The customer will pay an additional fee for removal.

What is Household Hazardous Waste?

When leftover paint, used oil, pool chemicals and other products containing hazardous materials are no longer wanted, they become "Household Hazardous Waste," or "HHW." It is illegal to dispose of HHW in the garbage, down drains, or onto the ground, as it may threaten human health or the environment. Illegally disposed hazardous waste can release chemicals into the environment and contaminate our air, water, and even the food we eat.


