Public Safety Facility & Storage Building Bond Proposal

On the May 2 ballot, Delta Township will ask voters to consider a bond proposal for the construction of a new public safety facility and storage building for the residents of Delta Township and the nearly 40 personnel (Lieutenants, Sergeants, Detectives, Deputies, and support staff) that serve them on the Delta Patrol.





How Would This Affect Taxpayers?

If the bond proposal passes, the average residential property owner in Delta Township can expect to pay an estimated \$112.18 in additional taxes per year based on an average home market value of \$200,000 and a taxable value of \$100,000.

2023 Eaton County Local Road Millage Projects

This year marks year 9 of 12 for the ECRC local road millage program. The County has submitted the list of roads to be completed in Delta Township in 2023. While these roadways are managed and maintained by the Eaton County Road Commission (ECRC), Delta Township works closely with the ECRC to coordinate and minimize impact on residents and businesses during maintenance and construction projects.

Additionally, Delta Township funds the position of a dedicated weighmaster through the Eaton County Sheriff Department, who patrols our roadways enforcing weight limits and frost laws from trucks traveling throughout the Township. This is one critical function for helping prevent road damage.

Ribbon Cutting Held for Waverly East Pool Facility Renovation

Waverly Community Schools has completed construction on new locker rooms and pool upgrades for the Delta Township Community pool at Waverly East Intermediate School. A Ribbon Cutting ceremony was held on March 20 in celebration of the newly remodeled facility.

The project was paid for through the Waverly School bond millages approved by voters in May 2021. The newly renovated facility is a resource for all community members. Delta Township is extremely grateful for the opportunity to partner with Waverly Schools on this project.

Facility improvements include a total facelift of the locker room area with floor to ceiling retiling and the addition of large spacious single showers with attached changing rooms. The pool area has been equipped with new lights, paint, and an overall fresh appeal to the space.





The Waverly East Intermediate School pool facility is used by the public for swim lessons, aerobic classes, open





swimming, and is available for private event rentals through the Delta Township's Aquatics Program.

Delta Township Honored as a Four-Star Community by U of M Dearborn iLabs eCities Project

Delta Township has been recognized as a Four-Star Community for its successes and efforts in contributing to Michigan's entrepreneurial growth and economic development, in the annual eCities study conducted by researchers at iLabs, University of Michigan-Dearborn's Center for Innovation Research.

The eCities study analyzed publicly available data from 277 communities from 54 counties in Michigan. Researchers focused on the five-year changes in property values, community assets, and tax rates, which can demonstrate the growth, investments, and cost of doing business within the community.

Although accounting for less than 20% of the State's cities and townships, the 277 communities analyzed are home to 71% of the state's population, have 86% of the state's real commercial property and 64% of the state's total property value. Over the five-year period from 2017-2021, these communities increased their capital assets



by an average of 3.4% per year by investments that include infrastructure improvements and community focused facilities such as libraries and community centers.

The study analyzes data from the Department of Treasury and each governmental units audited financial statements to calculate five-year trends. For Delta Township, the trend showed:

- A 4.72% increase in overall property value which includes residential, commercial and industrial development in the Township
- A 3.99% increase in governmental assets, which reflects Delta's commitment to investing in its infrastructure
- The Township held steady on non-homestead tax rate

Township Approves New Firefighter's Contract



Recently, the Delta Township Board approved a new six-year collective bargaining agreement with the local 2846 firefighters union, who unanimously ratified the contract.

The contract highlights include reduced work hours, kelly days, provisions for maternity and paid leave for birth or adoption of a child, paramedic bonuses, tuition for paramedic school, and very competitive wage increases throughout the life of the contract.

This agreement makes Delta Township a destination for Firefighter/
Paramedics and Firefighter/EMT-Bs while continuing a strong commitment to extraordinary public safety services to Delta Township residents.

Delta Installs AEDs in Several Parks

Delta Township has purchased five **Automated External Defibrillators** (AEDs) for several parks facilities. These life-saving devices have been placed at Sharp park, Delta Mills park, Mt Hope park, Ericson park, and Grand Woods park inside a locked, weather proof, key coded box at the rest rooms with in the parks. To access the AEDs you must call 911 and advise the dispatcher of your location and they will provide you with a key code to access the AED and will dispatch police, fire, and EMS to the scene of the emergency. This ensures quick and timely access to a life saving device in addition to an expedient response from emergency responders. The locations of the AEDs were chosen due to the size and number of visitors to each park.

While we hope the need to use this equipment never arises, it is a great peace of mind knowing that they are close and available.


Where Do My Taxes Go?

The pie chart below represents the taxes that Delta Township collects on behalf of all Taxing Authorities. In 2022, Delta Township was responsible for collecting approximately \$79,866,296 in property taxes and special assessments. Delta Township only retains approximately \$11,996,509 or 15% of the funds collected for General Operating, Paramedic and Library purposes. This number also includes funds retained by the Corridor Improvement Authority and Brownfield Redevelopment Authority. The pie chart illustrates where your tax dollars go.

2022 Taxing Authority Tax Dollar Distribution






6 Tips to Avoid Flooding in Your Home
