# New Utility Rates Go into Effect in 2021


Delta Township is proud to provide reliable water and sewer services to its residents and business owners. Water and wastewater services are funded through the revenue collected from your water and sewer bill. No tax revenue is used to provide water and wastewater services so the Township must align water and sewer rates with the cost to deliver these services. Costs include (1) the cost to supply water and treat wastewater, (2) compliance with regulations governing the distribution of drinking water and treatment of wastewater, (3) the repair, replacement, and update of the Township's aging wastewater treatment plant, and (4) ongoing maintenance of critical infrastructure. Like any asset, regular maintenance is critical to maintain and operate water and sewer infrastructure.

It is a best practice to periodically conduct a rate study to ensure that rates are fair, equitable, and tied to the demand customers place on the water and wastewater systems. In 2020, Delta Township contracted with the independent consulting firm Baker Tilly Municipal Advisors, LLC, to prepare the Delta Township Water and Sewer Fund - Rate Study. The results of this rate study for both the water and wastewater systems are outlined below.

#### Sewers:

In the upcoming years, the Township is planning to invest nearly \$78 million in maintenance and upgrades to the wastewater treatment plant. The rate study determined that the Township requires additional revenue to support the future debt service payments on these major capital improvements to the Delta Township Wastewater Treatment Plant.

A ready-to-serve charge for wastewater has been implemented at \$2.50 per typical residential meter per month. Additionally, a 7.25% increase in the wastewater charge per cubic foot of water used has been implemented. A typical residential customer with a 5/8" meter, using 1,000 cubic feet of water, would see their bill increase from

\$34.38 to \$39.40 per month in 2021 (Approximately \$4.99/month). *Please note 1,000 cubic feet is an estimate.* 

### Water:

On the water side, the ready-to-serve charge (formerly called the "customer charge") for the typical homeowner has been lowered from \$12.40 to \$10.00. Additionally, a 1.25% increase in water rates has been implemented. The average monthly residential water bill based on 1,000 cubic feet is expected to decrease from \$36.70 to \$34.60 despite the 1.25% rate increase due to the reduction in the ready-to-serve (\$-2.40/month). Please note, 1,000 cubic feet is simply an estimate.

The net impact of the changes in the ready-to-serve charge and utility rates for water and sewer customers will vary based upon actual water consumption and meter size. Despite these increases, Delta Township water and wastewater rates remain competitive in the greater Lansing region.

### GM to Invest \$100 Million at Delta Plant



On October 20, General Motors announced that it will be investing \$100 million into its Lansing/Delta Township plant to produce the next generation of the GMC Acadia. The investment is part of a \$2 billion investment in GM plants across the country. The plant currently builds the Chevrolet Traverse and Buick Enclave.

# I-496 & Waverly Road Projects Wrap-Up

On November 11, the Michigan Department of Transportation reopened I-496 to traffic in both directions after a nearly year-long reconstruction project.

The project, which was the first in Governor Whitmer's Rebuilding Michigan Plan, began in early spring 2020 with an investment of approximately \$60 million to improve I-496 between I-96 and Lansing Road. The work included reconstructing the freeway and ramps, preventive maintenance on all the bridges in the project area and making operational improvements to the entrance and exit ramps at the I-96, Creyts Road, and Waverly Road

interchanges.



In addition to the freeway reconstruction, Waverly Road, between St. Joe Highway and Lansing Road was completely reconstructed. Improvements included the addition of a non-motorized, shared-use pathway with a pedestrian crossing enhancement for crossings of Waverly Road, railroad tracks, Lansing Road and Old Lansing Road. The pathway portion of the project was completely grant funded through a combination of federal and local grants and Ingham County Parks and Trails Millage.

Multi-agency collaboration aided in improving the Waverly Road freeway interchange to I-496, replacement of the railroad

crossing, and the building of the pedestrian pathway, which enhances the walkability between Delta and Lansing Townships.

# **Creyts Road Project Funding In Delta Restored**

State Representative Angela Witwer wrote a letter to the Michigan Department of Transportation (MDOT) that requested funding for a road improvement project in Eaton County be restored. MDOT announced Friday, December 11, it has officially agreed to the representative's request.

The reinstatement of this funding (\$191,673) will include widening Creyts Road to accommodate a center turn lane from approximately 360 feet south of Auto-Owner's south campus driveway to the Eastbound I-496 ramps. The grant includes \$74,540 in matching funds from Eaton County Road Commission and \$53,242 in matching funds from Auto-Owners.

Previously, the MDOT Office of Economic Development denied the county road grants due to the economic shortage caused by COVID-19.

The project is set to begin in the upcoming fiscal year.



## **2021 Road Projects Update**

The Eaton County Road Commission (ECRC) local road millage program is entering its seventh year of projects in 2021. The millage was approved for 12 years to address local roads throughout the county. Delta Township had roughly 110 miles of local roads in poor or fair condition prior to the passage of the millage; of that total, approximately 8 miles was gravel.

In order to receive the budget award, Delta Township had to satisfy nation-

ally recognized guidelines for effective budget presentation. These guidelines are designed to assess how well an entity's budget serves as a policy document, a financial plan, an operations guide, and a communications device.

The Township's Budget document must be rated "proficient" in all four categories, and in the fourteen mandatory criteria within those categories, to receive the award.





# **Tax Collection in Delta**

The pie-chart to the right represents the taxes that Delta Township collects on behalf of all Taxing Authorities. In the 2020 tax year, Delta Township is responsible for collecting approximately \$70,973,969 in property taxes. Delta Township only retains approximately \$10,841,848 or 15% of the funds collected for General Operating, Paramedic, and Library purposes. The pie-chart illustrates a breakdown of where all your tax dollars go.



# Convenient Online Options for Delta Residents & Businesses

The Delta Township Accounting/Treasurer's Office offers the ability for residents and business owners to access services and make payments remotely. The availability of online\* services became even more vital during the pandemic due to concerns about in person transactions.

Below is a listing of the available opportunities for contactless service requests and bill payment which can be accessed at https://www.deltami. gov/departments/accounting/.

### Water/Sewer Bills

Online services are available to:

- Make a payment on your bill using a credit card or e-check.
- Turn on or turn off service for those moving in or out of the Township.

- o When a resident informs the Township that they are moving out of a property the water is shut off until the new owner sets up an account.
- Automatically pay your bill each month through direct withdrawal from a checking or savings account.
- Sign up for paperless e-billing.
- · View your water/sewer history.

### Property Taxes

Online services are available to:

- View your tax/property assessment information.
- Pay your bill using a credit card or e-check (fees apply).
- Pay your bill automatically through direct withdrawal from a checking or savings account.

 This form must be completed for each tax year. The winter tax payment can be scheduled for withdrawal in December or February.

# **Evaluation for Township Facilities is Underway**







In 2020, the Township completed its Phase 1 Baseline Facilities Assessment of all the Township Buildings. The study, completed by C2AE and Christman, identified approximately \$16 million in capital investments needed for Township facilities over the next 10 years. The Township will continue to analyze these findings and discuss future planning for investments into facilities and future building replacement. The study covered the Delta Township Sheriff Substation, Township administration building, Drolett Community Center, Enrichment Center, Firestations 1 and 3, and the Parks maintenance building.
