We need to just agree to disagree and we cannot pick and chose which amendments we abide by.

Tina Pirlot addressed the Board; she spoke of the acceptance of people that are different. She appreciates that the Board approved the library levy.

Doug Stock Kingsford addressed the Board, he questioned the expiration date of the canvass board. He wanted to note he doesn't understand why people won't take their hats off at public meetings. Danielle Kraimer addressed the Board. She stated this library has taught her so many amazing things. She thanked the Board for approving their full levy.

Cindy Harrington Iron Mountain addressed the Board. She didn't think anyone is trying to censor people, they are talking about taxpayers paying for something that goes against their values. Jeff Gurchinoff addressed the Board. His conservative values don't align with all. This group has never tried to ban a book, only to put them in the appropriate section.

James Larson addressed the Board. He stated he is disappointed the Board does not have an invocation at the meetings.

Jeff Edwards addressed the Board. He stated as a parent he is responsible for his children. He does not want them to have access to any material that is not for kids.

Angela Hall addressed the Board. She stated that no book was asked to be banned only moved. A very graphic novel was housed right next to her 4th grade daughter's favorite book. Its not about a specific group, it is about keeping pornography out of our kid's hands.

Carl Weber addressed the Board. He stated in 2018 this Board was presented with a sanctuary county resolution and did nothing with it.
