**NOTED :**

--**COURT**-- can only act based on reports from Sheriff Dept., i.e., only on facts; not rumors—Questions to answer today, i.e., declare disaster for 7 days ? how to implement and under what perimeters? being that most mandates are unfunded. Sheriff Dept. needs to provide this court with information; opening of the Detention Camps was not a decision of the county or of this court.

**COUNTY ATTORNEY**-- [sic] immigration is coming through Mexico; not from Mexico—issue is not lack of manpower in Sheriff Dept.; currently has 34 officers—**FOR THE RECORD**: no contact about opening any camp was made to the county or this court.

**Peter Perez III**—here today only as concerned citizen adding [sic] "We" 1) toured the Detention Facility, a/k/a BFS February 22 which is at maximum capacity, 2) know there is a problem inside there, 3) need to stop all the illegal
