**2.2 PUBLIC HEARING, contd.,**

[RE:--County Judge **Francisco G. Ponce** duly opened the Public Hearing to address concerns, questions related to the proposed County Budget for fiscal year : October 1, 2018 to September 30, 2019

1) **Sonia G. Perez**-JP Pct. 1, RE:--here to address the proposed cut in staff on claim that workload has decreased and to request the court to consider retaining staff on regular work schedules at both JP 1 and JP 2 Offices, i.e., not transfer them to also work at the County Auditor’s Office. Perez presented Activity Reports (as a work Audit) and narrated numbers for total revenue collected and retained for the county from 10/01/2016 thru 09/21/2018 and reiterated a consensus at the Budget Workshop to keep her 2-clerks. Currently has 2-full time clerks—JP’s have started Traffic Court Docket

2) **Alberto Esquivel**-JP 2, RE:--can assure court that workload has not decreased (civil cases, credit card, evictions, scan DPS tickets ); his staff maintains professionalism always; would be a mistake to cut staff

3) **Francisco G. Ponce**-County Judge, RE:--w/payments processed “on line”, i.e, not manually , is affirmative that there is a major decrease in workload; all tickets go into the system, not manually; only 2 Truancy cases this year at a cost of \$7000-

4) **Daniel Gonzalez**-County Attorney, RE:--has not received Truancy Cases to hear or approve; School District not following procedure—cases end up dismissed

5) **Debra Darter**-CS Resident, RE: --can reassure the court that JP 1, JP 2 have best public relations, honest, loyal—addressed a question to court : are initial numbers in the budget discussed beforehand and how determined (?) **Court** : they are projected numbers, followed by Hearing(s) and Commissioners are involved

6) **Ana V. Diaz**—CS Resident, RE:--request for court to allow JP Staff Members to speak on the matter at-hand [ consensus of court members agreed to “waive” any repercussions from Executive Session rule and allow JP Staff members to address the budget concerns ]

7) **Samantha Diaz**-JP 1 Chief Deputy Clerk, RE:--when applying for employment she specified to work in JP 1 Office, no other Office—and can justify that their offices also take influx from the public, i.e, those whom prefer to conduct business in person and not by phone
