#### What is CDBG?

The Community Development Block Grant (CDBG) Entitlement Program provides annual grants on a formula basis to entitled cities and counties to develop viable urban communities by providing decent housing, a suitable living environment, and by expanding economic opportunities, principally for low- and moderate-income persons.



#### What is OCR's CDBG?

- The Office of Homes and Community Renewal (OCR)
  received an allocation from PY2020 CDBG CARES Act
  Funds from the Program of the U.S. Department of
  Housing and Urban Development (HUD)
- The City submitted an application to OCR, and was awarded funds, for PY2020 CDBG CARES Act Funds to install broadband WIFI hotspots and solar cellular device charging stations at Point Gratiot, Dunkirk Pier, and Wright Parks

- Timeliness in Spending!



# Project Accomplishments

- Completed installation of broadband repeaters and equipment for WIFI hotspots at Point Gratiot Park and Wright Park.
- 12,156 City residents will now be assisted and have access to free broadband internet in these public parks and waterfront areas
- 6 new Solar Charging Stations installed at Point Gratiot Park, Dunkirk Pier/Boardwalk and Wright Park.
  - (2) Point Gratiot
  - (1) Dunkirk Pier
  - (1) Dunkirk Boardwalk
  - (2) Wright Park
- City residents are now able to charge their cellular devices, tablets and laptops utilizing these charging station located in accessible pubic locations.



# PY 2020 Accomplishments

- 2020 OCR Total Project Awards = \$103,500.00
  - Project covered
    - Purchase & Installation of WIFI Repeaters & Equipment
    - Purchase & Installation of Solar Charging Station
    - Purchase of Service Maintenance for 5 years
- Actual Total cost of the project= \$104,147.11
- City residents now have free public access to the internet for the purpose of accessing remote school, work, and benefit applications. By installing the additional access at Point Gratiot and Wright Park, residents can socially distance and still connect while also having the ability to charge their devices while using the WIFI.
