Permit Conditions

Only one (1) stand will be allowed per issued permit; Vendor is to set-up only in the area specifically designated by the Festivals/Special Events Coordinator.

Please contact the Dunkirk Festivals Department for event set up times. If event is cancelled by the city, refunds will be mailed.

Vendor is responsible for clean-up, including removal of all debris, no later than 10:00 a.m. on the day following the event unless otherwise determined by event.

Vendor is entitled to a pre-determined, reserved location measuring twelve feet (12') frontage. Set-ups requiring greater than twelve feet (12') frontage will require application for additional space(s). Individual food trucks may require more room per spot.

Vendor is solely responsible for the means and manner of all such activities contemplated hereunder and shall be solely responsible to ensure compliance with each and every applicable rule, regulation, law and/or requirement. The city makes no warranties, either express or implied, with regards to the goods and/or services sold by the vendor.

Vendor must comply with each and every rule, regulation, law and requirement imposed by any appropriate federal, state and local authority, including but not specifically limited to the NYS and County of Chautauqua Departments of Health. All statutory provisions applicable hereto are hereby incorporated by reference. Vendors preparing food items on site will need a Food Service Permit. If needed, please contact the Chautauqua County Health Department at (716) 753-4481 for details.

Vendor shall provide to the City before set-up appropriate proof of general comprehensive liability insurance naming the Dunkirk Local Development Corporation and City of Dunkirk as an additional insured, in an amount no less than \$1,000,000.00 (Vendor Classification E of the City of Dunkirk Standard Insurance Certificate).

Vendor shall, in addition to the other requirements hereunder, indemnify and insure the City against any and all claims, costs and damages arising out of the performance or non-performance of activities contemplated hereunder.

Approval of this application in no way confers any permanent legal right, title or interest in or to any property; approval and use by the Vendor of any such property does not and shall never ripen into or become a right to own or to use any portion of the premises in a manner inconsistent with the terms herein. Upon approval, the Vendor shall have a non-exclusive, revocable right to use the premises solely upon the terms and conditions contained herein.

RELEASE AND WAIVER: In consideration of accepting to participate as a vendor of the City of Dunkirk, I, the undersigned, intend to be legally bound for myself, my employees, our heirs, successors, and assigns, and to waive and release any and all claims against the City of Dunkirk and Festivals/Special Events Department and to hold them, their heirs, successors, and assigns, harmless during my participation as a vendor/merchant at the aforementioned event. By executing this application, the undersigned acknowledges that he has reviewed and understands the terms herein; the undersigned agrees to comply with each and every term, condition and obligation contained herein if awarded a Permit.
