- New York State bona fide farmers, please submit copy of NYS Dept of Ag & Market's FMNP Farmer Crop Plan.

**Compliance and Indemnity Agreement:**

This application does not guarantee your acceptance to the Dunkirk Farmers Market and in addition reserves the right to prohibit anyone from selling at the Market.
