To Our Council Members:

When E.C.I.A. Business Growth, Inc. was established, the goal was to stimulate the economy of our five-county region by making loans to new or established businesses. The primary purpose of these loans is the creation of jobs for our area citizens.

From inception in 1983 through June 30, 2019, the Board of Directors has approved 351 loans. This includes 192 SBA 503/504 loans totaling \$83,490,523 and 161 RLF loans totaling \$24,347,978 for a grand total of \$107,838,501. 4,135 jobs have been created and 1,260 have been retained. These loan projects have also produced a significant amount of new property tax revenue for our local governments and school districts.

Our lending in FY 2019 was up from FY 2018 for ECIA Business Growth, Inc. The Board and Jackson & Dubuque Counties approved these loans in FY 2019:

In total, 10 new loans or \$3,933,943 in new lending. RLF lending was \$651,620.00, down \$198,380 from last year SBA 504 lending was \$3,282,323, up \$2,588,323.

Long term interest rates for the 504 program have continued to be competitive. The following loans were closed by staff and funded in FY 2018:

The amount of funded loans totaled

\$1,310,250 a decrease of \$507,750 from FY 2018.

Our existing loan portfolio was stable in FY 2019: No loans went into default. Three loan prepaid early, representing \$358,182 in outstanding loan dollars. To date, three RLF and one city loan have been written off, twelve 503/504 loans transferred to the SBA, 36 cancelled (not funded), and 167 have been repaid in full. Of the remaining 86 active loans, none are in catch up, and none are on deferred payments. 78 are current with their loan payments and 8 are being closed and funded or under construction.

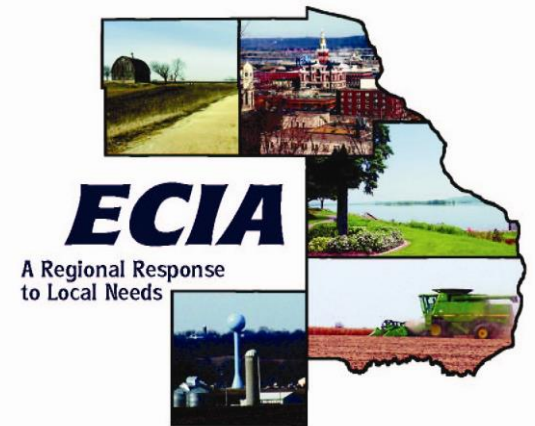

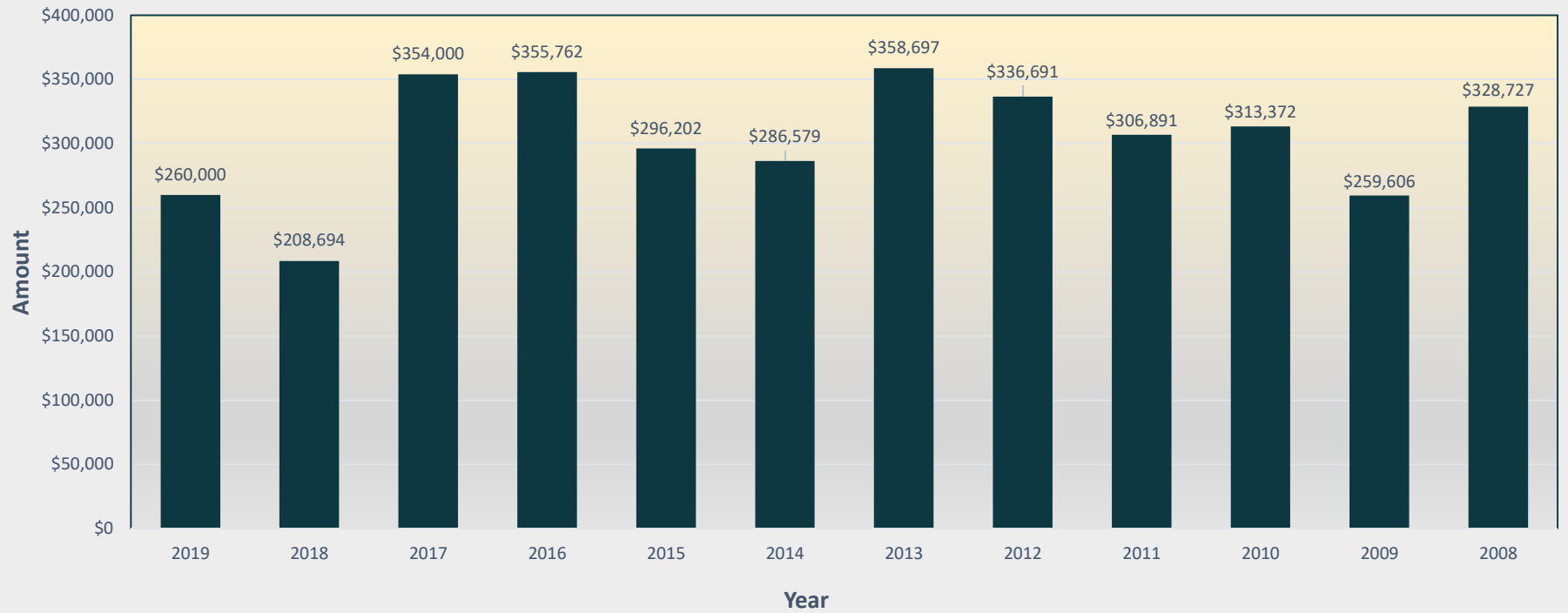
