**NOTICE TO CONTRACTORS AND INSTRUCTION TO BIDDERS**

NOTICE IS HEREBY GIVEN by the Village of East Dundee that sealed proposals will be received for roadway construction consisting of hot-mix asphalt (HMA) placement, pavement grinding, removal and construction of combination concrete curb and gutter, removal and construction of concrete sidewalk, storm sewer construction, topsoil, seeding, pavement patching and other appurtenant work.

**Time and Place of Opening Bids:** Said sealed proposals will be received until 9:00 a.m., on Monday, August 22, 2022, at the office of the Village Clerk, 120 Barrington Avenue, East Dundee, Illinois, at which time all Bids will be publicly opened and read aloud.

**Instruction to Bidders:** Complete sets of Contract Documents, including Plans and Specifications are on file for inspection at the office of Gerald L. Heinz & Associates, Inc., Consulting Engineers, 206 North River Street, East Dundee, Illinois. A non-refundable deposit of thirty dollars (\$30.00) payable to Gerald L. Heinz & Associates, Inc. is required for each set of bidding documents, which are available through and issued by the engineers.

All sealed proposals shall be accompanied by a Bid Bond or Certified or Cashier's Check made payable to the Village of East Dundee for not less than five percent (5%) of the total bid amount. The successful bidder must furnish a satisfactory contract bond in the full amount of the bid.

The SPECIAL PROVISION FOR BIDDING REQUIREMENTS AND CONDITIONS FOR CONTRACT PROPOSALS, effective January 1, 2022, as prepared by the IDOT, Bureau of Local Roads and Streets and contained in the "Supplemental Specifications and Recurring Special Provisions" adopted by the IDOT on January 1, 2022, shall apply fully to this project.

All work under this contract shall comply with the Prevailing Wage Rate Act of the State of Illinois, 820 ILCS 130/1 et seq. and Employment of Illinois Works on Public Works Act (30 ILCS 570/). Bids may not be withdrawn for a period of sixty (60) days after closing date without the consent of the Board of Trustees.

Any Bid submitted unsealed, unsigned, fax transmissions or received subsequent to the aforementioned date and time, may be disqualified, and returned to the bidder.

The Village of East Dundee reserves the right to reject any or all Bids and to waive any irregularities or informalities in the bidding process or in any Bidder's Proposal, and to award the contract in a manner best serving the interest of the Village.

The quantities appearing in the bid schedule are approximate and are prepared for the comparison of bids. Payment to the Contractor will be made only for the actual quantities of work performed and accepted or materials furnished according to the contract. The scheduled quantities of work to be done and materials to be furnished may be increased, decreased, or omitted as hereinafter provided.
