Subject: Discussion of Video Gaming Guidelines
Date: June 6, 2022

Action Requested:

Staff requests the Village Board discuss the current status of video gaming in East Dundee and whether or not to adopt any video gaming restrictions. Additionally, staff requests direction regarding a request to extend video gaming to convenience stores/gas stations.

Summary:

The Village of East Dundee has had video gaming since April 7, 2014. Currently, there are 19 licensed establishments offering video gaming with a total of 102 video gaming terminals (VGT's). The chart below shows each establishment and the number of VGT's each contains:

The Illinois Video Gaming Act authorizes the placement of up to 6 video gaming terminals in licensed retail establishments, fraternal and veteran’s establishments with a liquor license, where permitted by local ordinance. The Act also sets forth both maximum wagers and maximum earnings. The maximum wager per hand is capped at \$2.00 and the maximum cash award for a single hand is \$500.00. Additionally, the value of credits are limited to 5¢, 10¢, or 25¢.

Video gambling revenues, after payouts to winners, are taxed at a flat 30% rate, with 25% going to the State and the other 5% going to the local municipality. The remaining 70% of revenue is divided equally between the establishments and terminal operators.

In 2021, the Village of East Dundee received \$310,273.04 in video gaming revenue for its 5% share. Currently, all video gaming revenue and licensing fees are placed in the capital fund to be used only for capital improvements in the village.

Eligible Establishments

Licensed establishments include licensed retail establishments where alcoholic liquor is drawn, poured, mixed, or otherwise served for consumption on premises, licensed truck stops and fraternal establishments.

Hours of operation for video gaming terminals

Video gaming terminals may only be played during the legal hours of operation allowed for the consumption of alcoholic beverages at the licensed premises.

State Restrictions

1. Location - Video gaming terminals may not be operated within 1,000 feet of a horse racing or riverboat gambling facility or within 100 feet of a school or place of worship.
2. Number of Machines - No more than six machines are allowed on any premises
3. Location of Machines - Video gaming machines must be located in an area that is restricted to persons aged 21 or older, and in view of at least one employee.
4. Age Restriction - No one age 20 years old or younger is permitted to play at a video gaming terminal.

All video gaming terminals must be located in areas restricted to persons over 21 years of age. Licensed video gaming locations that restrict admittance to patrons 21 years of age or older, are not required to have a separate restricted area. In locations where separation from minors is required, a physical barrier to the gaming area is required and may consist of a short partition, gate, rope or other means of separation and shall not visually obscure the entrance to the gaming area from an employee of the licensed video gaming location who is over 21.

The Video Gaming Act requires that video gaming terminals must be within the view of at least one owner, manager, or employee of the establishment who is over 21 and shall be present during all hours of terminal operation. While locations may utilize closed circuit TV to monitor the entrance to the area in addition to an employee, closed circuit TV may not be utilized in lieu of an employee. Licensed video gaming establishments must also prevent access to or play of terminals by any persons who are visibly intoxicated.

Available Restrictions

The Village Board may adopt its own local restrictions regarding video gaming including but not limited to:

- Gaming Revenue Limitations: Limiting the percentage of income received from video gaming to a certain percentage of the overall income of the establishment.
- License Waiting Periods: Ensuring interested locations are established businesses capable of operations without reliance on video gaming.
- Security and Public Safety Requirements: Surveillance requirements including burglar alarms and additional safety measures in place.
- Promotional Signage Restrictions: Restricting video gaming signage.

At the conclusion of the discussion, the Village board may choose to:

1. Establish a 1-year moratorium on new video gaming applications/approvals while gathering community feedback to determine if additional restrictions are necessary
2. Establish restrictions based on available options above
3. Continue forward as has been done in the past with no restrictions

Regional Video Gaming Regulations

Village of Lombard & Village of Palos Park (Substantially Similar)

(D)The following restrictions apply to all liquor licenses which allow for and authorize the operation of video gaming terminals upon the licensed premises:

(1)The operation of video gaming terminals shall not be permitted during the hours alcoholic liquor sales are prohibited, as provided in § 112.36 of this Code.

(2)As required by the Illinois Video Gaming Act, video gaming is prohibited in any establishment located within 100 feet of any school (as defined in the Illinois Video Gaming Act) or place of worship.

(3)As required by the Illinois Video Gaming Act, video gaming shall be located in an area that is restricted to persons 21 years of age or older.

(4)As required by the Illinois Video Gaming Act, the total number of video gaming terminals located in the establishment shall not exceed five (5).

(5)The establishment shall comply with all of the village's sign regulations and it shall be unlawful to advertise for video gaming via a sign visible from any street, alley or public right-of-way within the village. This includes temporary or permanent signage that may include a business name, name, identification, description, display, illustration or attention-getting device which is affixed to or painted or represented directly or indirectly upon a building or other outdoor surface or lot, and which directs attention to a person, business, product, service, place, organization or entertainment.

(6)The establishment shall be required to install, operate and maintain a video camera surveillance system capable of recording clear and unobstructed photographic representations of the segregated area of the establishment where the video gaming terminals are located, and shall retain the video recordings produced therefrom for a minimum of 30 days. Said video recordings shall be subject to inspections by the Village's Police Department upon request therefor.

(7)The establishment shall be equipped with a direct connect burglar alarm system to the Village's Police Department, or to such other location as directed by the Village's Police Department, to address instances of unpermitted entry into the establishment.

(8)The percentage of income received from Video Gaming shall not exceed 49 percent of the establishment's gross revenue. The liquor licensee shall be prepared to establish that the liquor licensee has met the 49 percent standard upon the request of the Village and this determination shall be based upon, but not be limited to, audited financial statements, corporate financial reports, tax return information, State liquor license

reports, or any other form of documentation/information deemed acceptable by the village. At the village's discretion, each liquor licensee shall be subject to an annual audit to verify compliance with this subsection.

(9)As required by the Illinois Video Gaming Act, all video gaming terminals shall be located in a segregated area which shall be accessible only to persons over 21 years of age. Applicants shall submit a site plan clearly indicating the proposed location of all video gaming terminals and the type of barrier to be utilized to segregate the area; provided however, that such barrier shall not obstruct the view of the video gaming area, which shall be visible to an employee of the liquor licensee, who is over 21 years of age, at all times.

(10)The liquor licensee applicant/business establishment must be in good standing with the village at the time of the application for a liquor license which allows for the operation of video gaming terminals on the licensed premises. To be in "in good standing":(a)the liquor license applicant shall owe no sums of money to the Village at the time of submitting an application for a liquor license which allows for the operation of video gaming terminals on the licensed premises;(b)the liquor license applicant shall have had no violations causing a suspension of its liquor or business license in the 12 months prior to submitting an application for a liquor license which allows for the operation of video gaming on the licensed premises; and(c)the liquor license applicant shall be in compliance with all dram shop and video gaming laws, rules and regulations of the village and the State of Illinois.

(E)Video gaming cafés are expressly prohibited in the village, and no liquor license shall be created, maintained or authorized for a video gaming café.

Village of Berkeley – Section 4-2-13

A. State Approval And County And Village Permit Stickers Required:

1. It shall be unlawful for the licensee of any licensed premises to operate a video gaming terminal who has not also obtained approval for the operation of the video gaming terminals from the State of Illinois, from Cook County, and who has not obtained a video gaming terminal establishment permit sticker and a video gaming terminal operator permit sticker for each video gaming terminal from the village.

2. It shall be unlawful for a video gaming terminal operator to own, service, maintain or place a video gaming terminal in the village who has not also obtained a license for the ownership, service, maintenance and/or placement of each video gaming terminal in the village from the State of Illinois, and who has not also obtained a video gaming terminal operator permit sticker from the village for each video gaming terminal.

B. Regulations For Licensed Establishments: Regulations governing licensed establishments operating video gaming terminals are as follows:

1. A valid village video gaming terminal establishment permit sticker and a valid village video gaming terminal operator permit sticker shall be clearly displayed at all times on each video gaming terminal.
2. No more than the lesser of the maximum amount of video gaming terminals allowed by Illinois law or the amount of video gaming terminals allowed in the village-issued supplemental video gaming establishment permit may be located on the licensed establishment's premises.
3. All video gaming terminals must be located in an area restricted to persons twenty one (21) years of age or older. The entrance to such an area must at all times be within the view of at least one employee who is at least twenty one (21) years of age. Video gaming terminals must not be visible from any area outside of the building.
4. No licensed establishment may cause or permit any person under the age of twenty one (21) to use, play or operate a video gaming terminal.
5. No video gaming terminal may be played except during the legal hours of operation allowed for the consumption of alcoholic beverages at the licensed premises.
6. The licensed establishment must fully comply with the Illinois video gaming act and all rules, regulations, and restrictions imposed by the Illinois gaming board, as may be amended from time to time, which are hereby incorporated by reference into this chapter.
7. The licensed premises shall be video recorded pursuant to this chapter.
8. Any violation of this section shall be cause for the immediate suspension of the liquor license for the licensed premises, and such suspension shall remain in effect until the licensee demonstrates that he is in full compliance with this section.
9. Any licensee that has had his or her license revoked or suspended by the village or by the Illinois State Liquor Control Commission or has his or her video gaming license revoked or suspended by the Illinois gaming board shall automatically have his or her village-issued supplemental video gaming establishment permit and village-issued video gaming terminal establishment permit stickers revoked or suspended for the same time period as his or her liquor and/or gaming board permit sticker suspended, whichever the case may be.
10. Every video gaming terminal that does not have a valid video gaming terminal establishment permit sticker issued by the village, a valid video gaming terminal operator permit sticker issued by the village, and authorization from the state of Illinois, or that is operated in violation of this section or is otherwise unlawful, shall be considered a gambling

device subject to seizure and shall be turned over to the Illinois Gaming Board in accordance with Board regulations and applicable laws unless otherwise ordered by a court of competent jurisdiction.

11. Every licensee shall submit a written statement to the village with the identities and addresses of the video gaming terminal operators owning, placing, serving and/or maintaining video gaming terminals at the licensed premises prior to the video gaming terminal operator owning, placing, serving and/or maintaining any video gaming terminal at the licensed premises.

C. Regulations For Video Gaming Terminal Operators: Regulations governing video gaming terminal operators are as follows:

1. A valid village video gaming terminal operator permit sticker shall be clearly displayed at all times on each of the video gaming terminal operator's video gaming terminals in the village.

2. A video gaming terminal operator must fully comply with the Village Code, the Illinois Video Gaming Act and all rules, regulations, and restrictions imposed by the Illinois Gaming Board, as may be amended from time to time, which are hereby incorporated by reference into this chapter.

3. Any violation of this section shall be cause for the immediate suspension of any license issued to the video gaming terminal operator and any video gaming terminal operator permit stickers issued by the village to the video gaming terminal operator.

4. Any video gaming terminal operator that has had his or her video gaming license revoked or suspended by the Illinois Gaming Board shall automatically have his or her village-issued supplemental video gaming operator permit and village-issued video gaming terminal operator permit stickers revoked or suspended for the same time period as his or her Illinois Gaming Board revocation or suspension, as the case may be.

Subject: Creation of New B-5 Liquor License – Package & Pour
Date: May 16, 2022

Action Requested:

Staff requests the Village Board discuss and consider an ordinance amending Chapter 116 of the Village Code to add a new Class B-5 Liquor License allowing limited retail sale of package beer, wine and spirits as well as the sale of beer and wine for on-premises consumption.

Summary:

The Village has been approached by Jay Pastakia, owner of Dundee Marathon (305 E Main St, East Dundee, IL 60118) regarding his desire to have video gaming at his establishment in order to be able to compete with the other fuel stations in the Village. He is working with representatives from Accel Entertainment who advised that Harwood Heights and Oswego both recently created this same “package and pour” liquor license which allows customers to purchase packaged alcohol to-go, or purchase beer/wine for on-site consumption in a designated gaming area. This liquor license, if created, would allow Mr. Pastakia to apply to have video gaming in his establishment as the parameters of on-site consumption, as required by the state of Illinois, would be met.

If the Village Board decides to approve this new license, Mr. Pastakia would then apply for the license and return to the Board at a later date for potential approval. Creation of the Liquor Class does not guarantee any applicant will be awarded a license. Each item is a separate action of the board for approval or denial. If approval is granted Mr. Pastakia would return with more information regarding the layout of his store and how this would be accommodated.

ORDINANCE NUMBER 22 - __

AN ORDINANCE OF THE VILLAGE OF EAST DUNDEE, COOK AND KANE COUNTIES, ILLINOIS, AMENDING CHAPTER 116 OF THE VILLAGE OF EAST DUNDEE VILLAGE CODE TO ADD A NEW CLASS B-5 LIQUOR LICENSE TO ALLOW FOR THE SALE OF BOTH PACKAGE BEER, WINE AND SPIRITS FOR OFF-PREMISES CONSUMPTION AND BEER AND WINE FOR ON-PREMISES CONSUMPTION

WHEREAS, the Village of East Dundee (“Village”) is a home rule unit of local government pursuant to Section 6 of Article VII of the Constitution of the State of Illinois, and has the authority to exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, the Illinois Liquor Control Act, 235 ILCS 5/1-1, *et seq.*, authorizes the Village to determine the number, kind and classification of licenses for the retail sale of alcohol liquor, and to establish rules and regulations for the sale thereof; and

WHEREAS, the President and Board of Trustees of the Village have deemed it to be in the best interest of the Village that a new classification of liquor license, to be known as “Class B-5,” be added to the Village of East Dundee Village Code (“Village Code”) to allow the limited retail sale of package beer, wine and spirits for off-premises consumption, and beer and wine for on-premises consumption; and

WHEREAS, the President and Board of Trustees have deemed it to be in the best interest of the Village to make other housekeeping amendments to the section of the Village Code regulating restaurant liquor licenses;

NOW THEREFORE BE IT ORDAINED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF EAST DUNDEE, COOK AND KANE COUNTIES, ILLINOIS, AS FOLLOWS:

SECTION 1: Incorporation. That the recitals above shall be and are hereby incorporated in this Section 1 as if restated herein.

SECTION 2: Amendments. That the Village Code is hereby amended as follows, with additions underlined and deletions struck through:

Amendment One:

Section 116.05(A)(7-1) of the Village Code, entitled “Class B-5,” is hereby created and shall read as follows:

“(a) Package store license which shall allow licensee to sell and offer to sell, at retail in the premises specified in the license, (1) beer, wine and spirits in the original package not for consumption

on the premises where sold, and (2) beer and wine poured from an original package by the licensee for consumption on the premises where sold.

(b) This license shall be issued to retail food stores, department stores and retail food stores also selling gasoline only if the following conditions are met at all times when the license is in force:

1. Only "beer," "wine" and "spirits" as defined in the Illinois Liquor Control Act (235 ILCS 5/1-1, et seq.), may be sold.

2. The minimum enclosed floor area open to the public for retail sales for store products shall be 1,800 square feet, of which no more than 20% may be devoted to the sale and consumption of beer and wine.

3. The minimum inventory level shall be \$35,000 retail value, excluding beer, wine, spiritis, fuel and automotive products.

4. The maximum percentage of beer and wine to total store sales, exclusive of gasoline sales, shall be 3-5% on a retail basis during any consecutive 12-month period.

5. No displays of beer, wine or spirits shall be located within five feet of the store's entrance.

6. Cold beer, cold wine or cold spirits shall only be sold from, or displayed in, electrical refrigeration coolers.

7. Employees engaged in the sale of beer, wine or spirits must be at least 21 years of age.

8. The premises shall include an indoor area dedicated exclusively to alcohol consumption and video gaming, if any.

9. Alcohol consumption on the premises shall be strictly limited to a designated area approved by the Liquor Commissioner and may only occur during the hours of _____ AM to _____ PM daily. Any video gaming license shall be limited to the hours in which on-premises consumption of beer and wine is authorized as provided herein.

10. The licensee may not serve more than one serving of an alcoholic beverage per customer, per hour for on-premises consumption, and in no event shall a licensee serve more than two servings of an alcoholic beverage to an individual for on-premises consumption in a single calendar day. For purposes of this Subsection, one serving of an alcoholic beverage means twelve (12) ounces of beer or five (5) ounces of wine.

11. The licensee may only sell and serve beer and wine for on-premises consumption to a person who is actively playing at a video game terminal. For purposes of this Subsection, actively playing means that a person is presently engaged in real-time inputs and interaction with a video gaming terminal and shall be distinguished from passively watching a video gaming terminal or another person actively playing.

(c) In addition, retail food stores selling gasoline shall meet the condition that no mechanical or repair work of any kind may be performed on automobiles on the licensed premises.”

Amendment Two:

Section 116.04(A)(3) of the Village Code is hereby amended to read as follows:

“All personnel who prepare mixed alcoholic beverages or serve alcoholic beverages for consumption on premises, in premises licensed under license classes A, A-1, A-2, B-5, C, D, E and E-1 shall be required to complete BASSET or TIPS training.”

Amendment Three:

Section 116.04(B)(1)(a) of the Village Code is hereby amended to read as follows:

“It shall be unlawful for any holder of a license, under the Classifications A, A-1, A-2, B-5, C and D set forth in § 116.05, required for retail sales of alcoholic liquors to employ any person to sell or serve alcoholic liquors who has not registered with the Police Department, except that the registration shall be waived for employees of holders of Class C licenses.”

Amendment Four:

Section 116.08(L) of the Village Code is hereby amended to read as follows:

“To sell or offer for sale, at retail, or to give away, in or upon any licensed premises, any alcoholic beverages during the hours in which sale of alcoholic beverages is prohibited. It shall be unlawful to keep open for business or to admit the public to or permit the public to remain within or to permit the consumption of alcoholic liquor in or upon the premises at any time during which the sale of the liquor is prohibited; not to include license classes A-2 (Beer/Wine On-Premises Consumption), B-1 (Package Liquors/Supermarket/Drug Stores), B-4 (Retail Food/Gas), B-5 (Retail Food/Gas/On-Premises Consumption) and C-1 (Public Golf Course), provided that such licensees may remain open for business during such hours, but that no alcoholic liquor may be sold to or consumed by the public during those hours; provided further that for license Classes A, A-1, B, B-2, C, D, E, E-1, E-2, F, and G, only the licensee and any of its employees shall be allowed to remain on or about the licensed premises in order to clean-up or maintain said premises after the closing hour, as noted in § 116.08(B).”

Amendment Five:

Section 37.01(U)(2)(e) of the Village Code is hereby amended to read as follows:

1. Class A (tavern): \$2,000
2. Class A-1 (tavern/beer garden): \$3,000
3. Class A-2 (beer/wine on-premises/beer garden): \$2,500
4. Class B (package liquor): \$2,000
5. Class B-1 (supermarket and drug store): \$2,000
6. Class B-2 (incidental sales - beer and wine): \$1,200
7. Class B-3 (mail order sales): \$300
8. Class B-4 (incidental sales - beer, wine and hard liquor): \$1,500
9. Class B-5 (incidental sales – package and on-premises consumption): \$2,000
10. Class C (incorporated not-for-profit): \$750
11. Class C-1 (public golf course restaurant): \$2,500
12. Class D (outdoor amusement parks): \$1,250 plus \$375 per additional point of distribution
13. Class E (restaurants): \$2,500
14. Class E-1 (restaurants with service bar only): \$1,500
15. Class E-2 (restaurants with beer and wine only): \$1,000
16. Class E-3 (restaurant with beer and wine only and packaged sales): \$2,500

17. Class F (special events license): \$100 per day
18. Class G (banquet license): \$2,500 plus \$750 per additional point of distribution
19. Class H (entertainment venue license): \$3,000
20. Class I (specialty food and beverage establishment): \$1,000
21. Class J (village caterer): \$500
22. Class J-1 (caterer with business location outside of village): \$300
23. Class K (caboose concession stand): \$500, application fee waived
24. Class L (brew pub): \$2,500

SECTION 3: Continuation. That all provisions of the Village Code not amended herein shall remain in full force and effect.

SECTION 4: Severability. That if any Section, paragraph or provision of this Ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such Section, paragraph or provision shall not affect any of the remaining provisions of this Ordinance.

SECTION 5: Repeal. That all ordinances, resolutions, motions or parts thereof in conflict with this Ordinance shall be and the same are hereby repealed.

SECTION 6: Effect. That this Ordinance shall be in full force and effect upon its adoption, approval and publication in pamphlet form as provided by law.
