To the Residents of the Village of East Dundee:

On behalf of the men and women of the East Dundee Police Department, it is my pleasure to present this 2022 annual report. This report will summarize crime and accident data, police programs to the community, and personnel highlights from the past year. The East Dundee Police Department is dedicated to the values of integrity, fairness, and respect. Our police officers and civilian staff members have made significant advances toward outliving these values while serving the community.



Overall, the crime we reported to the Illinois State Police and the FBI showed us going from 80 serious Part 1 Offenses in 2021 to 112 in 2022 for a 40% increase in crime after two years of that level staying flat. One area that we saw a significant increase was theft doubling from 31 to 62. We also experienced an increase in aggravated assaults and batteries from 2 in 2021 to 7 in 2022.

The Department experienced several personnel changes. Most noteworthy of course was that of Chief of Police George Carpenter retiring from active law enforcement in February of 2022 and Deputy Chief Schenita Stewart being selected as the new Chief of Police for the City of Evanston in October of 2022. Part time Officers Leonard Wronski and Michael Gicla resigned from their position. We saw the addition of two additional full time officers, bringing our full time sworn compliment to fifteen. Officer Ryan Fleury was appointed by the East Dundee Police Commission on June 13, 2022 and attended the Suburban Law Enforcement Academy at the College of DuPage. Officer Jose Feliciano was appointed on September 6, 2022 after serving ten years with the Chicago Police Department. The Department welcomed two part time officers as well. Officer Sarah Donnellan was appointed on July 21, 2022, and Officer Robert Sarra on July 29, 2022. Both part time officers come to East Dundee with a plethora of experience.

Our Investigations Section, along with many members of the department, responded to an aggravated battery with a firearm at Carols Corner over the summer. This investigation consumed many hours of evidence gathering, interviews and analysis to culminate in felony charges being approved by the Kane County States Attorney.

The East Dundee Police Department is committed to provide the highest quality law enforcement services around. One important ingredient to that is the level of continuing education and training we provide our staff. During 2022, the department provided 2721 hours, up from 385 in 2021. This equates to an average of 129.57 hours per officer. Some of this was attributed to basic training of a new officer. However, we pride ourselves in the level of in service training we provide and go well above and beyond what is minimally required by state statute. Better training means higher quality, lower liability, and the highest level of professionalism available. The Department is also required by the Safe-T Act to provide for a higher level of mandated training to all sworn personnel with no distinction of full or part time.

Another area of our commitment to quality is accreditation. The East Dundee Police Department is an ILEAP, Illinois Law Enforcement Accreditation Program, accredited agency through the Illinois Association of Chiefs of Police. Through the efforts of our part time accreditation manager and the commitment of our staff, policies are kept up to date with best practices, changes in the law, and continuous improvement. This is an ongoing process that requires us to demonstrate we are following our own policies and are subject to outside assessment for compliance. We will have a renewal and visit from an assessment team in 2023 for another four-year term.

I wish to thank President Lynam, the Village Board, and Village Administrator Storlie for all of the support and confidence they continue to provide the East Dundee Police Department. Without it, we would not have accomplished as much as we have, as this annual report depicts. I appreciate the Village President and Village Administrator's unwavering support as I complete my first year leading this department. I would also like to thank the men and women of the East Dundee Police Department. Their continued display of commitment is an example to all and illustrate why this department and our profession is the most honorable in the world.

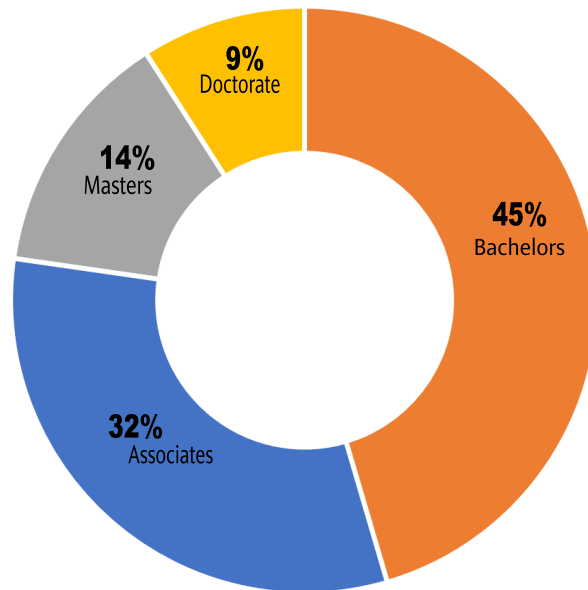
Police Officer Age

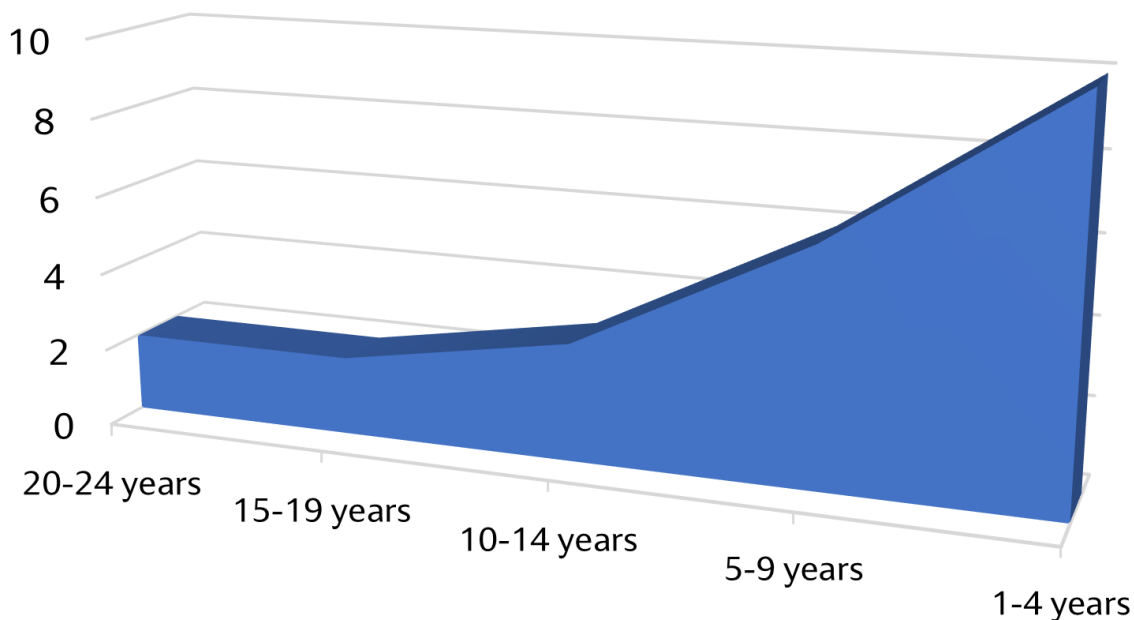

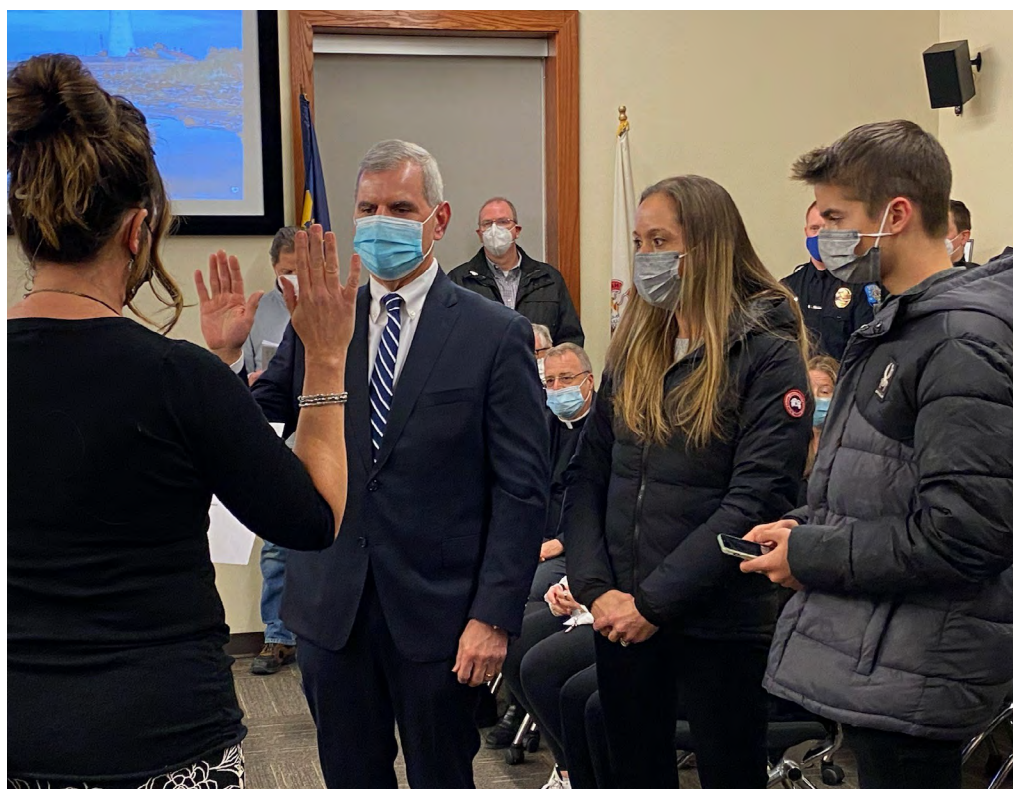

Recognition of the work our Officers do reflects on them and on the East Dundee Police Department as a whole. We are proud of the men and women whose actions inspired the following correspondence, emails and phone calls we received:

EXTERNAL COMPLIMENTS

- On 08/15/22 Officer Kasiba responded to a Civil Standby at 210 Christina Dr. The caller stated he was firing an employee and was fearful of a confrontation. Officer Kasiba spoke to the caller multiple times throughout the firing process to make sure everything was going as planned and he did not need police intervention. Officer Kasiba stood by until the caller felt safe enough for EDPD to leave. His professional actions resulted in positive feedback from the caller and brought credibility to the Department.
- On 9/10/22 Officer Feliciano and Officer Rybialek were approached by a female outside of Bandito Barney's. The female advised she was currently staying at a hotel in West Dundee for a wedding. Once the wedding finished, she took a shuttle bus into East Dundee to get something to eat. She was told by the Shuttle driver that the bus would be returning to the hotel at 0100 hrs. She advised the officers that the shuttle never returned to pick her up and she was stranded and by herself. Officers Feliciano and Rybialek transported the female safely back to her hotel in West Dundee. The female reached out to give her thanks and appreciation, stating these officers really made a difference in her life.
- The following was received by records and sent via email, "Martha Figueroa just called in and wanted to express her great appreciation to Officer Clark for all the help he provided to her today. She also wanted his supervisor to be aware of this as well as give her overall thanks to the police department." I wanted to thank Officer Jeff Clark for representing the police department in a positive manner
- A letter of thanks was received from Sergeant Quandee of the Carpentersville Police Department for the assistance rendered by Officer Lawson at a large scale disturbance at El Diablo in their jurisdiction.
- A letter of thanks was received from West Dundee Police Chief Gorski in regard to the assistance Sergeant Magnuson and Officer Rybialek provided their department on August 24, 2022 for a domestic battery arrest.

INTERNAL COMPLIMENTS

- Officer Miles responded to the scene of an aggravated discharge of a firearm incident and continued to investigate the case due to the unavailability of the detective. This required working additional hours as he was currently field training a new officer. Officer Miles conducted an interview that was determined to be critical to the investigation. He subsequently identified all parties involved in the incident, and worked with and met the Kane County States Attorney's Office regarding charges. He has also volunteered to take on LEADS validation responsibilities while the detective is out. Officer Miles' hard work and dedication is greatly appreciated.

The Police Chaplaincy Program aids Police Officers and the citizens of East Dundee to provide spiritual guidance, counseling and comfort in times of crisis. A few of the Chaplain's responsibilities are death notifications, accidents involving serious injuries, domestic disturbances and persons who are confused or emotionally upset.

Tim Perry is the President of Nationwide Chaplain Services and serves as Chaplain for several suburban police departments, as well as the Illinois State Police. He is a Certified Professional & Leadership Development Specialist with over 25 years of corporate leadership with the top 5 of Fortune 500 organizations. He also served 8 years in the U.S. Air Force in aviation, including combat time in Gulf War I. It is his vision to provide exceptional care to our Officers and citizens around the clock with Emergency Response Chaplains and Advocates (Counselors) that are trained and certified to provide a unique and valuable service. It is also their goal to have a diverse group of Chaplains and Advocates that reflects the needs of the East Dundee Police Department, so that they are sensitive to cultural diversity.

The Chaplain and Advocates also provide the following functions:

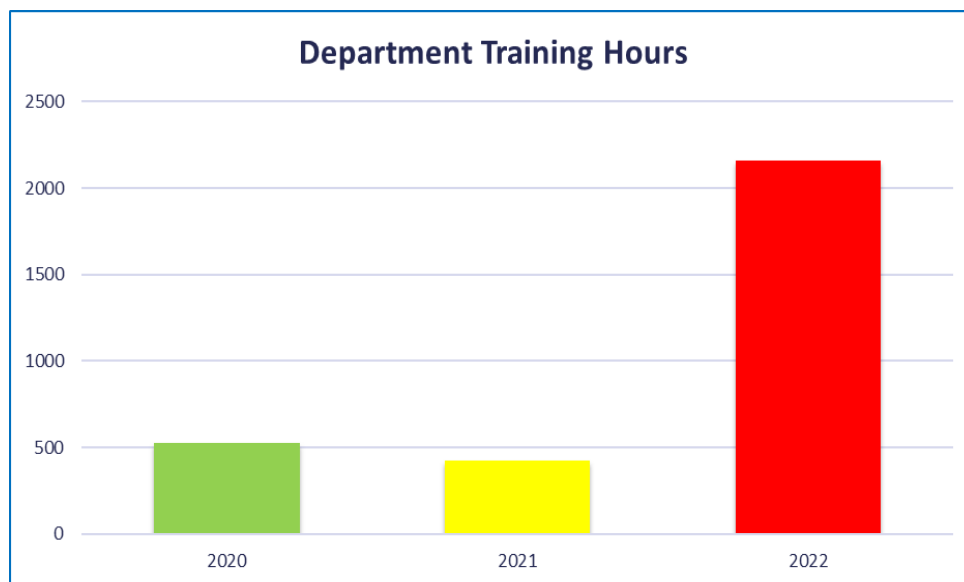
- Leadership Development Workshops

Training Supervisor

OVERVIEW – The department increased training hours significantly from the prior two years. Training was put on hold, or significantly limited, during the COVID pandemic. As a result, 2022 saw a significant increase in training across the board. The department remains committed to training that is essential for officers to effectively perform their duties and assignments. With the implementation of the SAFE-T Act, it is imperative officers receive mandated continuing education to maintain certification. We will continue to explore internal and external training opportunities, without sacrificing our commitment to a high level of public service.

OPERATIONAL – In 2022 69% of training was conducted in the operational category. Every month officers participate in online training called CourtSmart. CourtSmart provides a monthly publication of updated case law. Case law provides important guidance to officers on what they can and cannot do. Case law can frequently change, and this training provides officers with the most current law updates. This training meets the state training mandates of civil rights, law updates, use of force, and constitutional and proper use of law enforcement.

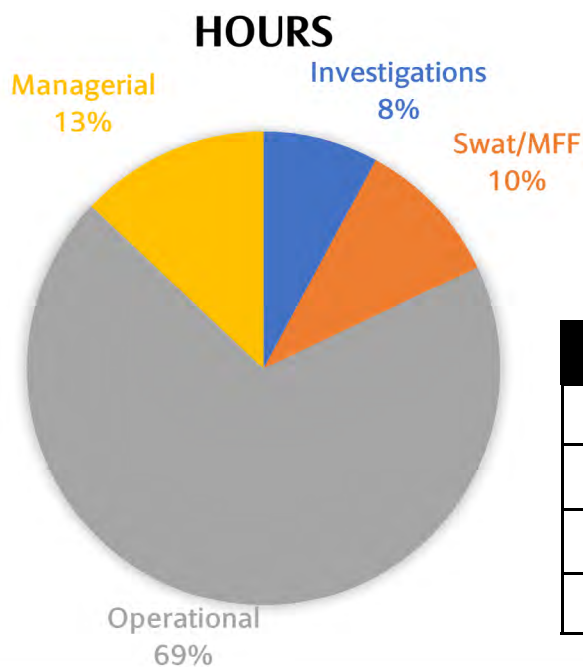


KANE COUNTY SWAT/MOBILE FIELD FORCE – Officers Kevin Lawson and Joseph Rybialek participate in reoccurring training for their respective specialties. 10% of department training was associated to Swat and Mobile Field Force. The training is beneficial to the Police Department as these skills are utilized while on duty and through training of other East Dundee Officers.

MANAGERIAL – Management training totaled 257 hours. Supervisor development through Northwestern’s Supervision of Police Personal accounted for 68% of managerial training.

INVESTIGATIONS – Patrol officers, as well as the department investigator, can conduct investigations. As such it is important patrol officers also receive training on proper investigative techniques. The Police Department spent 8% of training focused on investigations.

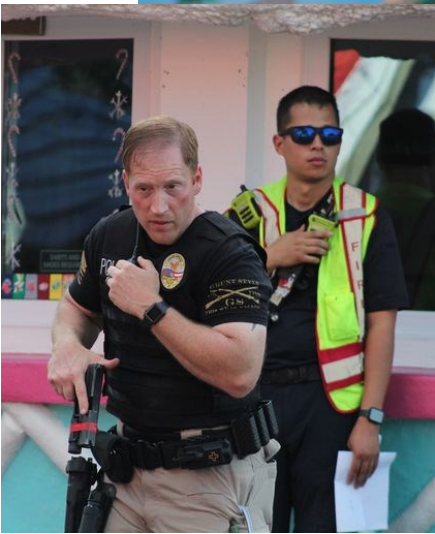

In September 2022, the East Dundee Police and Fire Departments participated in Rescue Task Force Training at Santa's Village after the season ended. RTF Training provides for a coordinated strategy to bring law enforcement and emergency medical resources together during an active shooter event. It has been recognized that EMS cannot wait

for a scene to be completely secure when there are victims that may be shot and bleeding.

The training provides for an understanding of each service's perspective and needs to address the emergency.





OPERATIONS

The Patrol Operations Division is the largest division within the East Dundee Police Department. Patrol is the most visible part of the Police Department providing 7-days-a-week, 24-hour operation services to the community. The Patrol Division makes up approximately 80 percent of the total police Department manpower. Patrol is staffed with both full and part time uniformed officers who provide a number of police services to include responding to 9-1-1 calls for service, traffic crashes, traffic enforcement and preliminary police investigations.

The services provided by the Patrol Division were established on the philosophy of Community Oriented Policing (COP). COP is based on the continued, positive interaction between the community and members of the East Dundee PD to work together to develop solutions to neighborhood problems.

Patrol officers are assigned to one of four Teams and work a 12 hour rotation giving the Village 24/7 coverage. Teams A and B cover the day shift, Teams C and D cover the night shift and are assigned such shifts for one year. The officers patrol their assigned beats and work as a team to address criminal activity and provide service throughout the community. As issues are identified, the sergeant coordinates the efforts of the officers and is empowered to seek additional department or community resources to address these issues.

Officer Kevin Lawson is assigned to the Multi-Jurisdictional Kane County SWAT (Special Weapons and Tactics) team. The team is comprised of nine different police agencies and three fire departments. The SWAT team was activated for multiple high-risk incidents in 2022. Officer Lawson was on the scene for three of those. In 2022, all callouts were for armed subjects who had barricaded themselves.

The team meets for bi-monthly training, focusing on close Quarters Battle and tactics, hostage rescue, vehicle assaults, firearms training, and even drone and robotic training. More focus has been on using robots and electronics in order to keep Officers safe. All Operators are required to pass a physical agility test twice a year. Team members are also required to pass rifle and pistol qualifications yearly. The rifle and pistol qualifications were recently changed to a higher standard than in the past. The team was able to conduct their five-day training course at Fort McCoy in Tomah Wisconsin, without being limited by COVID-19.

In 2019, Officer Joseph Rybialek was the first East Dundee Police Officer to join the Illinois Law Enforcement Alarm System (ILEAS) Mobile Field Force. The Mobile Field Force provides rapid, organized and disciplined response to civil disorder, crowd control or other situations. Mobile Field Forces are formally structured teams based on a platoon of law enforcement officers from multiple agencies with an assigned leader. Tactics used are based on small squad tactics developed by the Office of Domestic Preparedness as well as the more traditional Mobile Field Force and general police patrol tactics.

The Illinois Law Enforcement Alarm System (ILEAS), region 3 North, had 5 scheduled training days in 2022. The trainings included asset protection, search and rescue, riot control, and formations/defensive tactics/first aid. The team had no ILEAS activations for 2022.

The department remains professionally accredited by the Illinois Association of Chiefs of Police through its Illinois Law Enforcement Accreditation Program (ILEAP). The ILEAP Accreditation award symbolizes the department's achievement in excellence. The agency has reached a level of professional esteem through audits, inspections, and peer critique in an effort to maintain the best practices in the field of policing.

The police department was granted accreditation status on December 16, 2020, which will be for four years. During the four years, the police department must submit annual reports proving continued compliance with those standards under which it was initially accredited.

The Police Department is preparing for re-accreditation in Summer of 2023 and a site visit by ILEAP Assessors.





QUADCOM 9-1-1

Quadcom is an intergovernmental consolidated emergency dispatch system, providing 9-1-1 services for several communities in the northern fox valley. The combined population of the communities is nearly 68,559 covering over 82 square miles.

Quadcom began as an intergovernmental agreement between the villages of East Dundee, Carpentersville, West Dundee and Sleepy Hollow in 1979. Those four communities formed a Joint Emergency Telephone Systems Board to fund 911 operations. Prior to that the Carpentersville and West Dundee Police Departments operated their own in-house radio room and served East Dundee and Sleepy Hollow. Quadcom began operations in the Carpentersville Police Department dispatch center in the newly opened Carpentersville Village Hall and Police Department. They remained there until the 1990's when a state of the art communications center was built in its current location at 505 Elm Ridge Road in Carpentersville.

The Quadcom center handles an average of 350 telephone calls per day and dispatches approximately 45,000 calls for service annually. The center is staffed by Public Safety Telecommunicators who have completed a comprehensive training program and participate in ongoing continuing education.

The East Dundee Police Department Records Section serves as the community's point of contact for the East Dundee Police Department. The Records Section is staffed by one full time records clerk and one part time records clerk, serving the community Monday through Friday from 7:00 a.m. to 4:00 p.m.

The Records Section is responsible for verifying all incident, arrest and accident reports; storing and gathering crime statistics, as well as overseeing all inquiries and requests for copies of records, and Freedom of Information Act (FOIA) requests. In addition, records clerks conduct records checks for law enforcement and governmental agencies.

- All records clerks are Less than Full Access Certified in the Law Enforcement Agencies Data System of the Illinois State Police. Records clerks are responsible for examining and processing all statewide LEADS alerts and other communications and updating the East Dundee Police Department LEADS entries.
- Records clerks process traffic and parking citations and insure all traffic stops are entered in the Illinois Department of Transportation Traffic Stop Data Collection portal.
- Records clerks provide administrative support for the Police Department Command Staff.
- Records Clerks process reports and video evidence to be submitted to the appropriate county prosecutor or local prosecutor's office.
- Records Clerks prepare case files for local adjudication proceedings.

2022 INVESTIGATION SUMMARY:

P.I. Accident - DUI

On Friday January 28th, 2022, officers were dispatched to a vehicle accident with injuries at 622 Dundee Ave. where a vehicle drove into the building. Officers found a vehicle had left the roadway Northbound Dundee Ave., crashed into the business, and was now inside on its roof. Witnesses said that no one had exited the vehicle. The East Dundee Fire Department located one male subject alive inside the vehicle. He was extracted and transported to Sherman Hospital with life threatening injuries. An investigation found that the vehicle had struck a Comcast box, a snow pile, entered the parking lot and struck a light pole before colliding with and entering the building. No one inside the business was reported injured. The driver was later flown to Lutheran General Hospital due to his injuries. On 01/29/22, the driver was said to be in stable condition. Later, after being released from the hospital, the driver agreed to turn himself into EDPD and was charged with driving under the influence, failure to reduce speed to avoid an accident, and improper lane usage.

Aggravated Battery / Mob Action

On Sunday March 10th, 2022, officers took a report for a battery that occurred in the parking lot of 105 Prairie Lake Road. Three male juveniles had been at this location hanging out and reported that a white Chevy sedan pulled up to them. Three known occupants exited the vehicle with baseball bats and a BB gun. The occupants, two male juveniles and one adult, then attacked the three male juveniles with those bats and shot one with the BB gun. The Chevy then left the area. One male juvenile was transported to Sherman Hospital for injuries. The injured male juvenile received 6 staples in his head and had bruising on his upper body. He was able to identify the offenders. Arrest warrants for one of the offending male juveniles and male adult (brothers) were obtained. On 8/19/22 the juvenile was arrested and charged with 3 counts Aggravated Battery Class 3 and 1 count Mob Action Class 4. The arrest warrant for the adult male is still active.

Aggravated Battery - Discharge of a Firearm

On Sunday July 10th, 2022, officers responded to a report of a shooting that had just occurred inside of Carol's Corner, 5 E. Main Street. The offender was described as a male black wearing blue jeans, black T-shirt with a white shirt underneath. He was last seen walking Eastbound towards the Dairy Queen with a white female. Additional units arrived on scene and a search for the offender was underway. The male black victim had gunshot wounds to his upper chest/shoulder area. The victim was transported to Sherman Hospital. Witnesses on scene identified the offender and surrounding agencies assisted in trying to locate him. Security footage from inside Carol's Corner was reviewed and showed the offender and victim's altercation. It was later discovered that the offender had a revoked IL FOID. An arrest warrant was later obtained for the following charges: 2 counts Aggravated Battery with a Firearm - Class X, 1 count Aggravated Discharge of a Firearm at a person - Class X, 1 count Possession of a Firearm with no Valid FOID - Not Eligible - Class 3. The arrest warrant for the offender is still active.

KANE COUNTY MAJOR CRIMES TASK FORCE

The mission of the Kane County Major Crimes Task Force is to provide timely assistance to member agencies that become involved in a major investigation by providing additional expertise, manpower and equipment. KCMCTF will work the following types of cases: Homicide, serial sexual assault, serial arson, major bombing, non-parental kidnapping, complex violent crimes against people, heinous crimes, complex crime scene processing and evidence collection.

On April 13, 2022, Detective Marinos assisted the Task Force responding to West Dundee for a fatal shooting investigation at Esporta Fitness.

LIQUOR COMPLIANCE

East Dundee Police Department partnered with the Illinois Liquor Control Commission to implement a comprehensive alcohol control program. On April 29th, 2022, eighteen local licensed liquor establishments were checked. Employees from the five following establishments were issued citations for not checking for ID and attempting to serve an underaged compliance assistant:

- Mockingbird Bar and Garden, 217 Barrington Avenue
- D.C. Cobbs, 311 Barrington Avenue
- Shell Gas Station, 1097 E. Main Street
- Royals, 505 Dundee Avenue

On May 26th, 2022, an additional six licensed liquor establishments were checked with ILCC and no violations were issued.

Twenty-four establishments were checked throughout these two dates. East Dundee Police will continue to perform liquor compliance checks at various times and locations throughout the year.

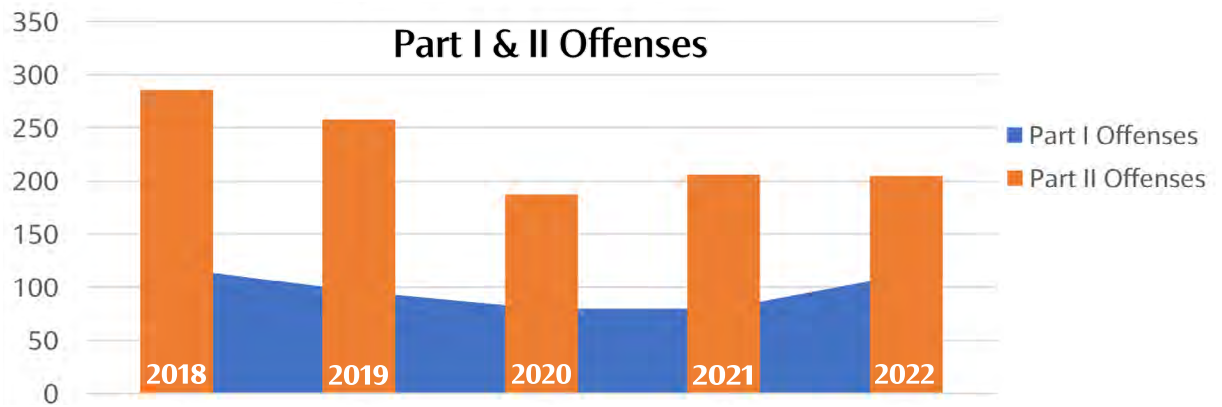

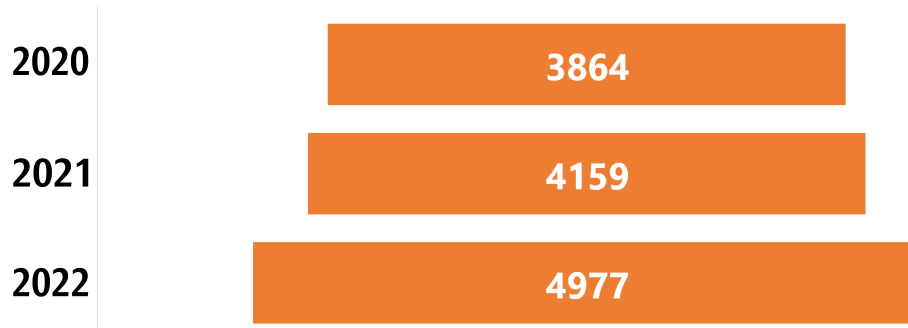

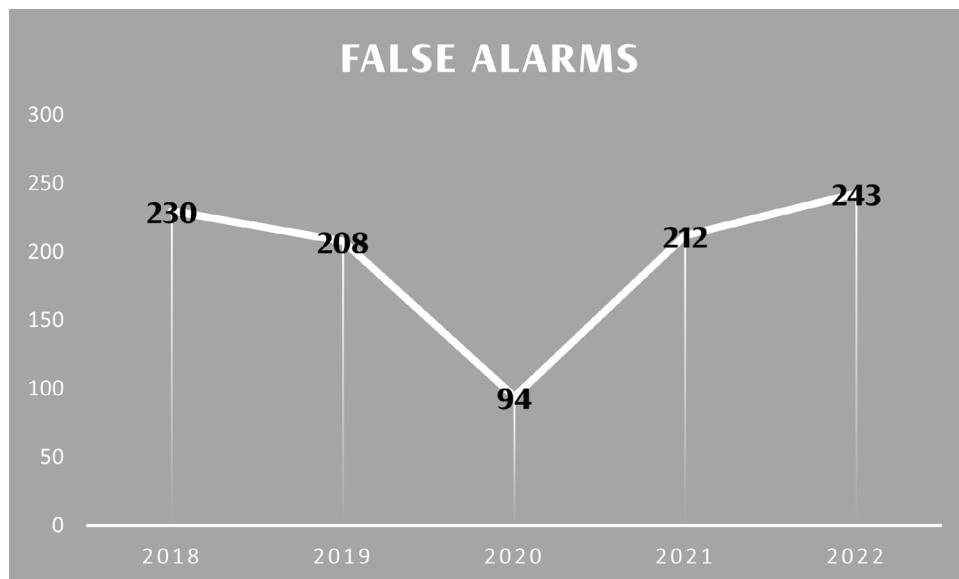

PROFESSIONAL STANDARDS

It is the policy of the East Dundee Police Department to investigate all complaints made against police department personnel in a manner that will ensure the community of prompt, corrective action when they have concerns or believe a Department member's conduct was improper. The duty of the Police Department is to protect the public against improper conduct of its officers, as well as protect police officers that are acting properly from false, inaccurate, misinformed or malicious accusations of misconduct.

During 2022, 1 external complaint was made against any Department employee. 14 internal policy or code of conduct violations were administratively resolved.

2022 RESPONSE TO RESISTANCE RESULTS

Eight incidents were documented in which East Dundee Police Officers were required to use force to overcome resistance in the performance of their duty. Three occurred during a traffic stop, two breaking up a fight in progress, and one each for resisting arrest, a domestic violence call, and the apprehension of a wanted person. Five use of force reports were when making an arrest, three to defend themselves, three to prevent a violent crime, two to defend a citizen and one to defend a fellow officer. The officer utilized their hands in five incidents, four were the active pointing of a firearm, three were utilizing a taser, one was the use of a controlled takedown and one was an armbar. All eight incidents were investigated by supervisors and reviewed by the Deputy Chief and Chief of Police and found to be justified and consistent with state law and department policy, requiring no further corrective action or investigation.

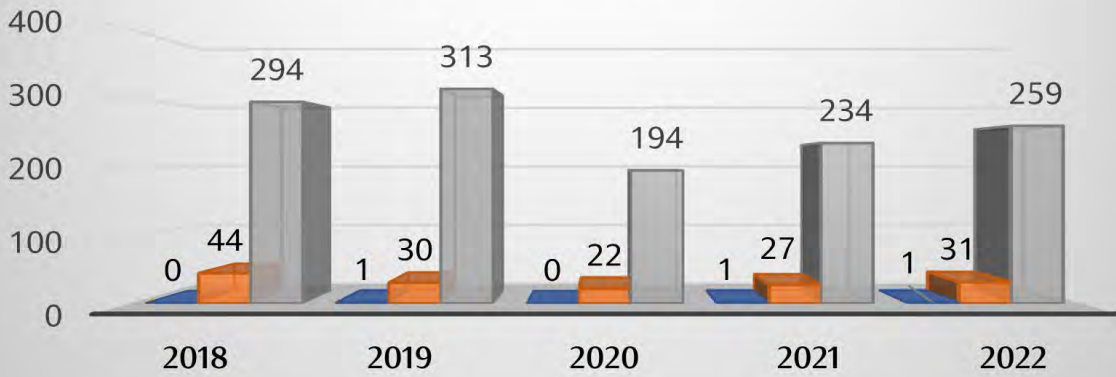

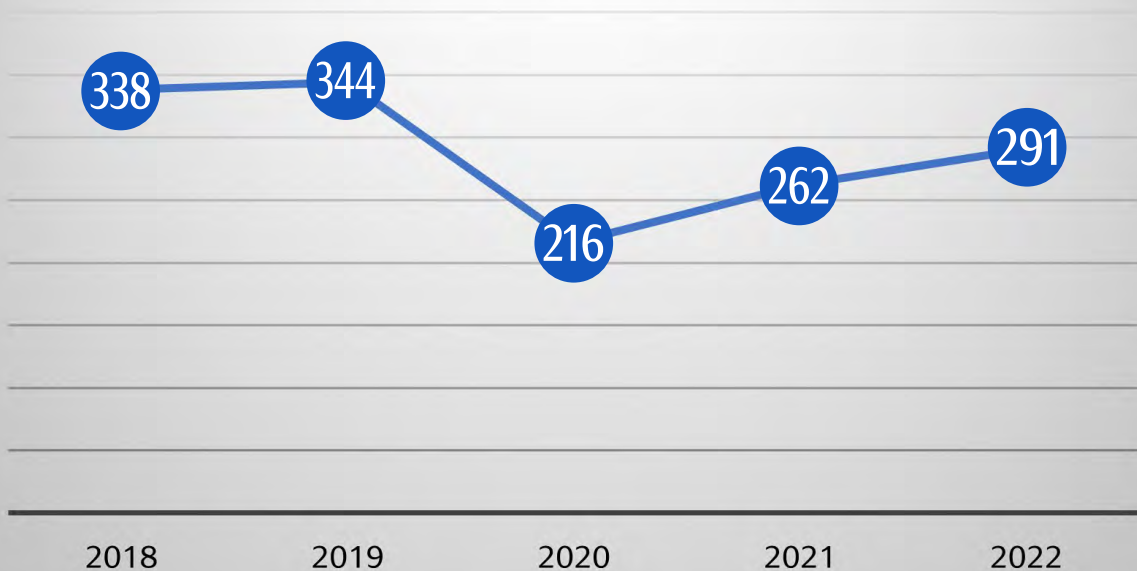


Traffic Crashes

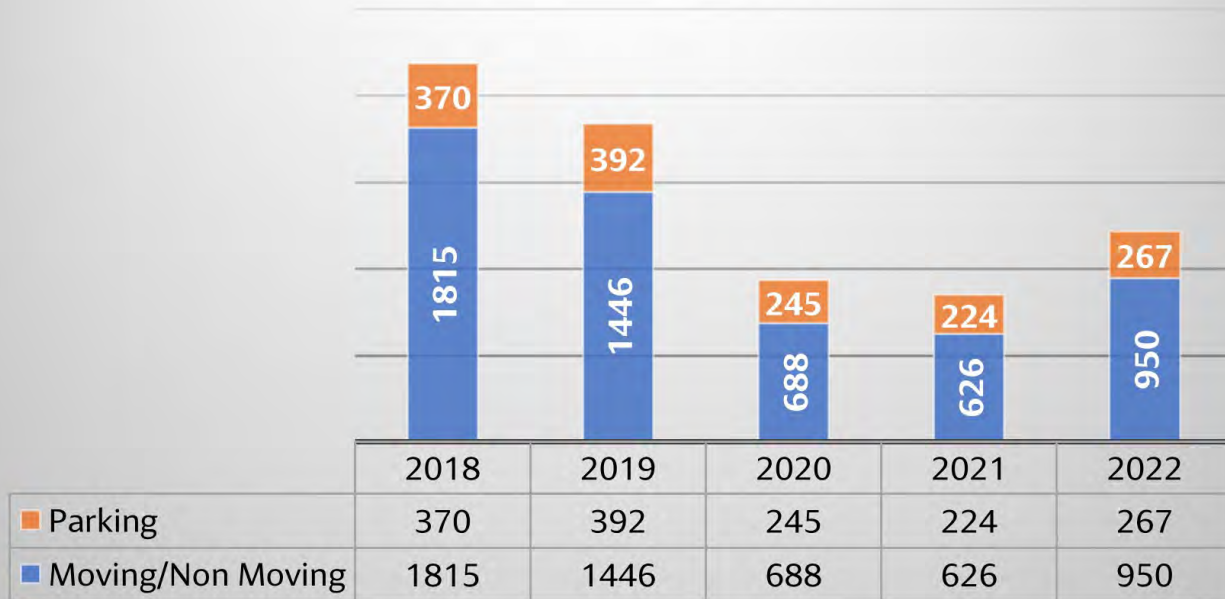

TRAFFIC STOP DATA COLLECTION

Members of the East Dundee Police Department and all Officers in Illinois are required to record demographic data for every driver of a motor vehicle stopped for traffic related offenses. Once collected, the data is forwarded to the Illinois Department of Transportation for analysis and reporting.

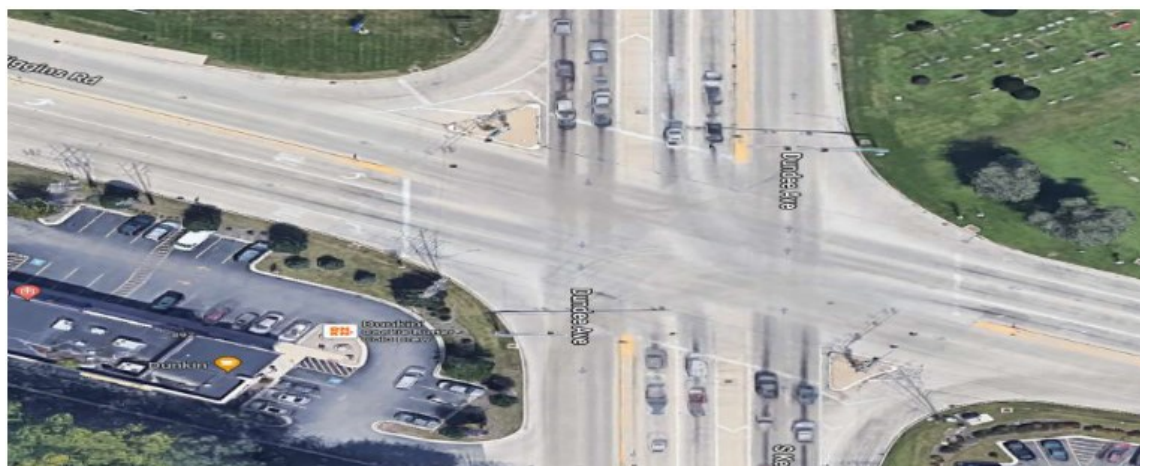
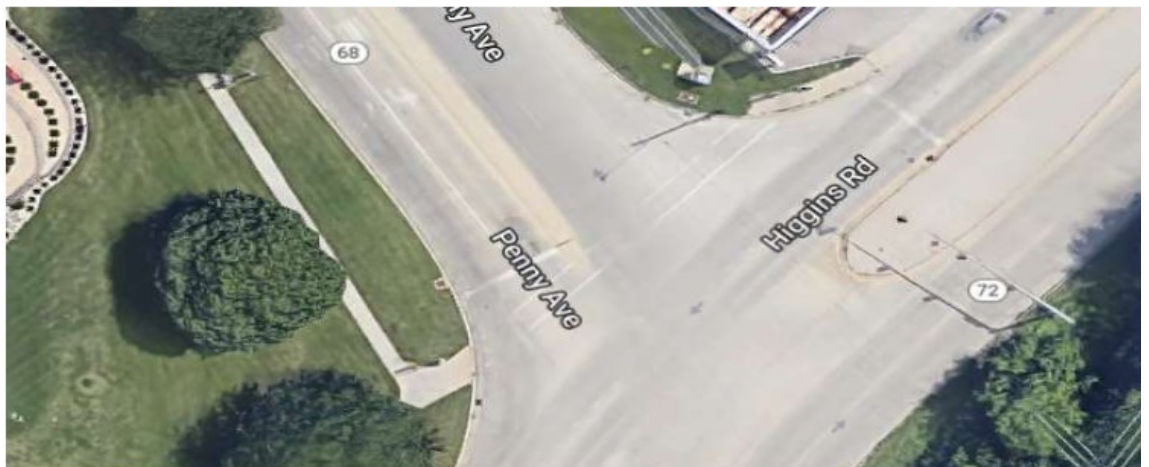
RED LIGHT PHOTO ENFORCEMENT

After finding limited success with other attempted measures to promote safer driving and improve compliance with traffic laws, Red Light Running (RLR) Photo Enforcement Systems were installed at the following intersections:



1. IL 72 (Main St.) at IL 68 (Penny Ave.) (southwest bound) on September 11, 2009
2. IL 72 (Higgins Rd.) at IL 25 (Dundee Ave.) (westbound) on March 1, 2011

After suspected violations are recorded, an East Dundee Police Officer must review each video and determine if a violation has been committed. After it is attested to by the officer, the violation is sent to the registered vehicle owner to satisfy the fine, or request a hearing.



ADMINISTRATIVE ADJUDICATION

The Office of Adjudication hears certain ordinance violations. One of the functions of this Office is the Administrative Tow Program. The Administrative Tow Program is utilized to remove dangerous drivers, who are found to be in violation of serious vehicular offenses, from the roadways, which adds to the safety of East Dundee residents and essentially everyone who use the streets within our Village.

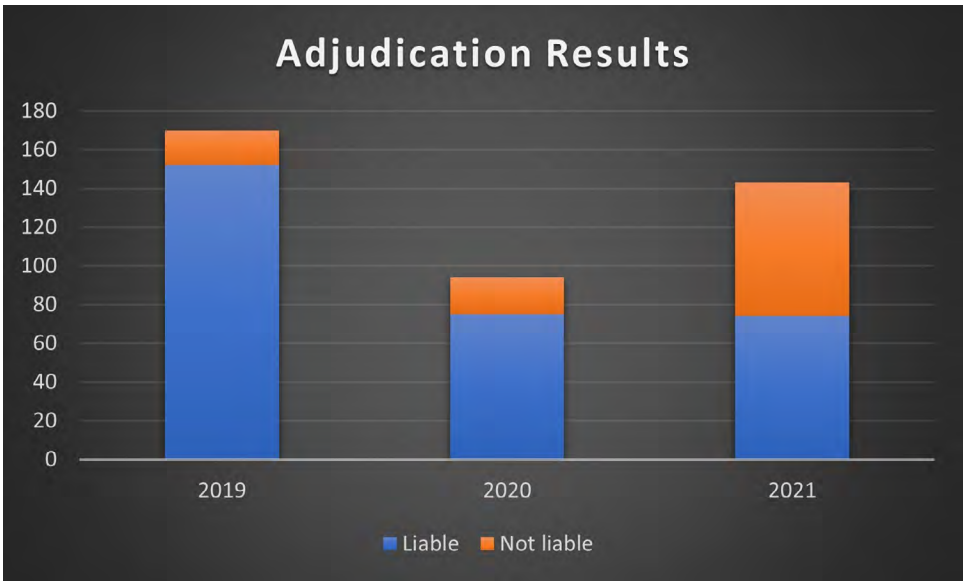
During the calendar year of 2022 there was 93 adjudication actions at the hearings. This included ordinance violations, contested in person Red-Speed, contested by mail Red-Speed hearings and administrative tows.

ADJUDICATION EXPERIENCE

Contested RLR camera violations are adjudicated through an administrative hearing conducted monthly. The high-quality video footage and photographic evidence produced by the enforcement system is a contributing factor in the majority of the contested RLR violations being upheld by the Hearing Officer.

The police officers assigned to review and approve/reject potential violations are vigilant in applying the same officer discretion and criteria they would if issuing an in-person citation, resulting in only highly prosecutable violations being mailed out.

The Police Department was assigned the former Public Works facility for department use over two decades ago. After nearly 50 years of inattention, Chief Kruger enlisted the help of staff volunteers to assist us in remodeling and repurposing the space. The facility was completely updated, new electrical, air compressor lines, remodeled restroom, and emergency decontamination shower built. Using in-house labor allowed the department to complete the project at a fraction of the cost. The facility is now used for village events and department training, as well as still being used to park police vehicles not on patrol. This is a well used resource to keep our vehicles and electronic equipment functioning well when squad cars are not stored outside in the elements when not in use.
