

# 4<sup>th</sup> Street Overnight Parking Permit



## Information

- All on-street parking spaces along 4<sup>th</sup> street between Barrington Avenue & Railroad Street are available for parking overnight, but only 10 permits have been created at this time. Those holding a valid overnight parking permit will be eligible to park overnight without danger of being ticketed in any parking stall along 4<sup>th</sup> Street directly opposite the 300 Block of River Street. No other parking stalls are available for overnight parking and those who do so will be ticketed.
- To be issued a permit, the applicant must show proof of residency of business ownership on the 300 block of River Street.
- No permit will be required to be displayed. Police will verify compliance via license plate. Should you purchase a new vehicle, you will be responsible to make the Village aware of the change in vehicle or license plate.
- There will be no accommodations made for snowplowing. The Village will not be responsible for digging out cars plowed in from overnight plowing operations. Those stalls and adjacent areas will then be cleaned of snow when the plows are available and can safely remove the snow from the stalls.
- Should a vehicle be inadvertently ticketed, the vehicle owner will be responsible for notifying the East Dundee Police Department as soon as possible in order to have the ticket properly waived.
- Permits will be available on a first-come-first-served basis. It is the responsibility of the permit holder to know when the permit expires and to take steps accordingly. If a permit expires, the permit holder has one month to renew the permit before it becomes available for purchase by another resident or business.
