ORDINANCE AMENDING TITLE XI, BUSINESS REGULATIONS, CHAPTER 116: ALCOHOLIC BEVERAGES, §116.05(B), LICENSES, BY INCREASING THE NUMBER OF CLASS D LICENSES TO TWO

WHEREAS, the Village of East Dundee is a home rule unit of local government under and pursuant to Section 6 of Article VII of the Constitution of the State of Illinois, has the authority to exercise any power and perform any function pertaining to its government and affairs, including but not limited to the power to regulate for the protection of the public health, safety, morals, and welfare; and

WHEREAS, The President and the Board of Trustees of the Village of East Dundee have determined that it is in the best interest of the health, safety, morals and welfare of the citizens of East Dundee for Title XI, Business Regulations, Chapter 116: Alcoholic Beverages, §116.05, to be amended to increase the number of Class D licenses from one (1) to two (2).

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF EAST DUNDEE, COOK AND KANE COUNTIES, ILLINOIS, AS FOLLOWS:

<u>Section One</u>. That Title XI, Business Regulations, Chapter 116, Alcoholic Beverages, §116.05(B), Licenses, is hereby amended to hereafter read as follows:

§ 116.05 LICENSES.

(B) Number of licenses to be permitted. The number of licenses issued in all preceding classes shall be as follows, except as modified from time to time by ordinance:
