

ORDINANCE NUMBER 13 - 02

**ORDINANCE AMENDING TITLE VII, TRAFFIC CODE,
CHAPTER 71, TRAFFIC SCHEDULES, SCHEULE I, SPEED
LIMITS BY ADDING VAN BUREN BETWEEN MAIN STREET
(ROUTE 72) AND JOHNSON AS A 20 MPH ZONE**

WHEREAS, the Village of East Dundee is a home rule unit of local government under and pursuant to Section 9 of Article VII of the Constitution of the State of Illinois, has the authority to exercise any power and perform any function pertaining to its government and affairs, including but not limited to the power to regulate for the protection of the public health, safety, morals, and welfare; and

WHEREAS, the Village of East Dundee has the power to regulate vehicular traffic and specifically to limit the speed on any roadway under its jurisdiction; and

WHEREAS, the corporate authorities of the Village of East Dundee have determined that it is advisable, necessary and in the public interest that the Village authorize the traffic control measure designated herein.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF EAST DUNDEE, COOK AND KANE COUNTIES, ILLINOIS, AS FOLLOWS:

Section One. That Title VII, Traffic Code, Chapter 71, Traffic Schedules, Schedule I, Speed limits, is hereby amended to add to the list of streets with special speed limits therein described, said schedule shall now read as follows:

SCHEDULE I. SPEED LIMITS.

(A) The general speed limit in the village shall be set at 25 mph, except for the following list.

(B) It shall be unlawful for any operator to drive a motor vehicle at speeds greater than those listed.

(C) The speed limit in school zones on school days when children are present shall be 20 miles per hour as follows:

Section Two. Severability. If any section, paragraph or provision of this ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this ordinance.

Section Three. Repeal. All ordinances, resolutions, motions or parts thereof in conflict herewith shall be and the same are hereby repealed.

Section Four. Publication. This ordinance shall be in full force and effect forthwith upon its adoption, approval and publication in pamphlet form as provided by law.
