

Ordinance No. 13-04

**AN ORDINANCE OF THE VILLAGE OF EAST DUNDEE, KANE
AND COOK COUNTIES, ILLINOIS, TO SET A DATE FOR A
PUBLIC HEARING FOR THE SECOND AMENDMENT TO THE ILLINOIS
ROUTE 72 AND ILLINOIS ROUTE 25 BUSINESS DEVELOPMENT DISTRICT**

BE IT ORDAINED by the President and Board of Trustees of the Village of East Dundee, Kane and Cook Counties, Illinois (the "*Village*"), as follows:

Section 1. It is necessary and in the best interests of the Village that a public hearing be prior to the adoption of an ordinance by the President and Board of Trustees of the Village approving the Second Amendment to the Illinois Route 72 and Illinois Route 25 Business District Development Plan (the "*Second Amendment*"), expanding the Illinois Route 72 and Illinois Route 25 Business Development District (the "*Business District*"), to include the area legally described in *Exhibit A*, attached to and made a part of this Ordinance (the "*Amended Area*"), and imposing a retailers', service, and hotel operators' occupation taxes (the "*Taxes*"), in accordance with the Business District Development and Redevelopment Act, 65 ILCS 5/11-74.3-1, *et seq.* (the "*Act*"), in the Amended Area.

Section 2. The Act grants the Village the power to establish by ordinance or Ordinance procedures for the planning, execution and implementation of business district plans; and pursuant to the Act, the Village desired to authorize the date for a public hearing (the "*Public Hearing*") on the proposed Second Amendment, proposed expansion of the Business District to include the Amended Area, and the imposition of Taxes therein, and the publication of notice thereof.

Section 3. It is hereby determined that the Public Hearing shall be held by the President and Board of Trustees of the Village of East Dundee on the 18th day of March, 2013, at 6:00 p.m., at the Village Hall, 120 Barrington Avenue, East Dundee, Illinois.

Section 4. Notice of the Public Hearing in the form attached hereto is hereby authorized to be given twice by publication in the *Daily Herald* on the 5th of March and the 7th of March, 2013.

Section 5. If any section, paragraph, clause, or provision of this Ordinance shall be held invalid, the invalidity of such section, paragraph, clause, or provision shall not affect any of the other provisions of this Ordinance.
