Ordinance No. 13-37

AN ORDINANCE OF THE VILLAGE OF EAST DUNDEE, COOK AND KANE COUNTIES, ILLINOIS ADDING REFERENCES TO THE ANNUAL FEE SCHEDULE INTO THE VILLAGE CODE

WHEREAS, the Village of East Dundee (the “*Village*”) is a duly organized and validly existing home-rule municipality created in accordance with the Constitution of the State of Illinois of 1970 and the laws of the State; and,

WHEREAS, the Village pursuant to its home rule powers has the authority to exercise any power and perform any function pertaining to its government and affairs including the power to regulate for the protection of the public health, safety and welfare and to establish general license regulations and fees for work requiring permits in the Village; and,

WHEREAS, the Village hereby adopts this ordinance pursuant to its home rule authority.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of East Dundee, Cook and Kane Counties, Illinois, as follows:

Section 1: That Subsection 53.012(D) of the Code of the Village of East Dundee, as amended, be and is hereby amended to read as follows:

“(D) *Classes and fees of building sewer permits.* There shall be two classes of building sewer permits:

- (1) For residential, wastewater service the fee shall be as adopted in the annual fee schedule.
- (2) To commercial, institutional/governmental, or industrial wastewater service. In all cases the owner or his or her agent shall make application on a special form furnished by the village. It shall be supplemented by plans, specifications, and other information considered pertinent by the Director of Public Works. The permit and inspection fee as adopted in the annual fee schedule shall be paid to the Utility Clerk at the time the application is filed. The industry, as a condition of permit authorization, must provide information describing its wastewater constituents, characteristics, and type of activity.”

Section 2: That Sections 113.01, 113.02, 113.03, and 113.04 regarding licensing bill posters and sign painters of the Code of the Village of East Dundee, as amended, be and are hereby repealed.

Section 3: That Section 152.04 of the Code of the Village of East Dundee, as amended, be and is hereby amended by adding subsection (F) to read as follows:

“(F). The fees for soil erosion permits shall be as adopted in the annual fee schedule.”

Section 4: This Ordinance shall be in full force and effect upon its passage, approval, and publication in pamphlet form as provided by law.
