

Ordinance No. 13-45

**AN ORDINANCE OF THE VILLAGE OF EAST DUNDEE, COOK AND KANE COUNTIES, ILLINOIS, AMENDING THE EAST DUNDEE ZONING ORDINANCE TO ADD TATTOOING AS A PERMITTED USE IN THE M-2 LIMITED MANUFACTURING DISTRICT AND AS A SPECIAL USE IN THE M-1 MANUFACTURING DISTRICT**

**WHEREAS**, the Village of East Dundee, Cook and Kane Counties, Illinois (the "Village") is a duly organized and validly existing home-rule municipality created in accordance with the Constitution of the State of Illinois of 1970 and the laws of the State; and,

**WHEREAS**, pursuant to Title 15, Chapter 150 of the East Dundee Zoning Chapter the regulations imposed and districts created under the authority of the home-rule East Dundee Zoning Ordinance may be amended; and,

**WHEREAS**, pursuant to Section 150.065(A)(10(f) of the East Dundee Zoning Chapter the Village filed an application to add (9) Tattooing to the list of permitted uses in the M-2 Limited Manufacturing District and as a special use in the M-1 Manufacturing District; and,

**WHEREAS**, notice of a public hearing before the Planning and Zoning Commission on the amendment was duly published on October 28<sup>th</sup>, 2013 in the Daily Herald newspaper of in the Village; and,

**WHEREAS**, the Planning and Zoning Commission convened and held a public hearing on the 14<sup>th</sup> day of November 2013, on the question of the application for a text amendment; and,

**WHEREAS**, the Planning and Zoning Commission adopted findings of fact and made a recommendation by a vote of 6 to 0 to approve the proposed text amendment; and,

**WHEREAS**, the Corporate Authorities have reviewed the Planning and Zoning Commission's findings of fact and recommendation.

**NOW, THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of East Dundee, Cook and Kane Counties, Illinois, as follows:

**Section 1.** The above recitals are incorporated herein and made a part of this Ordinance.

**Section 2.** That Section 157.003 of the East Dundee Zoning Chapter be and is hereby amended by adding a new definition as follows:

**"Tattoo.** The insertion of pigment under the surface of the skin of a human being by pricking with a needle or otherwise, so as to produce an indelible mark or figure visible through the skin but shall not include tattooing performed for medical purposes by a person licensed or otherwise authorized by the State to practice medicine or osteopathy."

**Section 3.** That Section 157.065(A)(1)(f) of the East Dundee Zoning Chapter be and is hereby amended by adding subsection (9) to the list of Permitted Uses in the M-2 Limited Manufacturing District and as a Special Use in the M-1 Manufacturing District as follows:

**Section 4.** That section 93.12 of the Code of the Village of East Dundee be and is hereby repealed.

**Section 5.** This Ordinance shall be in full force and effect upon its passage, approval, and publication as provided by law.
