

Ordinance No. 15-05

**AN ORDINANCE ADDING PARKING REGULATIONS FOR THE VILLAGE OF EAST DUNDEE'S PARKING LOTS AND AMENDING PARKING REGULATIONS FOR HILL, JACKSON AND RAILROAD STREETS**

**WHEREAS**, the Village of East Dundee, Cook and Kane Counties, Illinois (the "*Village*") is a duly organized and validly existing home-rule municipality created in accordance with the Constitution of the State of Illinois of 1970 and the laws of the State; and,

**WHEREAS**, Section 11-208(a)1. of the Illinois Vehicle Code (625 ILCS 5/11-208(a)1.) authorizes a municipality to regulate the standing or parking of vehicles.

**NOW, THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of East Dundee, Cook and Kane Counties, Illinois, as follows:

**Section 1:** That the following parking regulations are hereby established for the Village's public parking lots and Schedule 1. Restricted Parking, of Chapter 72: Parking Schedules, of the Code of the Village of East Dundee, is hereby amended by adding parking regulations as follows:

Street	Location	Direction	Special Provisions
"Parking Lots 1 and 2	Between Railroad Street and Hill Street		No parking for more than 24 hours. No parking within 12 hours after a snowfall of three inches or more has occurred."

**Section 2:** That Title VII, Chapter 70, Section 70.04(B) of the Code of the Village of East Dundee is hereby amended by deleting Subsection 5 of Section 70-11-1303 in its entirety and replacing said Subsection with the following in its stead:

"5. When signs are erected at the entrances of highways and streets into the Village giving notice thereof, no person shall park a vehicle between the hours of 2:00 a.m. and 6:00 a.m. on any day, on any street within the Village except such regulation shall not apply to Jackson Street between VanBuren Street and Water Street, Hill Street between VanBuren Street and River Street, Railroad Street between VanBuren Street and River Street, and Parking Lots 1 and 2 between Railroad Street and Hill Street where parking is permitted."

**Section 3:** That the following parking regulations are hereby established for Hill Street and Schedule 1. Restricted Parking, of Chapter 72: Parking Schedules, of the Code of the Village of East Dundee, is hereby amended by adding parking regulations as follows:

Street	Location	Direction	Special Provisions
"Hill Street	Between River Street and Van Buren Street	East and West sides	No parking for more than 24 hours. No parking within 12 hours after a snowfall of three inches or more has occurred."

**Section 4:** That the following parking regulations are hereby established for Jackson Street and Schedule 1. Restricted Parking, of Chapter 72: Parking Schedules, of the Code of the Village of East Dundee, is hereby amended by deleting the existing regulations for Jackson Street and replacing said regulations with the following in their stead:

Street	Location	Direction	Special Provisions
"Jackson Street	Between Water Street and VanBuren Street	East and West sides	No parking for more than 24 hours. No parking within 12 hours after a snowfall of three inches or more has occurred."

**Section 5:** That the following parking regulations are hereby established for Railroad Street and Schedule 1. Restricted Parking, of Chapter 72: Parking Schedules, of the Code of the Village of East Dundee, is hereby amended by deleting the existing regulations for Railroad Street and replacing said regulations with the following in their stead:

Street	Location	Direction	Special Provisions
"Railroad Street	Between River Street and VanBuren Street	East and West sides	No parking for more than 24 hours. No parking within 12 hours after a snowfall of three inches or more has occurred.
Railroad Street	From Water Street east to River Street and VanBuren Street to the dead end of Railroad Street	East and West sides"	

**Section 6:** That this Ordinance shall be in full force and effect upon its passage, approval and publication in pamphlet form as provided by law.


