

**AN ORDINANCE
AMENDING CHAPTER 151- BUILDING REGULATIONS; CONSTRUCTION OF THE CODE
OF THE VILLAGE OF EAST DUNDEE**

WHEREAS, the State of Illinois adopted the 2014 Illinois Plumbing Code amending the 2004 Illinois Plumbing Code on April 24, 2014; and the State of Illinois adopted the 2015 International Energy Conservation Code as Amended by the State of Illinois on January 1, 2016.

NOW THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of East Dundee, Kane County, Illinois that:

Section 1. That Section 151.002(E) and Section 151.002(I), Adoption of Codes, Chapter 151: Building Regulations; Construction of the Code of the Village of East Dundee are hereby amended as follows:

(E) 2014 Illinois Plumbing Code

(I) 2015 International Energy Conservation Code

Section 2. That Section 151.012 of Chapter 151: Building Regulations; Construction of the Code of the Village of East Dundee is hereby deleted.

Section 3. That Section 151.017 of Chapter 151: Building Regulations, Construction of the Code of the Village of East Dundee is hereby deleted.

Section 4. That Section 151.011 (A) of Chapter 151: Building Regulations, Construction of the Code of the Village of East Dundee is hereby amended as follows:

(A) *Adoption of National Electrical Code.* The standards and specifications, rules and regulations of the 2005 edition of the National Fire Protection Association (NFPA), as contained in the code known as the "National Electrical Code" are hereby adopted as the rules and regulations for the installation, alteration and repair of electrical equipment, subject however, to the additional standards and specifications, rules and regulations herein set forth, and except where they are in conflict with the provisions of this code. A copy of this code shall be on file in the office of the Village Clerk. It shall be mandatory that all equipment, material, devices and appliances covered by the provisions of this code shall be tested and listed by a standard testing laboratory, of nationally accepted stature, which performs services equal to or greater than those performed by the Underwriters Laboratories, Inc. In those instances where it is impossible to receive an approval, the Building Department shall make the determination of acceptability.

Section 5. Any motion, order, resolution or ordinance in conflict with the provisions of this Ordinance is, to the extent of such conflict, hereby superseded and waived.


Section 6. This Ordinance shall take full force and effect upon its passage and approval pursuant to law.


