### EAST DUNDEE POLICE ARREST BURGLARY OFFENDERS

East Dundee Police responded to a burglar alarm in the 500 block of Commonwealth Drive on June 29, 2021, at 3:17 a.m. (21-1783). The location is a fenced in landscaping yard. This location has been burglarized numerous times overnight in the past, in which landscape equipment was stolen.

Upon arrival officers observed multiple suspects on the property. Officers discovered that entry was made by the suspects through a small opening in the fence. When the suspects were confronted by police all three fled in different directions. With the help of the Carpentersville Police Department two offenders were taken into custody. Stolen proceeds and burglary tools were recovered from the offenders. Interviews were conducted with confessions being made by both offenders. Two offenders were charged for this crime. The third offender is still at large with an arrest warrant pending.
